**3 - Bill and Fiscal Impact Summary**

Changes 14 fee categories charged by the Board and also changes the Private Security Training Certificate from a onetime fee to an initial fee with renewal and late fees. The Board estimates a total increase in revenue of \$217,480 per biennium, and increased expenditures of \$50,000 per biennium.

**4 - Fiscal Impact Sections Detail**

Section 1 of SB 2051 amends N.D.C.C. 43-30-16 setting the Board's examination, license, and registration fees. SB 2051 amends this statute as follows: (1) Changes the fee to be paid by an applicant for an examination to determine the applicant's fitness to receive a license as a private investigator or a license to provide private security services from \$100 to \$200, changes fee to be paid by an applicant for the initial issuance or the renewal of a license as a

private investigator or a license to provide private security services from \$150 to \$300 and also changes the late fee from \$50 to \$100 for each month, changes fee to be paid by an applicant to apply for a license to conduct a private security or detective agency from \$100 to \$200, changes fee for the issuance or the renewal of a license to conduct a private security or detective agency from \$300 to \$600 and also changes the late fee from \$100 to \$200 for each month, changes the onetime fee to an initial fee to be paid by an applicant for the issuance of a private security training certificate from \$25 to \$60 and requires a renewal fee annually of \$60 and a late fee of \$20, changes the annual fee to be paid by an applicant for the issuance of an armed certificate from \$30 to \$60 and increases the late fee from \$10 to \$20, changes the fee to be paid for the issuance of a duplicate license from \$20 to \$40, changes the initial registration fee to provide private investigative service or private security service from \$30 to \$60 and increases the late fee from \$10 to \$20, changes the initial application fee for a certified course instructor for an armed first responder training certification from \$400 to \$800 and changes the renewal fee from \$300 to \$600.

The Board estimates approximately 12 examination applicator fees for an estimated revenue increase of \$1,200 annually or \$2,400 per biennium. The Board estimates approximately 116 Private Investigator and Security Provider Licenses for an estimated revenue increase of \$17,400 annually or \$34,800 per biennium. The Board estimates approximately 5 Private Investigator and Security Provider License late fees for an estimated revenue increase of \$250 annually or \$500 per biennium. The Board estimates approximately 8 Agency Application fees for an estimated revenue increase of \$800 annually or \$1,600 per biennium. The Board estimates approximately 89 Agency License fees for an estimated revenue increase of \$26,700 annually or \$53,400 per biennium. The Board estimates approximately 89 Security Trainer fees for an estimated revenue increase of \$5,340 annually or \$10,680 per biennium. The Board estimates approximately 3 Security Trainer late fees for an estimated revenue increase of \$180 annually or \$360 per biennium. The Board estimates approximately 262 Armed Certification fees for an estimated revenue increase of \$7,860 annually or \$15,720 per biennium. The Board estimates approximately Armed Certification late fees for an estimated revenue increase of \$300 annually or \$600 per biennium. The Board estimates approximately 116 Private Investigator and Security Provider Licenses for an estimated revenue increase of \$17,400 annually or \$34,800 per biennium. The Board estimates approximately 5 Private Investigator and Security Provider License late fees for an estimated revenue increase of \$250 annually or \$500 per biennium. The Board estimates approximately 8 Agency Application fees for an estimated revenue increase of \$800 annually or \$1,600 per biennium. The Board estimates approximately 89 Agency License fees for an estimated revenue increase of \$26,700 annually or \$53,400 per biennium. The Board estimates approximately 89 Security Trainer fees for an estimated revenue increase of \$5,340 annually or \$10,680 per biennium. ## 6 - Expenditures Detail

Historically the Board has had 2 employees. For the last 4 years the Board has been operating with 1 employee mainly due to budget constraints. The Board has seen increased legal and operating expenses. The lack of Board staff has contributed a backlog the Board was and is dealing with. The increase expenditures would be to hire a .5 FTE position to assist with clearing the backlog and for day-to-day Board operations. The estimated cost of this position would be about \$25,000 annually or \$50,000 per biennium. For the biennium 2023-2025 the Board estimates \$7,500 to undergo the administrative rules process to implement these fee changes in the administrative rules. This estimate is \$5,000 for legal fees for the Board general council and \$2,500 for publication fees. The increased revenue will also be utilized towards Board solvency and mitigating current operating expenses.
