HB 1070 changes the modified adjusted gross income for children's health insurance program from two hundred ten percent down to two hundred five percent of the poverty line.

There is no fiscal impact. After the children's health insurance program income eligibility limit was increased to 210% of the federal poverty line by the 2023 ND Legislative Assembly, the Centers for Medicare and Medicaid Services informed the Department that it could only approve a change up to 205% FPL. Decreases in potential new members due to the decrease in FPL from 210% to 205% are reflected in the Department's cost to continue in HB 1012, therefore there is no fiscal impact for this bill.
