The State Canvassing Board met on November 20, 2024, to certify the results of the 2024 General Election. Following the meeting, a Certificate of Election was issued to each of the newly elected members of the legislative assembly, as directed in Section 16.1-15-46 of the North Dakota Century Code. In addition, as required by Section 4, Article XI, of the North Dakota Constitution, an Oath of Office was provided to each Representative, with instructions to execute the Oath before a Notary Public and file it with the Secretary of State before he or she assumes the duties of their office.
