## COMMUNICATION FROM SECRETARY OF STATE MICHAEL HOWE November 24, 2024

#### REMARKS OF SENATOR DEVER

Life is good in North Dakota! Life is really good!

Twenty years ago, we were a state in search of a future. The statewide mantra was, "The best and brightest are leaving the state." Economic development efforts made a difference, but the trajectory of the economy was horizontal with a slight rise.

Then the Bakken boomed. Along with it came opportunity and great challenges. Investing to build infrastructure for a booming population required real leadership. The legislature was an important part, but the local communities stepped up to meet those challenges.

Senator Bekkedahl stepped up as Commissioner Bekkedahl in Williston, having taken that office in 1996 and continuing even now.

In 2015 he brought that leadership to Bismarck as the Senator from District 1. As a dentist, one of his victories in his first session was the defeat of a bill I sponsored allowing for mid-level dentistry. He did it with such grace that he and I became close personal friends.

Always a public servant, Brad retired from the ND National Guard as a full Colonel.

He continues his life of leadership now in the Senate as Chair of the Senate Appropriations Committee.

Somebody needs to know where all the money is, and he certainly does.

It is my distinct honor to nominate my good friend Senator Brad Bekkedahl as the next President Pro-Tempore, and I look forward to his leadership in that capacity.

#### REMARKS OF PRESIDENT PRO TEMPORE BEKKEDAHL

Madam President Miller, Majority Leader Hogue, Minority Leader Hogan, Senators, Staff, and Guests.

Thank you for bestowing this honor to serve as your session President Pro Tempore. I want to thank the minority party for their gracious support as well.

I also want to thank my family, friends, and constituents for all their support. As you all know, when we serve, it places burdens on them as well, and we couldn't do this job without their assistance. Just like the military, they serve with us.

People that know me well also know that I am not as comfortable giving speeches to an audience as I am in one-on-one conversations. That being said, I'll do my best to impart my sincere appreciation and share some bits of wisdom along the way. This will probably be the shortest speech you hear all session, and I hope the brevity of my remarks do not diminish in any way the appreciation I have for the responsibility you have granted me.

A trip to the ND Senate was never on my radar screen or plan in life. Like many of you here today, my journey began by serving in local capacities of leadership. My service to Boy Scouts, my church, hockey, the military, and community all displayed to others my desire to serve. Because of these exposures, I was asked to run for the Park Board where I served for 8 years and from there the City Commission where I am in my 28th year. In 2014, District 1 Senator Stan Lyson announced his retirement and asked me to run for his seat.

Stan and I were neighbors and both charter members of our church, and his request was extremely humbling, as he had been a mentor to me for most of my life. When the press asked me why I was running for this office, I responded "I hope to make good decisions for North Dakota that will also be good for the residents of my district and community."

The reason I brought up this history of how I got here was not so you would know more about me. It is to make the point that we all started our journey to this chamber as involved local citizens. We were asked to serve. Our motivation is to make things better for all our residents. That is the basis of our citizen legislature, which has been little changed since our statehood 135 years ago. It instills in me, and I'm sure in you as well, a great deal of pride in our State of North Dakota.

In all my positions, in order to be a successful public servant, I had to Listen, Learn, and then Lead. I've never seen single agenda candidates be very successful in elective office but have watched those that take the time to listen and learn become effective leaders. Many of these people have been mentors to me and I can't thank them enough. In fact, I have had many mentors, past and present in this chamber that I have learned from. You may not know it, but all of you have played a role. It may have been only a single conversation where you imparted some wisdom without even realizing it. Or, it may have been an invitation to have lunch or dinner to relax and converse. Sometimes, it was a note of congratulations or a pat

on the back in support. I can truly say I have learned something from all of you and look forward to learning from our new colleagues as well.

The real reason this is important is I have learned that the North Dakota Senate is a place where we develop Relationships, gain Respect, and ultimately get Results. We work together pretty intensely for 4 months every 2 years and that promotes the development of these Relationships, Respect, and Results. And the real winners are all the residents of North Dakota.

I thank you all from the bottom of my heart for this honor you have bestowed upon me. I hope that what I have imparted to you today is to remember the three L's of Listen, Learn, and Lead and the three R's of Relationships, Respect, and Results. They have been important in my public service, and I hope they help all of us to succeed. Remembering all the time that the only reason North Dakota exists as a state is to serve the residents and we have an immense responsibility to make that happen.

Thanks for listening and your support. Let's work together to bring great results this session for everyone. God's blessings to all of you, our State, and our Country.
