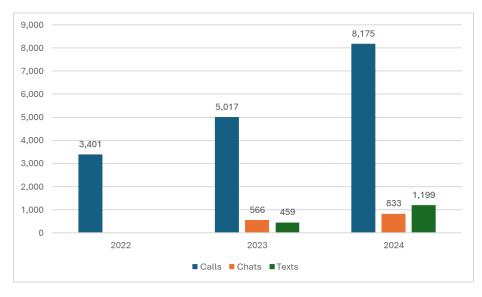
Chairman Nelson and Members of the House Appropriation Committee – Human Resource Division,

- collaborating with 911 to handle behavioral health-related calls efficiently

These services are all provided 24/7/365.
