- 1 A BILL for an Act to create and enact a new section to chapter 54-07 of the North Dakota
- 2 Century Code, relating to the children's cabinet and designated working groups; to repeal

3 section 50-06-43.1 of the North Dakota Century Code, relating to the children's cabinet; and to

4 provide for a legislative management report; and to provide an appropriation.

5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

6 **SECTION 1.** A new section to chapter 54-07 of the North Dakota Century Code is created

7 and enacted as follows:

8 <u>Children's cabinet - Membership - Duties - Working groups - Report.</u>

- 9 <u>1.</u> <u>The children's cabinet is created to assess, guide, and coordinate the care for children</u>
 and families across the state's branches of government and the tribal nations.
- 11 <u>2.</u> <u>The children's cabinet is composed of:</u>
- 12 <u>a.</u> <u>The governor, or the governor's designee;</u>
- 13 b. <u>The chief justice of the supreme court, or the chief justice's designee;</u>
- 14c.Two members of the house of representatives, appointed by the majority leader15of the house of representatives to serve two-year terms;
- 16d.Two members of the senate, appointed by the majority leader of the senate to17serve two-year terms;
- 18 <u>e.</u> <u>The superintendent of public instruction, or the superintendent's designee;</u>
- 19f.The director of the committee on protection and advocacy, or the director's20designee;

- 3 SECTION 2. REPEAL. Section 50-06-43.1 of the North Dakota Century Code is repealed.

4 SECTION 3. APPROPRIATION - OFFICE OF THE GOVERNOR - CHILDREN'S CABINET.

- 5 There is appropriated out of any moneys in the general fund in the state treasury, not otherwise-
- 6 appropriated, the sum of \$220,000, or so much of the sum as may be necessary, to the office of
- 7 the governor, for the purpose of administering the children's cabinet and coordinating-
- 8 designated working groups, for the biennium beginning July 1, 2025, and ending June 30, 2027.
