**PROPOSED AMENDMENTS TO**

**SENATE BILL NO. 2010**

1 A BILL for an Act to provide an appropriation for defraying the expenses of the council on the  
2 arts: to provide for transfers; to provide for a report; and to provide an exemption.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from other funds derived from special funds and  
7 federal funds, to the council on the arts for the purpose of defraying the expenses of the council  
8 on the arts, for the biennium beginning July 1, 2025, and ending June 30, 2027, as follows:

6 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO THE**  
7 **SEVENTIETH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding  
8 items included in the appropriation in section 1 of this Act which are not included in the entity's  
9 base budget for the 2027-29 biennium and which the entity shall report to the appropriations  
10 committees of the seventieth legislative assembly regarding the use of this funding:

14 **SECTION 3. APPROPRIATION - CULTURAL ENDOWMENT FUND.** All income from the  
15 cultural endowment fund is appropriated to the council on the arts for the furthering of the  
16 cultural arts in the state for the biennium beginning July 1, 2025, and ending June 30, 2027.

17 The council on the arts may use up to \$380,000 of moneys in the cultural endowment fund  
18 designated for maintenance for construction of arts across the prairie projects, for the biennium  
19 beginning July 1, 2025, and ending June 30, 2027.

20 **SECTION 4. APPROPRIATION - GIFTS, GRANTS, AND BEQUESTS.** All gifts, grants,  
21 devises, bequests, donations, and assignments received by the council on the arts are  
22 appropriated to the council on the arts for the purposes provided in section 54-54-06, for the  
23 biennium beginning July 1, 2025, and ending June 30, 2027.

24 **SECTION 5. NEW AND VACANT FTE POOL - LIMITATION - TRANSFER REQUEST.** The  
25 council on the arts may not spend funds appropriated in the new and vacant FTE pool line item  
26 in section 1 of this Act, but may request the office of management and budget to transfer funds  
27 from the new and vacant FTE pool line item to the salaries and wages line item in accordance  
28 with the guidelines and reporting provisions included in House Bill No. 1015, as approved by the  
29 sixty-ninth legislative assembly.

30 **SECTION 6. EXEMPTION - LINE ITEM TRANSFERS - REPORT.** Notwithstanding section  
31 54-16-04, the director of the office of management and budget shall transfer funds between line

1 items, excluding the new and vacant FTE pool line item, in section 1 of this Act as requested by  
2 the council on the arts. The council on the arts shall notify the legislative council of any transfer  
3 made pursuant to this section. The council on the arts shall report to the budget section after  
4 June 30, 2026, any transfer made in excess of \$50,000 and to the appropriations committees of  
5 the seventieth legislative assembly regarding any transfers made pursuant to this section.

<sup>1</sup> Funding is adjusted for base payroll changes, including a transfer of \$18,541 from the grants line item to the salaries and wages line item for the cost to continue 2023-25 biennium salary increases.

<sup>2</sup> The following funding is added for 2025-27 biennium salary adjustments of 3 percent on July 1, 2025, and 3 percent on July 1, 2026, and increases in health insurance premiums from \$1,643 to \$1,893 per month:

<sup>3</sup> Funding is added to replace 2023-25 biennium new and vacant FTE pool funding as follows:

<sup>4</sup> Funding of \$23,598 is removed for estimated savings from vacant 2025-27 FTE positions and \$16,519 is added for a new and vacant FTE pool line item resulting in net savings of \$7,079.

<sup>5</sup> One-time funding of \$5,000 from the general fund is added for the arts across the prairie initiative's education component.

This amendment also:

- Adds a section to appropriate all income from the cultural endowment fund to the Council on the Arts during the 2025-27 biennium for furthering the cultural arts in the state, including using \$380,000 of moneys in the fund designated for maintenance for construction of arts across the prairie projects.
- Adds a section to appropriate all income from gifts, grants, devises, bequests, donations, and assignments received by the Council on the Arts during the 2025-27 biennium.
- Adds a section to provide authority for the Council on the Arts to transfer funds between line items and requires the Council on the Arts to report transfers to the Legislative Council, Budget Section, and the Appropriations

Committees of the 70th Legislative Assembly.

- Adds a section regarding the use of funding in the new and vacant FTE pool line item.
