

Safe Schools and Libraries SB 2307

Madam Chair Larson and members of the Judiciary Committee,

My name is Jon K. Uhler. I am a Licensed Professional Counselor in private practice, I am a sex offender treatment provider, and I am founder of the websites: SurvivorSupport.net, ChurchProtect.org, and UnMaskingTheTransMovement.com. I appreciate the opportunity to appear before you, to provide you with a brief overview of the concerns for the protection of children and for public safety that will be addressed by the bill you are considering. The importance of this bill cannot be overstated, given that sexual predators are using libraries and schools as a means of gaining direct access to minors, in a variety of ways, which this bill endeavors to address.

I have worked with sexual perpetrators and predators for over 15 years, within prison, and those on Parole and Probation. Over those years, I have learned a great deal about the minds, motives, and methods of such men, that I never would have known, which the general public is unaware of in terms of how such men hunt, and how much they manipulate good people, toward access minors.

Why is it important to have such legislation? Because of what I know now through my clinical forensic work with predators, that I didn't understand when I first started working with sexually predatory men.

I didn't understand the process of reprobation... of becoming permanently sexually twisted

I didn't understand the process by which someone becomes a sexual psychopath.

I didn't understand the difference between a reactive and impulsive psychopath vs. a sophisticated white collar psychopath

I didn't understand the true nature of sexual deviance.

I didn't understand the stages through which men descend as they become predatorial

I didn't understand the key role porn plays in fast-tracking deviance.

I didn't understand the fact that ever since porn became readily available back in the 1970s, and certainly once it became readily accessible via the internet, that 100% of all sex offenders were deeply steeped in porn prior to arrest, and that 100% of all pedophiles are charged with possession of child rape-porn, and 98% are also charged with dissemination/distribution of it as well.

I didn't understand how predators hunt.

I didn't understand that they love playing good people for fools, and they are driven to always test boundaries and the resolve and insight of those tasked with safeguarding of minors.

I didn't understand that it is more common than not that sophisticated child predators actually worked in positions of trust, respect, and authority, as a Mandated Reporter

I didn't understand how predators use libraries to gain access to minors, to groom them with salacious reading material, and by accessing porn on library computers.

I didn't understand how many victims a predator has perped against prior to ever being arrested.

I didn't understand how many predators had clean criminal background clearances prior to arrest, after having been perping upon minors usually for years.

I didn't anticipate that predators would be so successful in getting grooming material placed into schools, under the guise of Trans and SOGI Sex Ed (Sexual Orientation and Gender Identity).

I didn't anticipate sexually deviant and predatory men crossdressing men in women's underwear and drag being so bold as to work their way right into direct access to vulnerable women and minors, via sports teams, women's prisons, deviant sex ed, and drag queens.... And, even Furrries. A classic example would be the LGBTQ activist, and former Trevor Project executive, Sam Brinton, the former under secretary of energy who stole women's luggage

My message is really quite straight forward... to adequately protect minors from predators, it takes a commitment to an unapologetic high bar approach toward the safeguarding of minors, via firm and clear boundaries, based upon a proper understanding of the ways predators will endeavor to gain access to vulnerable women and minors.

Toward that end I urge a "DO PASS" on Senate Bill 2307. Thank you. I stand for questions."
