SHOWING SECTIONS OF THIS SUPPLEMENT WHERE VARIOUS SESSIONS LAWS FOUND.

All the session laws passed since 1913 which are embodied in this Supplement will be found in this table. Such laws and sections of laws as could be in no way helpful were not so embodied. These included the ordinary repealing clause stating that acts and parts of acts in conflict herewith are hereby repealed, and the ordinary emergency clause declaring the act to be an emergency measure which should take effect and be in force from and after its approval. If more was included so as to be helpful in the construction of the rest of the act, it was included and will be found here. Another class of laws omitted was the appropriation laws, except for the year 1925, and a few of earlier years on subjects not included in the Laws of 1925. A few of the appropriation acts of 1925, such as chapter 19 making an appropriation for Leila Diesem, which could be of no general use were also omitted. A still different class omitted was the concurrent resolutions, such as Laws of 1917, ch. 83, petitioning for certain action on the part of the President or Congress. If any of these contained matter useful for this work such as Laws of 1925, page 312, it was included. Still another class of acts included in the session laws but omitted from this work consists of laws passed by the legislative assembly but vetoed by the governor.
