Victor L. Anderson, who served in the seventeenth and eighteenth legislative assemblies, from the twenty-seventh legislative district, died November 6, 1955.

Theodore G. Buchholz, who served in the twenty-sixth legislative assembly, from the tenth legislative district, died December 2, 1955.

Elmer Carr, who served in the thirty-third legislative assembly, from the forty-sixth legislative district, died January 6, 1956.
