CHAPTER 369

H. B. No. 624 (Snow, Short and Tescher)

PAY OF TOWNSHIP OFFICERS

AN ACT

To amend and reenact section 58-0801 of the North Dakota Revised Code of 1943 and sections 58-0602 and 58-0701 of the 1953 Supplement to the North Dakota Revised Code of 1943 relating to compensation and mileage of township supervisors, clerks and treasurers.

Be It Enacted by the Legislative Assembly of the State of North Dakota:

- § 1. Amendment.) Section 58-0602 of the 1953 Supplement to the North Dakota Revised Code of 1943 is hereby amended and reenacted to read as follows:
- 58-0602. Compensation Of Supervisors.) A township supervisor shall receive as compensation for his services six dollars a day for each day necessarily devoted to the work of his office, but his compensation shall not exceed one hundred dollars in any one year. He shall receive as reimbursement for expenses seven and one-half cents per mile for each mile actually and necessarily traveled in the performance of his duties.
- § 2. Amendment.) Section 58-0701 of the 1953 Supplement to the North Dakota Revised Code of 1943 is hereby amended and reenacted to read as follows:
- 58-0701. Compensation And Fees Of Clerk.) The township clerk shall receive as compensation for his services six dollars a day for each day necessarily devoted to the work of his office. He shall receive as reimbursement for expenses seven and one-half cents per mile for each mile actually and necessarily traveled in the performance of his duties. He shall be paid fees and not per diem for the following services:
 - 1. For serving notices of election upon township officers, twenty-five cents each;
 - 2. For filing any papers required to be filed in his office, ten cents each;
 - For posting notices required by law, twenty-five cents each;

- 4. For recording any order, instrument, or writing authorized by law, ten cents for each one hundred words; and
- 5. For copying any record or instrument on file in his office and certifying the same, ten cents for each one hundred words to be paid by the person applying for the same.
- § 3. Amendment.) Section 58-0801 of the North Dakota Revised Code of 1943 is hereby amended and reenacted to read as follows:
- 58-0801. Compensation.) Each township treasurer shall receive for his services one and one-half percent of all moneys paid out of the township treasury. He shall not receive more than one hundred dollars in any one year nor shall he be allowed a percentage on the balance turned over by him to his successor in office.

SIDEWALKS AND STREET LIGHTS OF UNINCORPORATED VILLAGES

AN ACT

- To amend and reenact sections 58-1601, 58-1603, 58-1604, and 58-1605 of the North Dakota Revised Code of 1943, relating to sidewalks and street lights of unincorporated villages.
- Be It Enacted by the Legislative Assembly of the State of North Dakota:
- § 1. Amendment.) Section 58-1601 of the North Dakota Revised Code of 1943 is hereby amended and reenacted to read as follows:
- 58-1601. Petition For Construction Of Sidewalks Or Installation Of Street Lights In Unincorporated Villages; Contents; Ordering Construction Or Installation.) When a majority of the lot owners on any street in any block within the platted limits of an unincorporated townsite or village shall petition the board of supervisors of the township in which the unincorporated village or townsite, or the greater portion thereof, is situated, praying that a sidewalk be constructed or street lights be installed along the side of a street or thoroughfare

within the platted limits described in the petition, the board, by resolution, shall order the construction of the sidewalk or a portion thereof by the owner of the land along which the sidewalk is to be built, if it appears that the sidewalk described and prayed for in the petition is necessary to connect sidewalks already built or that public convenience and necessity require its construction, and shall order and make all necessary contracts and arrangements for the installation of street lights if the public convenience or necessity require the installation.

- § 2. Amendment.) Section 58-1603 of the North Dakota Revised Code of 1943 is hereby amended and reenacted to read as follows:
- 58-1603. Assessment And Levy Upon Property; Form.) The board of township supervisors shall assess and levy upon each lot or parcel of land along which the sidewalk has been built by the township a sum sufficient to cover the cost of the construction thereof, and shall assess and levy against each lot or parcel of land benefited by the installation of street lights by the township. The assessment shall be in substantially the following form:

The board of supervisors of the township of..... does hereby assess upon and levy against the several parcels of land hereinafter described the respective sums of money set against each lot or parcel. This assessment is made to defray the cost of a sidewalk or street lights along the side of to in accordance with the resolution of the board of township supervisors passed the day of 19..... and duly published inon thedays of levied upon each lot or parcel being the amount that it cost to construct or reconstruct such sidewalk along and fronting upon the same lot or parcel of land. When street lights are installed the cost of such installation shall be assessed and levied against all lots or parcels of land that benefit from the street lights.

- § 3. Amendment.) Section 58-1604 of the North Dakota Revised Code of 1943 is hereby amended and reenacted to read as follows:
- 58-1604. Petition For Repair Or Reconstruction Of A Sidewalk Or Street Lights; Procedure Followed.) If the petition described in section 58-1601 prays for the repair or reconstruction of a sidewalk or street lights, the same procedure shall be had as is prescribed for the construction of new sidewalks or street lights.
- § 4. Amendment.) Section 58-1605 of the North Dakota Revised Code of 1943 is hereby amended and reenacted to read as follows:
- 58-1605. Township Supervisors To Prescribe Material For Construction Or Repair Of Sidewalks Or Street Lights, And To Prescribe The Type Of Light Fixture To Be Used.) The board of township supervisors shall prescribe the material of which the sidewalks shall be constructed or with which they shall be repaired, or the type of light fixture or equipment used or with which they shall be prepared. Whenever a sidewalk to be constructed as provided in this chapter connects sidewalks already in existence, the new sidewalk shall be constructed, as nearly as practicable, of the same material as the sidewalks which it connects.
