SENATE RESOLUTIONS

SENATE RESOLUTION NO. 1 (Nething, Hoffner)

PRESIDENTIAL INAUGURATION ATTENDANCE AUTHORIZED

A resolution authorizing the majority and minority floor leaders, or their designees, to attend the presidential inauguration, excusing their absence, and authorizing expenditure of moneys from the legislative appropriation necessary to cover their expenses.

WHEREAS, the inauguration of Jimmy Carter as the 39th President of the United States on January 20 will mark the beginning of the third century of our independence as a nation; and

WHEREAS, the presidential inauguration symbolizes democracy in action and freedom in the selection of our nation's leaders; and

WHEREAS, harmonious relationships between the three coequal branches of government on the state and federal levels are vital to the success of our democratic society; and

WHEREAS, important decisions which may greatly alter the future course of North Dakota will be made by the President and the executive branch in the next four years; and

WHEREAS, the spirit of goodwill and cooperation between the various branches of state and federal government can be demonstrated by representation at the presidential inauguration during this important turning point in North Dakota history;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Senate authorizes the majority and minority floor leaders, or their designees, to attend the presidential inauguration in Washington, D.C. on January 20; and

BE IT FURTHER RESOLVED, that the Senate excuses their absence to attend the inauguration and authorizes the expenditure of such sums as are reasonably necessary from the legislative appropriation to cover their expenses.

SENATE RESOLUTION NO. 2 (Nething)

SELECT COMMITTEE TO STUDY THE BANK OF NORTH DAKOTA

A resolution creating a select Senate Committee to study and review the administration and operation of the Bank of North Dakota and legislative proposals for use of the Bank, and to report its findings and recommendations to the Senate within fortyfive legislative days after passage of this resolution.

WHEREAS, a 1975 Select Senate Committee conducted a study of the administration, operation, and investment policies of the Bank of North Dakota and made eleven recommendations concerning the Bank of North Dakota; and

WHEREAS, the 1975 Select Senate Committee was limited by available time during the 1975 Legislative Session and was not able to review the effect of proposals concerning use of the Bank for funding various programs and proposals before the 1975 Legislative Session; and

WHEREAS, the Legislative Council's interim committee on Industry, Business & Labor "B" reviewed the extent of implementation of the recommendations made by the 1975 Select Senate Committee, but did not review proposals for use of Bank funds for expanded or new programs proposed for the 1977 Legislative Session; and

WHEREAS, there are a number of proposals before the 1977 Legislative Session concerning use of the Bank to administer or provide funding for existing or new programs; and

WHEREAS, the Legislative Assembly must have facts and data to take informed legislative action concerning use and functions of the Bank of North Dakota; and

WHEREAS, the Forty-fifth Legislative Assembly is in session, and such facts and data must be gathered swiftly and put before the Senate if it is to be the basis of action during this session;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the creation of a select Senate study and review committee is hereby authorized. The committee shall be composed of eight members, five from the majority party and three from the minority party, to be appointed by the floor leaders of the two parties. The

appointments are to be made within two days after passage of this resolution, and the Majority Floor Leader shall appoint the chairman of the committee. The committee is hereby empowered to study and review the administration and operation of the Bank of North Dakota in all its phases, and to review proposals for legislation in the Forty-fifth Legislative Assembly concerning Bank programs, policies, activities, and funding of new or expanded programs. The committee is to report its findings and recommendations to the Senate within forty-five legislative days after passage of this resolution; and

BE IT FURTHER RESOLVED, that the select committee created by this resolution may call upon such persons in the employ of the Bank of North Dakota as it may deem appropriate; and may call upon members of the Industrial Commission, the Legislative Council staff, the State Treasurer, the Commissioner of Banking and Financial Institutions, and any other executive department, agency, office, officer, board, bureau, commission, or institution, or any organization or individual outside state government, for any reasonable assistance in the conduct of its study and review as the committee deems necessary; and

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded immediately by the Secretary of State to each member of the Industrial Commission, to the President of the Bank of North Dakota, to the State Treasurer, and to the Commissioner of Banking and Financial Institutions.

SENATE RESOLUTION NO. 3 (Melland, Lashkowitz)

EARLY COMPLETION OF GARRISON DIVERSION URGED

A resolution supporting and urging early completion of the Garrison Diversion Project.

WHEREAS, the State of North Dakota has suffered the ravages of reoccurring drought throughout its history resulting in tragic impacts to its citizens and severe economic losses to the state; and

WHEREAS, the Garrison Diversion Unit would help stabilize North Dakota's agricultural production and furnish dependable municipal and rural water supplies thereby benefiting a large portion of the state's citizens; and

WHEREAS, the Garrison Diversion Unit will add an estimated \$160 million annually to the economy of North Dakota; and

WHEREAS, the increased and stabilized food production resulting from the Garrison Diversion Unit will be important to hungry people throughout the world; and

WHEREAS, the lake restoration program and recreation development of the Garrison Diversion Unit will result in a greatly expanded tourist industry for North Dakota; and

WHEREAS, the Congress of the United States recognized the necessity of the Garrison Diversion Unit by its authorization in the Flood Control Act of 1944; and

WHEREAS, Congress reauthorized the Garrison Diversion Unit in 1965 and proceeded to fund its construction through subsequent appropriations; and

WHEREAS, the Garrison Diversion Unit is now approximately 20 percent complete and more than \$100 million has been expended towards its completion; and

WHEREAS, the State of North Dakota has transferred to the federal government 62,370 acres of land valued at \$3.6 million as its share of the reimbursable costs associated with recreation and fish and wildlife; and

WHEREAS, the citizens of the Garrison Diversion Conservancy District have invested \$4.2 million for administration of the district in preparation for the operation and maintenance of the project; and

WHEREAS, the State of North Dakota has suffered the loss of 568,000 acres of fertile river bottom farmland for the construction of Missouri River reservoirs necessary as a first stage to the development of the entire Missouri River Basin; and

WHEREAS, the benefits from the reservoir construction on the mainstem of the Missouri River in the form of flood control, navigation, and power generation have been largely for downstream and out-of-state interests; and

WHEREAS, the State of North Dakota and the Garrison Diversion Conservancy District have recognized the concerns of our good neighbors in South Dakota, Minnesota, and Manitoba, and have asked that all legal and administrative means be used for an amicable settlement of boundary water issues; and

WHEREAS, more equitable land acquisition policies have resulted from the recommendations made by the Conservancy District to the Bureau of Reclamation concerning rules and regulations under which the U.S. Bureau of Reclamation and the federal government operate; and

WHEREAS, the Garrison Diversion Conservancy District made recommendations to the North Dakota Congressional Delegation to secure revisions in federal land acquisition and tax laws to assure fair and compassionate treatment of landowners and counties affected by federal projects; and

WHEREAS, those recommendations resulted in passage of HR 9719 which provides for certain payments to be made to local governments by the Secretary of the Interior based upon the amount of certain public lands within the boundaries of such localities; and

WHEREAS, the federal tax regulations concerning capital gains now give the landowners an additional year in which to reinvest money received for their lands purchased for project purposes;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Senate of the Forty-fifth Legislative Assembly wholeheartedly supports and reaffirms North Dakota's need for the water distribution which would be provided by the Garrison Diversion Unit, and further urges the early completion of the plan necessary to bring the long awaited benefits to its citizens; and

BE IT FURTHER RESOLVED, that the President of the United States, the United States Congress, and the Governor of North Dakota are respectfully urged to support and give immediate attention to accelerating the funding for the Garrison Diversion Unit; and

BE IT FURTHER RESOLVED, that accelerated funding is needed not only to complete construction of the Garrison Diversion Unit, but also to provide additional emergency funds to plan and build water systems to meet the continuing critical water supply needs of a large number of North Dakota towns and cities; and

BE IT FURTHER RESOLVED, that the parties responsible for resolution of the International Boundary Waters Treaty issue are respectfully urged to apply the terms and conditions of the Boundary Waters Treaty in a fair and equitable manner giving bi-national consideration to each party's need to utilize and manage its natural resources; and

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded by the Secretary of State to the President of the United States, the Speaker of the U.S. House of Representatives, the President of the U.S. Senate, the Chairmen of the House and Senate Committees on Interior and Insular Affairs, the Secretary of the Interior, the North Dakota Congressional Delegation, and the Governor of North Dakota.

SENATE RESOLUTION NO. 4 (Erdman)

NORTH DAKOTA PORK QUEEN CONGRATULATED

A resolution congratulating Miss Tamera Brandvold for being named 1977 North Dakota Pork Queen.

WHEREAS, the North Dakota Pork Producers Council is an important part of North Dakota's agriculturally based economy; and

WHEREAS, the Council held its Fifth Annual State Convention in Bismarck on January 12-14, 1977; and

WHEREAS, as part of the Council's efforts to increase recognition and appreciation of the pork industry in North Dakota, it has annually sponsored a queen contest; and

WHEREAS, the 1977 North Dakota Pork Queen is the Northwest Pork Council Region Princess, Miss Tamera Brandvold, a student at Bottineau High School and the daughter of Mr. and Mrs. Marvin Brandvold of Bottineau;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Senate extends its sincere and heartiest congratulations and best wishes to Miss Tamera Brandvold, the 1977 North Dakota Pork Queen, as she begins a year of representing the important pork industry in North Dakota; and

BE IT FURTHER RESOLVED, that the Secretary of State send a copy of this resolution to Miss Brandvold.

SENATE RESOLUTION NO. 5 (Nething)

TRI-STATE WATER FORUM SUPPORTED

A resolution supporting the Tri-State Water Forum to be held in Fargo January 31 and authorizing Senators Hoffner and Nething to attend as official representatives of the Senate of the Forty-fifth Legislative Assembly.

WHEREAS, the Tri-State Water Forum will be held in Fargo on Monday, January 31, 1977; and

WHEREAS, the Tri-State Water Forum is designed to stimulate tri-state and international cooperation in the solution of regional water management problems; and

WHEREAS, specific objectives of the Tri-State Water Forum are to emphasize the critical nature of current and future water shortage problems in the Red, Souris, and James River Basins; to establish the importance of the Garrison Diversion Project to stabilize water supplies for municipal, industrial, agricultural, and recreational uses; and to examine the extent to which legal and institutional regulations restrict cooperation; and

WHEREAS, it is expected that the Governors of North Dakota, South Dakota, and Minnesota, and Manitoba's Prime Minister will be taking part in the Forum, along with a host of other key federal, state, and Canadian water officials; and

WHEREAS, as the branch of government charged with the responsibility of formulating the state's water laws, it is important that the North Dakota Legislative Assembly participate in such meetings as the Tri-State Water Forum;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Senate of the Forty-fifth Legislative Assembly express its strong support of the Tri-State Water Forum in its efforts to encourage discussions and cooperation in regional and international water management problems; and

BE IT FURTHER RESOLVED, that Senators Hoffner and Nething be authorized to attend the Tri-State Water Forum as representatives of the Senate, that they be excused for absences caused by such attendance, and that they have their expenses paid by the Forty-fifth Legislative Assembly.

SENATE RESOLUTION NO. 6 (Nething)

SELECT COMMITTEE TO STUDY COMPREHENSIVE EMPLOYMENT TRAINING ACT

A resolution creating a select Senate committee to study and review the operations of the Federal Comprehensive Employment Training Act as it affects political subdivisions and nonprofit corporations in North Dakota.

WHEREAS, federally supported job creation programs seem prevalent in North Dakota; and

WHEREAS, the new national administration places emphasis upon the continuation and expansion of such programs; and

WHEREAS, manpower training programs, such as the Comprehensive Employment Training Act (CETA) programs, can, and often do, have substantial effect upon the budget and operations of political subdivisions; and

WHEREAS, private, nonprofit corporations can be, and sometimes are, the recipients of funds under such programs; and

WHEREAS, comprehensive knowledge of programs such as the CETA program is necessary to ensure sound legislative decisions concerning the fiscal needs of political subdivisions, and the operations of nonprofit private entities subject to legislative control;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the creation of a select Senate committee is hereby authorized. The committee shall be composed of eight members, five from the majority party, and three from the minority party, to be appointed by the floor leaders of the two parties. The appointments are to be made within three days after passage of this resolution, and the Majority Floor Leader shall appoint the chairman of the committee. The committee is hereby empowered to review and study the administration operation, grant policies, and effect of CETA programs as they affect political subdivisions and nonprofit corporations or organizations. The committee shall have the power of subpoena which shall be utilized in accordance with chapter 54-03.2 of the North Dakota Century Code. The committee is to report its findings and recommendations to the Senate within forty legislative days after passage of this resolution; and BE IT FURTHER RESOLVED, that the select committee may call upon such persons in the employ of the Employment Security Bureau, the executive branch of state government, any political subdivision, and the Legislative Council staff, for any reasonable assistance the committee deems necessary; and

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded immediately to the Governor and the Executive Director of the Employment Security Bureau.

WHEREAS, he is a longtime member of the Society of Professional Journalists - Sigma Delta Chi, and the North Dakota Newspaper Association, and was honored by the North Dakota Associated Press Association for a half century of distinguished service; and

WHEREAS, Hal Davies and The Minot Daily News have been at the forefront of those promoting good government through open meetings and open records; and

WHEREAS, in a rarity in union-management relations, the Minot local of the International Typesetters Union made Hal Davies a lifetime member, thus showing the esteem in which he is held by those concerned with the production of The Minot Daily News; and

WHEREAS, he has throughout his career been a constant and most articulate proponent of the proper use of North Dakota's water resources, and was one of the originators of the Garrison Diversion movement; and WHEREAS, his high quality work in the field of water development has earned him awards from the Garrison Conservancy District, the State Water Commission, the North Dakota Water Users' Association, and the North Dakota Irrigation Districts Association; and

WHEREAS, he is the recipient of one of the federal government's highest awards to citizens, the Bureau of Reclamation's Citizen's Award, for his work with Garrison Diversion; and

WHEREAS, his work with state water resources also led to his commissioning as a Commodore in North Dakota's Mythical Navy; and

WHEREAS, he has devoted a lifetime of service to the YMCA in Minot, having served as its president, as the chairman of its board, as a leader in its various fund drives, and generally as one of its guiding lights throughout its years in Minot; and

WHEREAS, he has recognized throughout his career the importance of highway transportation in North Dakota and has been an ardent supporter of the state's highway system, including service as president of the Highway Two Association; and

WHEREAS, he has held a host of civic offices in Minot, including president of the Minot Rotary Club and president of the Minot Chamber of Commerce; and

WHEREAS, he has long been interested in North Dakota's cattle industry, and is a past president of the Mouse River Cattlemen's Association and is a charter member of the National Cowboy Hall of Fame; and

WHEREAS, the North Dakota Bar Association, when it instituted its prestigious Liberty Bell Award to honor the contributions of outstanding North Dakotans, chose Hal Davies as the initial recipient in 1972;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Senate of the Forty-fifth Legislative Assembly officially uses this means to pause and take note of the truly unique and outstanding career of Hal S. Davies, a career that has been built not only on professional excellence in the newspaper field, but on singular achievements in civic and state matters such as water resources, highway transportation, the YMCA, and the cattle industry, a record which certainly qualifies Hal S. Davies for the richly deserved plaudits of his fellow citizens as well as congratulations of the Forty-fifth Legislative Assembly; and

SENATE RESOLUTION NO. 10 (Lashkowitz, Naaden)

PRESIDENT INVITED TO VIEW GARRISON DIVERSION

A resolution urging President Carter to visit North Dakota to discuss the Garrison Diversion Project.

WHEREAS, North Dakotans have registered deep concern and anxiety over the revelation that funds for the much-needed Garrison Diversion Project have been deleted from the budget President Jimmy Carter has submitted to Congress; and

WHEREAS, the need for water in North Dakota and the other Upper Midwestern and Western states is as great now as it has been since the drought-stricken 1930's; and

WHEREAS, the need for water is a basic need for human consumption and to grow food, the very essentials of life-sustaining activities; and

WHEREAS, North Dakotans are shocked and sick at heart at the unfortunate action that came without warning cutting Garrison Diversion funds from the budget at a time when North Dakota farmers are facing the very real possibility of drought years, when North Dakota cities are desperately seeking water sources, and when some cities have been forced to implement water rationing; and

WHEREAS, a trip to North Dakota would enable President Carter to view firsthand the need for the Garrison Diversion Project and to visit with citizens at the grass roots level to get the benefit of their views, concerns, and expertise regarding Garrison Diversion; and

WHEREAS, North Dakotans are looking to the Forty-fifth Legislative Assembly to take the initiative in meeting the mounting difficulties facing the Garrison Diversion Project;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Senate of the Forty-fifth Legislative Assembly of the State of North Dakota hereby extends to President Jimmy Carter an invitation to visit North Dakota as soon as possible to view firsthand the vital need for the Garrison Diversion Project and to discuss with local officials and citizens on the grass roots level the very human needs, concerns, and anxieties involved with an irrigation project such as Garrison Diversion which involves the basic human needs of food and water to a very real extent, not only for North Dakotans, but to the United States and world agricultural markets; and

BE IT FURTHER RESOLVED, that the Senate of the Forty-fifth Legislative Assembly urges Governor Arthur Link, the state's elected public officials, and the legislative leaders of both parties to take immediate steps to obtain and facilitate a visit to the state by President Jimmy Carter; and

BE IT FURTHER RESOLVED, that the Secretary of State send an original copy of this resolution to President Jimmy Carter and that additional copies of the resolution be sent to the North Dakota Congressional Delegation, the Secretary of the Interior, the Speaker of the House of Representatives, the Vice President of the United States, and the chairmen of the House and Senate Appropriations and Interior and Insular Affairs Committees.

SENATE RESOLUTION NO. 13 (Committee on Delayed Bills) (At the request of Senators Nething, Hoffner)

CRUDE OIL PORT FACILITY CONSTRUCTION URGED

A resolution urging the legislature and executive officials and agencies of the State of Washington to encourage and permit the construction of appropriate port facilities for unloading crude oil for shipment by pipeline to the northern states, including the State of North Dakota.

WHEREAS, a substantial portion of the crude oil used by the petroleum refinery at Mandan, North Dakota, has originated in the Dominion of Canada, but the government of Canada has recently announced sharp curtailment in the supply of crude oil to the United States, and the refinery at Mandan is presently unable to operate at full capacity due to a shortage of crude oil; and

WHEREAS, the government of Canada has recently announced eventual, complete denial of international exportation of Canadian natural gas from Canada to the United States, including the State of North Dakota, and has allowed exportation of such fuel only at greatly increased cost to distributors and consumers in the United States; and

WHEREAS, the refinery at Dickinson, North Dakota, is currently experiencing difficulty in obtaining sufficient crude oil to meet its refining needs; and

WHEREAS, agriculture, labor, industry, and the entire economy of the northern states are imperiled in that the United States has become dependent for almost 50 percent of its petroleum requirements upon imports of foreign crude oil, and the lack of sufficient energy reserves during the winter of 1976-1977 has caused the closing of schools and industries, with resulting unemployment, in the northern states; and

WHEREAS, port and pipeline facilities from the west coast will provide a crude oil supply system for the northern states that is completely within the boundaries of the United States and is not subject to interruption, burdens, or regulation by foreign governments; and

WHEREAS, crude oil from Alaska will become available to the northern states beginning in the fall of 1977, and this crude oil, or products produced therefrom, could be utilized in the states of Washington, Idaho, Montana, North Dakota, South Dakota, Minnesota, Wisconsin, Michigan, Indiana, Ohio, and Illinois, if port and transportation facilities are available; and

WHEREAS, it is feasible at the present time to build port facilities to deliver crude oil to the northern states, such construction being compatible with environmental safety and yet possibly helping to avoid a shortage of crude oil;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Senate of the Forty-fifth Legislative Assembly urges the legislature and executive officers and agencies of the State of Washington to encourage and permit the construction of appropriate port facilities for unloading crude oil for shipment by pipeline to the northern states, including the State of North Dakota; and

BE IT FURTHER RESOLVED, that the Senate of the Forty-fifth Legislative Assembly urges the Governor of the State of North Dakota to consult with the Governor of the State of Washington as to the manner and methods whereby this encouragement and construction may be accomplished; and

BE IT FURTHER RESOLVED, that copies of this resolution be forwarded by the Secretary of State to the Honorable John Cherlberg, President of the Senate of the State of Washington; to the Honorable John Bagnariol, Speaker of the House of Representatives of the State of Washington; and to the Honorable Dixie Lee Ray, Governor of the State of Washington.

WHEREAS, the passage of such legislation will contribute to an already unacceptable level of construction unemployment;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Congress of the United States and the President of the United States respectfully be urged not to approve proposed legislation that would legalize secondary boycott activities by construction unions on construction sites; and
