Agenda: Presentations by the Office of Management and Budget on the status of the state general fund, state gas tax collections, and tobacco settlement proceeds; by the State Engineer on the status of the statewide water development program; by the Department of Human Services on the status of the intergovernmental transfer program, proposed reductions to the Social Security block grant, funding for traditional Medicaid grants, and additional full-time equivalent positions hired; by the Department of Public Instruction on the details of the new business communication specialist position; by the North Dakota University System on a request to modify the annual local fund budget tracking report and the status of flood damage and repair at the University of North Dakota and North Dakota State University and a related deficiency appropriation request; and by the Legislative Council staff on federal funds to be received by state agencies during the 1999-2001 and 2001-03 bienniums and a memorandum on block grant hearings required during the 2001 legislative session.
