



The North Dakota Department of Corrections and Rehabilitation (DOCR) maximum operational capacity for men and women inmates is 1,624 and 224, respectively. The operational capacity consists of inmate housing at the North Dakota State Penitentiary, James River Correctional Center, Missouri River Correctional Center, Dakota Women's Rehabilitation and Correctional Center, contractual treatment, transitional / community housing facilities, and contract beds in county and regional correctional facilities. When the average daily inmate population, specific to gender, for a discrete month exceeds the maximum operational capacity, the DOCR will implement the inmate admission prioritization plan the following month. Currently, admissions to DOCR custody are not being prioritized pursuant to North Dakota Century Code Section 54-23.3-11.

Currently both male and female populations are below operational capacity. However, in effort to mitigate the impact of COVID19 the DOCR took action to defer the admission of the individuals' sentence to the DOCR under the authority of an executive order issued by Governor Burgum. The DOCR continues to take action to mitigate the spread of COVID19 to our incarcerated populations.

The DOCR in coordination with the North Dakota Department of Health establish Vulnerable Population Plan (VP3). Protocols were establish and shared with sheriffs and jail administrators throughout North Dakota. The VP3 Plan not only established a mitigation plan to resume admissions to the DOCR it also provided guidance to local administrators. The DOCR requested CaresAct funding in order to provide compensation to the local correctional facilities for housing DOCR sentence individuals.

The pages following contain the DOCR VP3 plan shared with the regional correctional centers and sheriffs, statistics on the number of deferred admissions, and compensation paid to local facilities for housing DOCR sentence individuals.

We would like to express our gratitude to our local correctional partners for assisting the DOCR with efforts to mitigate the impact of COVID19 in correctional facilities throughout North Dakota. These efforts protected staff, residents, and help to reduce the impact of COVID19 patients using medical resources in facilities throughout North Dakota.



DOCR VP3 PLAN

Justice involved individuals who are detained or incarcerated represent vulnerable populations. Close quarters for eating and recreation are the rule, and congregate housing is typical. Transport between facilities most often involves groups of justice involved individuals in vans. Social distancing cannot be maintained in such environments. Risk for COVID infection is high, as is the rate of spread of the infection in these environments. Additionally, there are high rates of underlying health conditions among justice involved individuals. Given these conditions, the ND DOCR in coordination with the ND Department of Health has established a process for accepting admissions from North Dakota county and regional correctional facilities.

1. Correctional facilities must have an established robust COVID-19 containment and mitigation plan in place prior to transferring individuals to DOCR facilities. A robust plan includes these elements:
 - a. Protocols requiring staff to wear PPE, specifically masks throughout the facility. Please send your protocol to Lance Anderson lwander@nd.gov and Robert Werlinger rwerlinger@nd.gov for review.
 - b. Staff and detainee screening are performed upon arrival to the facility.
 - c. COVID positive staff members isolate at home and do not work at the correctional facility while infectious.
 - d. Staff close contacts as determined by the ND DoH guidelines of COVID positive individuals self-quarantine and do not work at the correctional facility during the quarantine period.
2. Individuals who are candidates for transfer to DOCR will undergo COVID testing within 5 days of transfer. Once tested, these individuals will be kept in quarantine only with others set to transfer to the ND DOCR at the correctional facility to minimize risk of cross-contamination prior to transfer. Documentation of negative result is required to obtain approval for transport.
3. The ND DOCR plans to accept adults in custody transferring in groups up to 60 males and 8 females. These individuals will remain in quarantine at ND DOCR intake facilities for a period of 4 weeks during the classification process.

The goal of the ND DOCR is to accept up to 60 adult male new arrivals starting June 3 – June 12, 2020. The goal for adult female admissions will be the week of June 15, 2020.
