Evidence Based Programs Utilized

Criminal and Addictive Thinking – Cognitive Behavioral Therapy that treats addiction in law-involved clients

Cognitive Behavioral Interventions – Core Curriculum – Provides a thorough intervention that broadly targets all criminogenic needs

Risk / Needs Assessment - Treatment dosage hours determined by level of risk

Thinking for a Change – Stresses interpersonal communication skills development and confronts thought patterns that can lead to problematic behaviors

CBI – Substance Abuse - Cognitive Behavioral approach to teach participants strategies for avoiding substance abuse

Victim Impact Panel - Participants undergo several classes focusing on how criminal behaviors impact others. The culmination of this program involves volunteers who have been victims of various crimes speaking with participants regarding how their lives have been altered by crime.

Gallatin County Re-Entry Program Bozeman, Montana



Located on property owned by Gallatin County. CCCS designed, financed, and constructed facility that transferred to the County after the debt service was completed (10 Years).

Activated Facility in December 2005.

Multiple use (pre-release/work-release/drug court sanction/detention/re-entry) facility for adult male offenders.

40-bed capacity including county (work-release/re-entry/drug court/detention) beds and state (pre-release) beds.

Other Programs include; Cognitive Principles and Restructuring, Life Skills, Anger Management, Relapse Prevention, Parenting, and others based on the needs of the offender.

Offer a drug and alcohol sanction group for probation and parole violators.

Residents are currently 100% employed.

Other benefits are that offenders pay taxes, room and board, family support, restitution, community services, etc.



<u>Sanction</u>, <u>Treatment</u>, <u>Assessment</u>, <u>Revocation</u> and <u>Transition</u> center for adult male offenders developed as an alternative to prison or jail for those individuals who have violated the terms of parole, probation, or pre-release placement.

Original facility activated in December 2005.

New \$12.3 million state-of-the-art facility opened its doors in July 2010 near Anaconda

152 bed capacity

Secure- double bunked cells

Highly structured intensive treatment models designed to encourage cognitive and behavioral change



START Facility Anaconda, MT

Sanction/Assessment placement ranging from 10-180 days

Offenders assessed and sanctioned with emphasis of returning to the community

No upfront capital for construction costs of facility

Average stay of approx. 55 days

Reduced admission to the prison by 90%

Taxpayer Cost savings - 55 day average stay vs. 12-24 months in prison.

Elkhorn Treatment Facility – 42 Beds (Female Offenders)

Passages – 55 Beds (Female Offenders)

Connections Corrections Program East - *Butte, Montana*

CCCS purchased buildings in Uptown Butte in 1997 and infused \$1.0 million in renovations to its current use as an addictions treatment facility.

Began providing service in March 1998.

90-day intensive addictions treatment program for adult male offenders.

2 Locations: Butte Montana and Warm Springs Campus.

Treatment is a hybrid between Traditional Minnesota or Medical Model of treatment and with some aspects of a Modified Therapeutic Community.



WATCh West Program Warm Springs, Montana

Located on a state hospital campus, owned by the Montana Department of Corrections and leased to CCCS

Began providing services in February 2002

6-month modified therapeutic community for adult male, 4th or subsequent DUI offenders

81-bed capacity

Contracts with the Montana Department of Corrections

Texas Study – NIJ in conjunction with the University of Texas at San Antonio

Cost Analysis 6 months of treatment vs. 24 months in prison/jail.

WATCh East *Glendive, Montana*

Located at a facility owned by the Montana Department of Corrections and leased to CCCS

Began providing services in February 2005

6-month modified therapeutic community for adult female offenders and some male offenders from Eastern Montana, all 4th or subsequent DUI offenders

52-bed contract capacity

Additional physical plant capacity located on the former EastMont Campus, Glendive, MT

Contracts with the Montana Department of Corrections

Cost Analysis 6 months of treatment vs. 24 months in prison/jail

Repurposing – Licensed Substance Use Facility – 32 Beds – Medicaid Eligible Clients



Nexus Correctional / Treatment Facility Lewistown, Montana

Designed, financed, constructed, and owned by CCCS

\$9.2 Million Facility - Secure residential treatment facility - non climbable fence and secure sally ports and vestibules. All movement supervised and controlled

88-bed capacity for adult male offenders – Additional bed capacity available

Located next to a little league baseball field (NIMBY)

9-month modified therapeutic community for offenders convicted of 2nd or subsequent Methamphetamine possession and offenders whose criminal offense and/or violations are associated with Methamphetamine related behavior

Construction began May 2006. First family members arrived June 1, 2007

Contracts with Montana Department of Corrections

No upfront capital costs for construction to the State of Montana (long range planning)

Existing infrastructure designed for expansion

10-Year Study completed by University of Montana







Martin Hall Juvenile Detention Facility Medical Lake, Washington

Facility is located on a state-hospital campus, owned by the State of Washington, leased to the Martin Hall Juvenile Detention Facility Board, and sub-leased to CCCS.

CCCS began operating facility in November 1999 under contract with a 11-county consortium in Eastern Washington.

Detention facility for juveniles.

Located in Medical Lake, Washington.

63-bed capacity.

Contracts with several counties in Eastern Washington as well as with the Bureau of Indian Affairs (BIA) and several Native American Tribes in Eastern Washington.



Discovery House Anaconda, MT

Short-term shelter care facility serving Southwest Montana

In existence since 1974—CCCS, Inc. took over operations April 1, 2007

Member of the National Network for Runaway and Homeless Youth

Licensed by the State of Montana Department of Public Health and Human Services

9 bed facility



CCCS Transport Services

24+ years experience providing adult and juvenile transport services for federal, state and local governments in Montana, Washington and North Dakota

Transportation is provided using state-of-theart secure caged vehicles

Professionally trained staff, transportation will be done by professionally trained staff, when females are transported one staff member of same sex will be present

Vehicles equipped with necessary restraints in accordance with acceptable correctional policies, procedures and practices

All facilities also provide non-secure transportation services when appropriate

Vehicles and staff members adequately insured, users name on policy as additional insured

SMART- Southwest Montana Addiction Recovery and Treatment Program is a State-approved, out-patient treatment center for Butte and Southwest Montana



CCCS Drug Toxicology Lab is C.O.L.A. / CLIA Certified and provides Urinalysis / Breathalyzer Testing



Galen, Montana

Designed, financed, constructed, and owned by CCCS. \$9.5 million facility. Construction amortized over 20 years.

Began providing service in December 2002.

Former juvenile correctional (long-term)/detention (short-term) facility – RYO Facility.

State-of-the-Art Facility - Leased to the State of Montana DPHHS under a 20 year agreement (Feb 2016).

Expended \$1M renovating the facility to address State of Montana concerns.



Special Projects *Montana Chemical Dependency Center*

The M.C.D.C. Facility is a flagship, state-of-the-art, 48 bed residential treatment facility. CCCS, Inc. was the successful respondent to a competitive Request for Proposal (RFP) that was released by the State of Montana in August 2012, to complete a "turn-key" (design, build, finance, lease) project for the Department of Public Health and Human Services.

CCCS also provides food service to the M.C.D.C. Program

No upfront capital expended from the State of Montana (long term lease)

Only publically funded inpatient treatment in the State of Montana





Bismarck Transition Center Bismarck, North Dakota

Began providing services in August 2002

Transition center for adult offenders in North Dakota – 63 Bed Capacity

Facility expanded to 160-bed capacity for adult offenders in June 2006 – Building Addition

Contract with North Dakota Department of Corrections and Rehabilitation, US Probation and Parole, and local cities and counties in North Dakota to provide work-release and detention beds utilizing jail alternative program.

ACA accredited facility.

Unique public / private partnership.

Full menu of services and treatment offered depending on the needs of the contracting agency.
