CHAIRMAN BERG called the hearing for HB 1096 to order.

1B: 4.8 RON GUMERINGER, Labor Standards Supervisor for the ND Department of Labor, testified in support of the bill. He said that the bill is not presenting a new issue, it is simply for clarification.

1B: 6.7 REP. LEMIEUX asked what the cost of each drug test would be. Mr. Gumeringer said the cost would run from \$15 to \$43. Rep. Lemieux continued his questioning, asking who would be negatively impacted, regarding who would pay for the costs of testing. Mr. Gumeringer replied that the bill clarifies that when an employer requires the employee to take a drug test, the employer will bear the cost.

1B: 8.8 REP. STEFONOWICZ asked if there were any cases in the state in which the employee has had to pay for their own test. Mr. Gumeringer said that this has happened.

1B: 9.4 REP. EKSTROM questioned the possible dangers of repetitive testing on individuals in certain industries such as trucking. Mr. Gumeringer did not have the information available.

CHAIRMAN BERG adjourned the hearing on HB 1096.

1B: 12.2 ACTION ON BILL REP. KEISER made a motion for a DO PASS. The motion was seconded by Rep. Klein. A roll call vote was taken. The bill passed and Rep. Lemieux will carry it to the House floor.

Good morning Mr. Chairman and members of the House Industry, Business, and Labor committee. For the record, I am Ron Gumeringer, Labor Standards Supervisor for the North Dakota Department of Labor. I appear before you today in support of HB 1096 relating to the clarification of payment for an employment-related medical examination.

The purpose of this bill is to specify in NDCC 34-01-15 that when an employer requires an employee or potential employee to take a test for the presence of drugs or alcohol, as a condition of retaining or obtaining employment, such test is construed as a medical exam and thus the cost of the test is to be incurred by the employer.

The Department of Labor is receiving an increasing number of inquiries from North Dakota employees and employers seeking information on this issue. At present, the North Dakota Department of Labor views a medical examination as incorporating the testing for drugs or alcohol.
