# House Human Services Committee HB1118 January 12, 1999

Good afternoon Chairman Price and members of the House Human Services committee.

I am Gladys Cairns and I serve as the administrator for child protection services for the Children and Family Services Division of the Department of Human Services. I am here today to provide information in support of House Bill 1118.

This bill was introduced as a result of a change in the federal Child Abuse Prevention and Treatment Act (CAPTA). The change dealt with the confidentiality of information gathered as a result of an assessment or investigation of a report of suspected child abuse or neglect. As you may know the information gathered as a result of our child abuse and neglect law is confidential and shall not be disclosed but to certain entities designated by the North Dakota statute.

There has been elevating concern over the years about the deaths of children caused by abuse and neglect while there is an open child protection service case. Communities are concerned about how a fatality or near fatality could happen when a concern has been reported and there is an expectation that the concern is being dealt with through protective services.

Child Protection Services in other states has been accused of hiding behind the confidentiality of the law. The federal act was changed to say states needed to be able to disclose information about what had been done about the concerns reported where child abuse or neglect caused a fatality or near fatality.

It is my belief North Dakota citizens are served well by the provision of quality Child Protection Services through the County Social Services offices. To date, to my knowledge, we have not had any deaths of children caused by abuse or neglect after we began a child protection assessment and obviously I am expecting we will not have such a case. However, if a child was abused or neglected after we became involved and as a result the child died, it is our position we should be able to disclose information about how we had handled the case.

I ask for your support of this bill. I would be please to attempt to answer any questions you may have. Thank you.
