Minutes:

REP. KOPPELMAN: This is an attempt to help identify sex offenders to law enforcement officers. HB 1031 came out of the Criminal Justice Interim Committee and called for an identifying mark on an offender's drivers license. I think HB 1205 does the same thing in a better way. This legislation will create a situation that when an officer makes a stop and calls the stop in to state radio, he will be told if the person stopped is on the offender registry. This will be cheaper, more discreet and more effective.

JONATHAN BYERS (AG) I am not here to be for or against this bill, but just to provide information. This bill will have a fiscal effect on Attorney General's office which will be covered by a federal grant. Law enforcement will keep the list restricted and will only tell those who have a right to know if they are dealing with an offender.

This bill allows for the accessing of information about those offenders on the registration list by persons who most need to know. It is important that law enforcement have access to this information upon request especially when stopping vehicles in which children seem to be upset or agitated.

The Caucus supports the Attorney General supplying this information to the Department of Transportation where license plate characters or license driver's numbers can readily access it. Many members were surprised that this information was not available in this means.


In studying other bills concerning the same information, this bill seems to be a reasonable compromise in protecting children and the right to know.

Testimony on House Bill 1205 before the Senate Judiciary Committee by Rep. Kim Koppelman 3-1-99

Mr. Chairman and Members of the Senate Judiciary Committee, I am Rep. Kim Koppelman and I represent District 13, which consists essentially of West Fargo and a small surrounding rural area.

House Bill 1205 would give law enforcement officials virtually instantaneous notification of a convicted sex offender's status. I believe this may prove an invaluable law enforcement tool and, consequently, an important deterrent to combat these heinous crimes in our state.

Under this legislation, we can make use of the technology available to us to alert law enforcement personnel in situations when it could make a life and death difference. It will make a convicted sex offender's status known to law enforcement, when a check is run on that individual's driver's license or license plate. This would alert an officer investigating a suspicious situation and possibly lead to the prevention of crimes.

In the past interim, the Criminal Justice Committee studied this issue and proposed a bill which would have placed a "Y" on the driver's license of convicted sex offenders. While this bill was motivated by some of the same worthwhile objectives, it also, in my opinion, was flawed legislation. Both the law enforcement community and the House of Representatives agreed and that bill was defeated in favor of this approach.

Mr. Chairman and Members of the Committee, I urge a "Do-Pass" recommendation on House Bill 1205 and I'll be happy to attempt to answer any questions you might have.

HOUSE BILL 1205 MARCH 1ST, 1999 SENATE JUDICIARY COMMITTEE FORT LINCOLN ROOM

Testimony by Jonathan Byers, Assistant Attorney General

Chairman Stenehjem, members of the Senate Judiciary Committee:

I appear on behalf of the Attorney General and testify in support of House Bill 1205. This bill was introduced as an alternative to having a mark appear on the driver's license of registered sex offenders. The intent is to make sure that officers making traffic stops are informed whether the motorist is a registered sex offender.

The Attorney General has indicated that although there may be a fiscal impact for providing this information, a federal grant that we have received will cover those expenses. The system is expected to be operational in July 1999.

The bill requires the Attorney General to provide information in a form that is referenced by the driver's license number or number plate characters. The information that is available in July 1999 will reference driver's license numbers.
