Grafsgaard: The language is amended to refer to them.

Rep. Haas: How do you see that tied to the removal of the requirements of the health

certification.

Grafsgaard: Serves no purpose.

Rep. Nelson: School food service personnel, the rules and training session, there is no mention

of hours of training.

Grafsgaard: We will use administrative rule process.

Rep. Nelson: What is required now?

Grasfgaard: There is no requirement.

Rep. Nelson: The child care providers, what would be the requirements for those people.

Gragsgaard: There are specific rules set by the Department of Human Services.

Rep. Nottestad: Would you describe what is a school service facility.

Grafsgaard: There would be a preparation kitchen, or a receiving kitchen, a satellite kitchen

which has a end production.

Rep. Nottestad: A full time director, do they get the same training.

Grafsgaard: If that person was directly involved with food preparation, yes we would.

Rep. Nottestad: Why not train them to deal directly with the workers?

<u>Grafsgaard</u>: That is a possibility. Most schools have a kitchen manager.

Rep. Nottestad: Would that be placed in the rules?

Grafsgaard: Yes.

Rep. Nelson: Is this training duplicated elsewhere?

Grafsgaard: I'm not aware of any.

Rep. Haas: Were you involved in the preparation of the fiscal note?

Grafsgaard: Yes.

Rep. Haas: The cost that you have, is that department cost?

Grafsgaard: No, that is the net cost.

Rep. Nottestad: Did you figure what it would cost the local school district?

Grafsgaard: Yes.

Kirby Kruger: Epidemiologist with the North Dakota Department of Health. (see written

attached).

Rep. Nottestad: In the food industry, are those people all brought together and given formal training?

Kruger: No.

Rep. Nottestad: How is it comparable?

<u>Kruger:</u> It is comparable, because the private sector goes through educational services from the Division of Food and Lodging during inspection.

Rep. L. Thoreson: Is there any follow up on the training, what standards are met?

Kruger: I think Kathy can better answer that question.

<u>Dixie Schultz</u>: Food Service Director at Mandan. spoke in favor of HB 1233.

Al Stenejhem: Executive Director of the Hospitality Association. spoke in favor of HB 1233.

Rep. Nottestad: This is a voluntary program, what type of response are you getting?

Stenejhem: The program is costly, I had eight classes this year and a waiting list for the next class.

Dan Hoffman: Assistant Superintendent of Fargo Schools. spoke in support of HB 1233.

Rep. L. Thoreson: What is the follow up the process?

<u>Grafsgaard:</u> The follow up is done routinely, with visits and observation and periodic work shops.

Rep. Nelson: When the health department does its inspections does the DPI do follow up also.

<u>Grafsgaard:</u> Not all counties have access to the services of the Health Department. By federal regulation our office must review school districts once every four years.

Rep. Nelson: Then you can double up on the same school in the same year and other schools not seen at all.

Minutes:

SENATOR FREBORG opened the hearing on HB1233. All senators were present.

REPRESENTATIVE RAE ANN KELSCH, DISTRICT 34 introduced HB1233. Basically this bill would require that the lead manager for a school or child care facility would have to have ongoing safety training in food and preparation. It would repeal the section that requires the food service personnel to have a health certificate. We currently are one of the only states if not the only state that requires a certificate for food service personnel and it is something that is antiquated. If you go in and get a health certificate it only means that you are healthy today and that is not something that says you'll be healthily tomorrow. If we train these workers to properly handle food that is going to be the best thing for students.

SENATOR O'CONNELL: Is anyone set up for this kind of training and what kind of courses, how many hours, etc. Why did you put the amendments on.

Rep. Kelsch: Kathy will address your questions.

Testimony in Favor: Kathy Grafsgaard, Director of Child Nutrition and Food Distribution

Programs, DPI. The bill would implement a requirement for the manager or lead worker in the

child care facility to have initial training and periodic updates in food safety and sanitation.

Written testimony attached.

SENATOR O'CONNELL: How long a program is this and basically how difficult.

Judy: The lead worker in the food service would have sanitation and food handling training that

would be in the neighborhood of about 10 hours in length. This is a standard course offering by

the Dept., whatever other courses are offered by other organizations and agencies that vary in the

length of time that is required for the training. The person would probably have an initial

training and then perhaps update every three or four years. A certificate or award would be given

upon completion. A complete record would be kept for DPI.

SENATOR WANZEK: The lead worker would be the only one getting the training.

Kathy: We view the lead worker as being the most critical person to oversee the operations of

food preparation. It is our view that person would be the only one required to have the training.

It is likely that others will already have had it and probably already do. The requirement meets

the means of being a lead worker, it limits cost to the school district and provides a mechanism

where there is a a reporting system. The other workers in the food service would report to the

lead worker. The system would be set up for supervision and oversight.

SENATOR WANZEK: Would that put more liability risk on that lead worker or more

accountability on them.

Kathy: Perhaps more accountability.

SENATOR COOK: Give me some idea of the sort of child care facility that is underneath the administration of DPI.

Kathy: We administer the child development program and that ranges from Head Start Centers, to private nonprofit corporations. There are currently 80-90 and they care for in the range of 20-100 children in each facility.

SENATOR COOK: Do these child care facilities also fall under the law that is being repealed here. Are they required to have a health certificate.

Kathy: No, they are not required currently, that only applies for school food service.

My name is Kathy Grafsgaard and I am the Director of Child Nutrition and Food Distribution for the Department of Public Instruction. I am here to speak in favor of HB 1233.

The bill would implement a requirement for the manager or lead worker in a school or child care facility to have initial and ongoing training in food safety and sanitation. This would apply to local agencies that participate in the National School Lunch, School Breakfast and Child and Adult Care Food Programs as administered by the Department. We believe that this type of training is imperative in order to protect children in schools and child care centers from the potential of food borne illness. Children are especially vulnerable to the effects of food borne illness.

As an educational agency, we believe that the training of school and center personnel is an effective approach. It is desirable to help employees gain the knowledge necessary to be effective in their jobs in food service.

Numerous training opportunities are available statewide to food service

personnel. The DPI will continue to offer high quality training programs statewide at no or very minimal cost to participants. Other organizations and groups also offer quality programming on this topic. All training is consistent with standards established in the food service industry.

The bill also repeals a section in the chapter that requires school food service personnel to file a health certificate annually prior to the first day of employment. To do this requires that the individual visit a licensed physician who is asked to state that the employee is not afflicted with any communicable disease. This requirement applies to all employees in school foodservice, over 1300 people in North Dakota. It provides no assurance concerning the onset of communicable disease during the rest of the school year. We support repeal of that section.
