Representative Klein, Chairman of the GVA Committee opened the hearing on January 21, 1999.

Summary of the Bill: Relating to real estate license continuing education requirements.

Testimony in Favor:

Representative S. Kelsh, Appeared before the committee and to introduce the bill he sponsored.

The amendments put a sunset clause on this bill.

Representative Thoreson, Couldn't the fee be set in code or can the board set it?

Kelsh, Yes.

<u>Representative Devlin</u>, What is the annual fee now? Essentially what were doing is doubling the fee if they don't fill the requirements each month or is that for 12 months. Aren't we lowering the standards for real estate agents?

Jeff Schlossman, The fee is 60 dollars for broker and 50 for salesman. I don't think it's lowering

<u>Representative Cleary</u> The mandated classes are only given in ND? There's no other place you can get them.

1. Please estimate the fiscal impact (in dollar amounts) of the above measure for state general or special funds, counties, cities, and school districts.

Narrative: House Bill 1279 provides that a person who does not satisfy the continuing education requirements when due at the conclusion of every three year period shall pay, in addition to the renewal fee, the sum of ten dollars for each month or fraction of a month after January first during which the continuing education requirements are not satisfied. It is difficult to determine how many licensees would take advantage of this provision and pay the fine rather than obtain the required hours at the end of the three year cycle. We estimate that approximately 100 licensees might choose to pay a fine and that approximately three months would be the normal period during which they would choose to complete their required education. There would be no additional administration costs.

Mr. Chairman and members of the Government & Veterans Affairs Committee, my name is Jan Gubrud and I am a licensed Real Estate Broker from Williston. I have been a ND REALTOR® for 13 years and I have always easily met and many times exceeded the number of continuing education hours required to renew my license.

The North Dakota REALTOR'S® Association provides more than ample educational opportunities for licensees to obtain the required continuing education hours within the three year cycle currently in place. If a REALTOR® found they were short of continuing education hours towards the end of the three-year cycle, they then have an opportunity to pick up any or all of the necessary hours at the three-day session offered by NDAR in December. There is simply no excuse for a REALTOR® not obtaining the hours required by current law, other than carelessness or extreme procrastination.

North Dakota's education requirements for REALTORS® are designed to insure its citizens that real estate professionals are well trained and educated on the mechanics and laws governing our profession.

I encourage you to recommend a do not pass on HB 1279. Thank you for your time.

Mr. Chairman and members of the Government and Veterans Affairs Committee, my name is Janelle Kerr, broker with RE/MAX Realty Plus in Grand Forks. Currently I'm serving as President of the Grand Forks Board of Realtors and as a Director for the North Dakota Association of Realtors.

I appear in opposition to this legislation. The very essence of continuing education is to keep every licensee educated and knowledgeable on a regular basis. In the Grand Forks area we feel strongly about this issue and have asked for an introduction of legislation that increases the number of hours plus shortening the old 3-year cycle. We testified on SB 2098 and shared with the Senate Committee our experience with continuing education programs. Education elevates the professionalism in our industry and that is the ultimate benefit of the public. SB 2098 has already passed the Senate with a vote of 46 to 3.

This bill before you (1279) would be a step backwards. Line 12 through 17 on page one would allow anyone to pay \$10 a month in lieu of education.

I would like to recommend to you a do not pass on HB 1279.

Mr. Chairman and members of the Government and Veterans Affairs Committee, my name is Ninetta Wandler and I am Chair-Elect of the NDAR Education Committee, was President of the Badlands Board of REALTORS® for two years and have been a Director on the State level. I am a REALTOR® with Everett Real Estate in Dickinson.



I am opposed to this legislation and appreciate the opportunity to explain to you my reason for opposition. I am opposed because there is no reason you shouldn't be able to finish your continuing education requirements because our State Association expends a great deal of effort to provide ample opportunities to attend education seminars. Attached to my testimony (page 2-4) you will find a chart that describes all seminars that we have provided in the last 3 years. The chart reveals the course topic, number of hours and location. (By the way the abbreviation of the town Bois refers to the Bois de Sioux Board of REALTORS® in Wahpeton/Breckenridge).

We also did a comparison analysis among other states and found this:

*Virtually every state has a continuing education law


*The average hours among the states are 11.5 hours each year

*Neighboring states:

Minnesota: 90 hours pre-licensing and 30 hours every two years thereafter South Dakota: 60 hours pre-licensing and 24 hours every two years thereafter Montana: 60 hours pre-licensing and 12 hours every year thereafter North Dakota: 30 hours pre-licensing and 24 hours every three years thereafter

*We also found only one state (District of Columbia) that allows correspondence in lieu of classroom attendance for those who are 70 years old or older.

The need for ongoing education to keep ones knowledge and competence is equal. It should not make any difference if you sell lots of homes or only a few. Please oppose this legislation.
