Minutes: BILL SUMMARY: Relating to the salaries of county officers; and provide an effective date. Chairman Froseth opened the hearing with all members present except Rep. N. Johnson. <u>Rep. Maragos, Dist 3</u> : 26.1 testified in support of the bill. This bill is introduced on behalf of counties to update and modernize for the new millennium.

<u>Mark Johnson, N.D. Assoc. of Counties</u> : 26.9 testified in support of the bill. (See attached testimony) In order to keep the minimums and maximums appropriate for economic times, we feel the legislature needs to make adjustments. The last adjustment was made in 1991. It's time to take another look.

<u>Rep. Glassheim</u> : I think you may have a typo in your testimony; second paragraph should read minimum not maximum in the first line.

<u>Mark</u>: That is correct, that's a typo. Not all commissioners have come close to getting their maximums.

<u>Rep. Koppelman</u> : Do you think this increase in salaries, and passing this bill, will put a hard ship on smaller counties trying to keep pace with this.

<u>Mark</u>: We are trying to address that issue. If that arises, we will come back to legislature to change this, if there is a problem. 33.9

<u>Rod Finch, McHenry County Sheriff</u>: 34.8 testified in support of the bill. I'm the lowest paid sheriff in N.D. That's why I'm here. I went through the minimums. As elected officials we are not entitled to overtime. I'm a 20 year veteran in law enforcement and this bill will help me a little.

Rep. Delmore :38.7 Can't you negotiate your salary. We are setting minimums here.

<u>Rod</u> : I am in my third term. I have not received a raise in seven years. Mainly because of budget reasons. I put in for a raise every year and get denied. I thank you for the minimum. <u>Arlin Thompson, retired sheriff from McLean County</u> : Every two years we would come here for salary years. I am here in support of the bill and especially part 7. I do question the county commissioners getting \$2000 increase, because they are part-time. This will raise questions in rural areas.41.0-43.0

<u>Pat Cameron, Hettinger County Commissioner</u> : testified in support. I have never looked to take the maximum. I sympathize with the sheriffs. 43.7-45.6

Lonnie Olson, Pres. N.D. States Attorney Assoc. : 46.0 testified in opposition to HB1362. We are concerned with the amounts of increase. The states attorney salaries have not increased since 1983. That time the judges salaries were broken off from states attorney salaries. Now the judges are \$30,000 higher. Here is the concern; when you look at the role of the prosecutor, who does the most work getting ready for trial. When you look at the stress and work load, it

doesn't make sense to pay low salaries and get quality personal. You will get bargain basement prosecution and get people right out of law school. You want top notch trial lawyers for the community, or you will have lots more people getting off with crimes. We are asking for equity. Rep. Delmore : 54.9 Counties don't pay for their judges anymore, the state does. We can't equate the state and county level. The job varies from county to county. Rep. Glassheim : 56.6 Can we get a list of salaries of the states attorney county by county? Lonnie : Sen. Traynor has a copy I saw this morning at another hearing. Vice Chair Maragos : If I understand you correctly, you want us to raise the salary to \$60,000. Lonnie : Yes, that was introduced in SB2274 today.

<u>Chairman Froseth</u> : The way I read the bill, your salary is negotiable with the county commission.

Lonnie : That's true.

Hearing no more testimony in opposition, hearing was closed. Action taken same day.

ACTION: Vice Chair Maragos made a motion of DO PASS and Rep. Delmore seconded the motion. VOTE: 14 YES, 0 NO and 1 ABSENT. Rep. Ekstrom will carry the bill.

TESTIMONY TO THE HOUSE POLITICAL SUBDIVISIONS COMMITTEE Prepared January 28, 1999, by the North Dakota Association of Counties Mark Johnson, NDACo Executive Director

CONCERNING HOUSE BILL NO. 1362

Chairman Froseth and members of the House Political Subdivisions Committee, my name is Mark Johnson and I am the Executive Director of the North Dakota Association of Counties. I am here today on behalf countyelected officials to state our support for House Bill 1362.

Since statehood, state law has established salary **Bernum**s for county commissioners and salary minimums for all other county-elected officials. In order to keep these minimums and maximums appropriate to economic times, the legislature has revisited these salary standards and made adjustments as needed. The last adjustment was made in 1991, and we believe that it is once again time to make such adjustments.

I have listed on the attached sheet (Table 1) the current levels that are in state law and those proposed by House Bill 1362. In many cases, it is obvious that the proposed levels are still well below the salary a similar employee of the private sector might receive; however, it is important that the adjustments be made in such a way that any one county is not impacted to greatly by the change. The average \$2000 annual increase proposed in this bill is consistent with the change made in 1991, and as indicated by the effective date, it would not become effective until the start of the next county fiscal year. This is because any change prior to that time could create a cost not included in the calendar 1999 budgets that have already been set.

The second sheet (Table 2) shows the estimated impact the minimum salary increase would have on individual counties on an annual basis. Based on our most current salary survey data, only 7 counties would be affected by the proposed increases to the statutory minimum salaries. The adjustment for county commissioners would not mandate a change, since the change affects the maximum that a commissioner may be paid. Salary surveys of county commissioners indicate that 14 of the 53 counties are paying the current maximum.

As I mentioned earlier, the Legislature periodically has revised these salary levels; however, there currently is no adjustment to these limitations unless legislation is brought to the Legislature. To avoid the periodic revisiting of this issue, House Bill 1362 also includes a clause to adjust county salary minimums and maximums somewhat automatically every two years. The adjustments would be based on the base amounts established in the bill, with increases tied to the same percentage change appropriated by the Legislative Assembly for all full-time state employees, starting in the year 2002. This clause would allow county salaries to stay competitive without the change of a state law and the continual revisiting of these minimum and maximum salary levels. Like the immediate change, these incremental increases would only become effective at the start of the counties' next budget cycle.

In conclusion, the adjustments proposed are moderate and necessary to maintain adequate compensation for the individuals filling these important posts. By including a provision to keep these minimums and maximums growing at approved state levels, North Dakota's citizens can be assured that well qualified candidates will be attracted to these positions. Mr. Chairman and committee members, I strongly urge a Do Pass recommendation for House Bill 1362.

TESTIMONY TO THE HOUSE POLITICAL SUBDIVISIONS COMMITTEE Prepared February 4, 1999, by the North Dakota Association of Counties Mark Johnson, NDACo Executive Director

CONCERNING HOUSE BILL NO. 1362

Chairman Froseth and members of the House Political Subdivisions Committee, the North Dakota Association of Counties continues to support this bill in its entirety, however we realize that some sections may not be acceptable to the legislature at this time. We will therefore support the proposed amendments to make this important legislation more acceptable to everyone.

The proposed amendments to this bill completely remove the salary maximums for county commissioners, as well as the clause that would eliminate the need to adjust these salaries through legislative action in the future. We feel that both of these items had merit, however we recognize the philosophy of some Legislators that commissioner salaries should not be limited by the Legislative action. We also recognize the feelings about linking county salary minimums to legislation action; however we feel that providing a reasonable salary floor is essential to ensuring that newly elected officials are not treated unfairly.

We want to clearly state that changing the statutory minimums for the "other elected officials" will have <u>virtually no impact on current county costs</u>. The attached Table 1 indicates the 1998 statewide average salaries for these positions. In every case the average is well above the proposed minimum. Table 2 again shows the actual impact of these changes if they would have been implemented in 1998. The bill would not become effective until the year 2000; very likely no adjustments will actually be necessary due to cost of living adjustments before that time. This is not an issue of increasing costs, but of providing some level of protection against reducing a salary to a level so unattractive that some individuals are convinced not to run for the office.

The final change in the bill is the addition of language we had intended to add at introduction. By adding the word "elected" in each section, we have made it clear that offices that have become appointed through home rule or other statutory provisions are not governed by these limitations.

While the amendments proposed remove some important points, we feel the compromise created is in the best interests of county officials. Mr. Chairman and committee members, I strongly urge a Do Pass recommendation for House Bill 1362 with the proposed amendments.

TESTIMONY TO THE SENATE POLITICAL SUBDIVISIONS COMMITTEE Prepared March 4, 1999, by the North Dakota Association of Counties Mark Johnson, NDACo Executive Director

CONCERNING ENGROSSED HOUSE BILL NO. 1362

Chairperson Lee and members of the Senate Political Subdivisions Committee, my name is Mark Johnson and I am the Executive Director of the North Dakota Association of Counties. I am here today on behalf county elected officials to state our support for Engrossed House Bill 1362.

Since statehood, state law has established salary maximums for county commissioners and salary minimums for all other county-elected officials. In order to keep these minimums and maximums appropriate to economic times, the legislature has revisited these salary standards and made adjustments as needed. The last adjustment was made in 1991, and we believe that it is once again time to make such adjustments.

I have listed on the attached sheet (Table 1) the current levels that are in state law and those proposed by Engrossed House Bill 1362. In many cases, it is obvious that the proposed levels are still well below the salary a similar employee of the private sector might receive; however, it is important that the adjustments be made in such a way that any one county is not impacted to greatly by the change. The average \$2000 annual increase proposed in this bill is consistent with the change made in 1991, and as indicated by the effective date, it would not become effective until the start of the next county fiscal year. This is because any change prior to that time could create a cost not included in the calendar 1999 budgets that have already been set.

The second sheet (Table 2) shows that Engrossed House Bill will have <u>virtually no impact on current county costs</u>. Based on our most current salary survey data, only 7 counties would be affected by the proposed increases to the statutory minimum salaries. The adjustment for county commissioners would not mandate a change, since the change would remove the maximum that a commissioner may be paid. Salary surveys of county commissioners indicate that 14 of the 53 counties are paying the current maximum.

A provision has also been placed in the engrossed bill that makes it clear that offices that have become appointed through home rule or other statutory provisions are not governed by these limitations.

Representative Boucher has also asked that an amendment be attached to this bill to clarify that a state's attorney may not also serve as <u>a state or</u> <u>federal</u> judge. The purpose of the amendment is to allow a state's attorney to serve as a tribal judge. As they would perform these functions in different jurisdictions, we don't believe this would pose a conflict and thereby support the amendment.

In conclusion, the adjustments proposed are moderate and necessary to maintain adequate compensation for the individuals filling these important posts. Madam Chair and committee members, I strongly urge a Do Pass recommendation for Engrossed House Bill 1362 with the proposed amendments.

Madam Chairman and fellow committee members.

My name is Renee Jochim. I am Sioux County Auditor. I am here at the request of the Sioux County Commissioners, Mr. Larry Silbernagel, Mr. David Volk, and Mrs. Deb Gullickson.

At our meeting on March 2, 1999, the commissioners discussed HB 1362. They have instructed me to appear before you to oppose HB 1362.

Sioux County is the 2nd poorest county in the nation. We are completely encompassed on the Standing Rock Reservation. Therefore only about one half of our county land base is taxable. We have a very limited budget. The county commissioners feel that the current law works very well in our county. At this time commissioners are not at the maximum of their potential salaries.

We feel that the current minimum salaries for elected officials works very well! Our elected officials all start at the minimum salary, but after proper training and education they are adjusted. Normally after one year they receive approximately \$20,000 per year.

With this bill, a liberal group of commissioners could set their salary at a very unreasonable rate which could send our county into fiscal turmoil. Because of our limited taxable land base, we feel that it is in the best interest of the tax payers that HB 1362 be defeated!!
