Froseth opened the hearing with all committee members present.

Rep. Disrud introduced the bill and supports HB 1366.

Lois Hartman, Executive Director, N.D. Firemen's Association : .8 testified in support of the bill.

<u>Rep. Eckre</u> : 5.5 Will the fire marshal require more staff to enter more data from all the increased information coming in from the rural fire departments?

Lois : No.

Rep. B. Thoreson : What type of classes are in fire schools?

<u>Rep. Niemeier</u> : Please explain the difference between fire department and fire protection district. <u>Lois</u> 7.8 : A city has a fire department, and a fire protection district is strictly rural. <u>Rep. Severson</u> :8.4 testified in support of the bill. I have been a fireman for 20 years and this

legislation is long overdue.

<u>Rep. Koppelman</u> : Explain the relationship between local fire departments and the state fire marshal.

<u>Joel Boespflug</u> : 10.2 As a former state fire marshal, I will try to answer. The fire marshal is a resource for assisting local in fire investigations, training in arson detection, and fire codes and inspections. It is a very good relationship.

<u>Rep. Koppelman</u> : Is there any supervisory relationship that the fire marshal has over volunteer fire departments?

<u>Joel</u> : Not really. It's more of an assistance agency. Some statutes in law require that local fire departments make reports to the fire marshal.

<u>Rep. Disrud</u> brought forth the amendments Lois spoke of earlier and explained them to the committee.

There was no further testimony. Chairman Froseth closed the hearing and asked what the committee wished to do. Vice Chair Maragos made a motion to DO PASS as amended, Rep. Delmore seconded the motion. ROLL CALL: <u>14</u> YES <u>0</u> NO <u>1</u> ABSENT. Rep. N. Johnson will carry the bill.



HB 1366 "HOUSEKEEPING BILL"

Chairman Forseth, and Members of the House Political Subdivision Committee, my name is Lois Hartman; I am the Executive Director of the North Dakota Firemen's Association.

Thank you for the opportunity to present an explanation of HB 1366. Section I, cleans up language and identifies fire protection districts as a separate entity from fire departments. They provide the same service, except that a fire protection district is a rural area, and not an extension of a city department.

Section 2, deals with the fire schools. At the Annual Convention of the North Dakota Firemen's Association, the Executive Board was instructed to address the issue of Regional Fire Schools and make them more fiscally efficient. The State Fire School is held in Bismarck, the last full weekend of February each year. In the past, regional fire schools were held around the state as requested by local fire departments. Historically, more than four regional fire schools were held annually. In the year 1997-98, eleven regional fire schools were held. Rather than having a regional school offer one or two classes for the fire fighters in a regional area, the Executive Board would like the to offer an academy type training opportunity. The current plan is to offer classes from the National Fire Academy along with several classes geared to the needs of the specific regions and or departments hosting the fire school. If we have classes offered at the State Fire School that fills very fast and I have to turn away a number of firefighters, we will look at offering the class across the state, making it available to more firefighters.

By changing the language and allowing the executive board to hold schools as requested by fire departments, we can better meet their needs. It is not always possible to announce the fire schools at the annual convention a year in advance, because it is almost impossible to get schools scheduled and planned that far in advance. It has been the practice to schedule schools as requested by fire departments and send a memo to all fire departments in the region or across the state announcing the school and giving registration information. This section also allows the opportunity to use teleconference, video and other alternative media in offering training. This provision is new to the fire service. We think that this will allow more participation in training.

Section 3, addresses the reporting of the training activities to OMB. This basically is a language change to reflect current practices. Since the funding from OMB for fire schools is an annual appropriation, the reporting back to OMB is also annual.

Section 4, is a language update and reflects no other change.

Section 5, is a language update, reflecting the current practices of the Association. As of June 1997, the Association has a business office, which is new. The position of the Executive Director is a new position and carries the administrative responsibilities that various executive board members held in the past. It shall be the responsibility of the Executive Director to be sure that all reports are filed with the Office of Management and Budget and the State Auditors office in a timely manner.

Section 6, is correcting language to keep it consistent throughout this section of code.

Section 7, also reflects updated language. If you notice subsection 2, line 7, steam and hand engines are no longer used.

The amendment would add subsection 4. It is a requirement of the Fire Marshal's office to work in cooperation with the Insurance Department and the Association to certify fire departments and fire protection districts. This subsection would add the requirement of filing fire reports to maintain certification eligibility. This is important in order to get the departments to comply with the reporting requirements of the Fire Marshal's office.

Many departments do not understand the importance of reporting all fires to the Fire Marshal's office. The Fire Marshal is required to report to the National Fire Administration the fire activity in the state. The lack of complete reporting will be reflected in the funding to the National Fire Academy and the National Fire Administration. This also effects the programs and support that is made available to the states. By adding this requirement, it gives the Fire Marshal more power is collecting the information necessary.

Because neither the Fire Marshal's Office nor the North Dakota Firemen's Association has a staff to develop fire service training programs; we are dependent on the programs from the National Fire Academy. This is one of the reasons that it is essential to report all fire activity to the National Fire Administration.

Section 8, cleans up outdated language. The fire services no longer use steam engines and hose carts.
