Sen. Urlacher - opened the hearing on HB 1401, roll taken. A BILL RELATING TO CHARITABLE SOLICITATION LICENSE APPLICATION.

Al Jaeger - Secretary of State -Submitted amendments that clarifies the language. If the law is clear, people can work off of it. Worked with Consumer Fraud Division in developing the language.

Sen. Urlacher - Is it a \$5,000. penalty?

Al Jaeger - We had based it on valid data.

Sen. Christmann - Changes on pg. 8, is violation that they can't continue 'til they file their report + penalty?

Al Jaeger - Yes, It's a bill of clarification, guide. Give a small text for organization & they can follow it easily.

Sen Schobinger - Penalty is limit to \$5,000 or 5 years.

Al Jaeger - Prosecuted up to felony - lot to be dealt with before going to court., Stipulation of some wrong doing, and then just a slap on the wrist.

Sen Kinnoin - Type of organization out of State?

Al Jaeger - Specific examples, No. We haven't pursued any, but down the road professional fund raisers. They come in and collect, using a post office box and then leave the State. We work closely with the Fraud Department.

Sen. Kroeplin - Is there something done before they go to court?

Al Jaeger - We refer them to Civil Litigation and sometimes an agreement can be reached at that time. It depends on the parties involved.

Sen. Kinnoin - Is this a class A misdemeanor?

Sen. Schobinger - It is a 1 year prison term or \$1,000. fine or could be both.

Sen. Urlacher called for any more testimony or discussion, and closed the hearing.

RE: HB 1401 – Charitable Solicitation

Section 1 (page 1, lines 9 through 23, and page 2, lines 1 through 20) of the bill clarifies the definition of what it means to be a "Charitable Organization" and what the term does not include.

Section 1 (page 2, lines 21 through 31) clarifies the meaning of the word "Contribution."

Section 1 (page 3, lines 25 through 31, and page 4, lines 1 through 16) clarifies the meaning of the word "Solicitation."

Section 2 (page 4, lines 21 through 31, and page 5, lines 1 through 7) clarifies the information required on the application for a charitable solicitation license.

Section 3 (pages 5 and 6) clarifies the information required of professional fundraisers on their application for a license.

Section 4 (page 7, line 18) clarifies the annual report filing date.

Section 4 (page 8, lines 1 through 19) clarifies the information required on the annual report and what happens if the report is not filed in a timely manner.

Section 5 (page 8, line 24) removes an unnecessary word.

Section 6 (page 9, lines 1 through 4) clarifies the procedures when an application is denied or a license is revoked or has lapsed.

Section 6 (page 9, lines 15 through 17) provides for the imposition of civil penalties and denial of licensure or registration for a period of up to five years.

Section 7 (page 9) repeals 50-22-03 (copy attached) pertaining to the information required on a license application form. This section of law has remained unchanged since 1961. The provisions have been incorporated under Sections 2 and 3 of this bill to make them more applicable to the two different types of licenses (charitable solicitation and professional fundraiser) issued by the Secretary of State's office.

50-22-03. Application for license — Contents. The application for a license must contain the information concerning such solicitation, as required by this chapter, submitted on forms provided by the secretary of state. This information must be filed with the secretary of state and must be available to the public as a matter of public record. The forms containing such information must be sworn to and must include the following:

1. The name of the charitable organization for whom the solicitation is

to be conducted.

2. The address thereof.

- 3. The purpose or purposes for which the contributions solicited are to be used.
- 4. The individual or officer who will have custody of the contributions.

5. The individuals responsible for the distribution thereof.

- 6. The period of time during which such solicitation is to be conducted.
- 7. A description of the method or methods of solicitation in such detail as may from time to time be determined by the secretary of state.
- 8. Whether such solicitation is to be conducted by voluntary unpaid solicitors, by paid solicitors, or both, and if in whole or in part by paid solicitors, the name and address of each professional fundraiser supplying such solicitors, the basis of payment, and the nature of the arrangement.

9. Such additional information as may be deemed necessary by the secretary of state for the proper administration of this chapter.

Section 4 (page 8, lines 1 through 19) clarifies the information required on the annual report and what happens if the report is not filed in a timely manner.

Section 5 (page 8, line 24) removes an unnecessary word in this section (same word removed throughout various section of the bill).

Section 6 (page 9, lines 1 through 4) clarifies the procedures when an application is denied or a license is revoked or has lapsed.

Section 6 (page 9, lines 15 through 17) provides for the imposition of civil penalties and denial of licensure or registration for a period of up to five years.

Section 7 (page 9) repeals 50-22-03 (copy attached) pertaining to the information required on a license application form. This section of law has remained unchanged since 1961. The provisions have been incorporated under Sections 2 and 3 of this bill to make them more applicable to the two different types of licenses (charitable solicitation and professional fundraiser) issued by the Secretary of State's office.
