STATEMENT BY THE AMERICAN CROP PROTECTION ASSOCIATION BEFORE THE HOUSE COMMITTEE OF AGRICULTURE FIFTY-SIXTH LEGISLATIVE ASSEMBLY OF NORTH DAKOTA

FEBRUARY 11, 1999

CONCERNING HCR3030

LADIES AND GENTLEMEN:

THE AMERICAN CROP PROTECTION ASSOCIATION IS THE NOT-FOR-PROFIT TRADE ASSOCIATION, BASED IN WASHINGTON, D.C., THAT REPRESENTS THE COMPANIES THAT PRODUCE, SELL AND DISTRIBUTE VIRTUALLY ALL OF THE CROP PROTECTION AND PEST CONTROL CHEMICALS REGISTERED FOR USE IN THE UNITED STATES.

ACPA APPRECIATES THE INVITATION OF THIS COMMITTEE TO TESTIFY IN STRONG SUPPORT FOR THE RESOLUTION BEFORE YOU: HCR3030, TO URGE CONGRESS TO ENSURE THE AVAILABILITY OF CROP PROTECTION PRODUCTS AND A TRANSPARENT, SCIENCE-BASED IMPLEMENTATION OF FQPA BASED ON STATISTICALLY ACCURATE PESTICIDE USE DATA.

THE FOOD QUALITY PROTECTION ACT: EPA IMPLEMENTATION WILL HAVE SIGNIFICANT IMPACT ON GROWERS ACROSS THE COUNTRY.

TO HELP UNDERSTAND THE CHANGES BROUGHT ABOUT NOW AND IN THE FUTURE BY FQPA, THINK OF THE EXPOSURE THAT CAN BE SAFELY ALLOWED FOR A PARTICULAR PESTICIDE AS FILLING A "RISK" CUP. THIS CUP CONTAINS THE AMOUNT OF PESTICIDE RESIDUE THAT A PERSON CAN BE EXPOSED TO DAILY WITHOUT AFFECTING HEALTH.

BEFORE FQPA, EACH PESTICIDE HAD ITS OWN RISK CUP, WHICH HELD ONLY THE RISK FROM USE ON FOOD CROPS; FOR EXAMPLE, FROM CORN OR APPLES. UNDER FQPA, THE RISK CUP MUST NOW MAKE ROOM NOT ONLY FOR RESIDUES ON FOOD, BUT ALSO FROM THOSE FOUND IN

DRINKING WATER, FROM USES IN AND AROUND THE HOME, SUCH AS ON LAWNS AND GARDENS, AND ON PUBLIC SPACES, SUCH AS PARKS, RIGHTS-OF-WAY AND GOLF COURSES. EXPOSURE FROM THESE MULTIPLE SOURCES IS COMBINED AS "AGGREGATE" RISK.

WHEN DATA PERTAINING TO A PESTICIDE'S POSSIBLE EFFECT ON CHILDREN'S HEALTH CALL FOR IT, EPA ALSO MAY ADD AN EXTRA TENFOLD OR MORE MARGIN OF SAFETY. IN THESE CASES, THE RISK CUP BECOMES EVEN SMALLER, RESULTING IN POTENTIALLY FEWER PESTICIDES AND/OR PESTICIDE USES.

FURTHERMORE, UNDER A CONCEPT KNOWN AS "CUMULATIVE" RISK, IF TWO OR MORE PESTICIDES HAVE THE POTENTIAL TO ACT ON HUMAN HEALTH IN THE SAME MANNER, FQPA REQUIRES THEM TO SHARE A COMMON RISK CUP, AGAIN SHRINKING THE NUMBER OF AVAILABLE PESTICIDES AND/OR PESTICIDE USES.

IN ADDITION, FQPA CONTAINS A PROVISION REQUIRING THAT ALL PESTICIDES BE TESTED FOR THEIR POTENTIAL EFFECTS ON THE HUMAN ENDOCRINE SYSTEM. FINALLY, THIS MASSIVE REASSESSMENT OF THE MORE THAN 9,000 PESTICIDES AND PESTICIDE USES MUST BE COMPLETED WITHIN TEN YEARS.

UNFORTUNATELY TO THIS DAY, EPA HAS NOT ISSUED ANY REGULATIONS OR GUIDELINES TO FOLLOW IN ADHERING TO THESE NEW REQUIREMENTS. THIS IS LEADING TO SIGNIFICANT DELAYS IN REREGISTERING EXISTING PRODUCTS AND THE REGISTRATION OF NEW PRODUCTS AND USES.

BECAUSE THE AGENCY IS SO FAR BEHIND IN IMPLEMENTING THE LAW, IT HAS ASKED MANUFACTURERS TO PRIORITIZE THEIR TOP FIVE PRODUCT USES, WHICH AGAIN AFFECTS BOTH AVAILABILITY AND PRICE.

WE COMMEND REPRESENTATIVES NELSON, JOHNSON AND POLLERT FOR WORKING ON THIS ISSUE AND ADVANCING THE IDEA OF A RESOLUTION DOCUMENT TO ADDRESS CONCERNS ABOUT FQPA IMPLEMENTATION SUCH AS ADVERSE IMPACTS ON AGRICULTURE NOT ONLY IN THIS STATE BUT ACROSS THE COUNTRY.

LAST YEAR, MICHIGAN, IDAHO AND PENNSYLVANIA BECAUSE OF GRASSROOTS REQUESTS FROM GROWERS AND AGRIBUSINESS ADOPTED SUCH FQPA RESOLUTIONS. ALSO, THE NATIONAL GOVERNORS ASSOCIATION AND THE NATIONAL ASSOCIATION OF STATE DEPARTMENTS OF AGRICULTURE HAVE PASSED SIMILAR POLICY POSITIONS ON FQPA.

ASIDE FROM HCR3030 IN NORTH DAKOTA, KANSAS, WYOMING, AND GEORGIA ARE RIGHT NOW CONSIDERING SIMILAR FQPA RESOLUTIONS. OHIO AND NORTH CAROLINA MOST PROBABLY WILL ALSO REVIEW SIMILAR INSTRUMENTS TO MEMORIALIZE CONGRESS AND THE ADMINISTRATION. ALSO, ACTIVITY IS UNDERWAY IN NEW YORK AND FLORIDA AND SOME OTHER KEY AG STATES TO SECURE GUBERNATORIAL FQPA MESSAGES.

IN ADDITION, CALIFORNIA, WASHINGTON AND IDAHO HAVE HOSTED FQPA "GROWER CONCERN" MEETINGS FOR TOP EPA OFFICIALS AND THEIR U.S. REPRESENTATIVES (THE ENTIRE STATE'S CONGRESSIONAL DELEGATION ATTENDED THE WASHINGTON MEETING!), AT WHICH POTENTIAL FQPACRISES OF PRODUCT AVAILABILITY WERE AIRED.

WHEN STATE AFTER STATE--ESPECIALLY STRONG AG STATES—SEND SUCH CLEAR FQPA CONCERN SIGNALS TO WASHINGTON, WE KNOW THOSE INSIDE THE BELTWAY LISTEN.

Chairman Wanzek and members of the Senate Agriculture Committee. My name is Gary Knutson. I serve as Executive Director of the North Dakota Agricultural Association. Our membership includes over 400 retailers, distributors, manufacturers and individual service providers of seed, fertilizers, crop protection products and equipment for farmers. Our members play an important role in our rural communities. We appreciate the direct correlation between a healthy farm economy and success for our businesses. In many cases our service centers for these crop production inputs are the major employer in the community.

The position of the Association has been to promote and support those efforts that will bring the timelines and registration requirements together for crop protection products registration between the United States and Canada. However, it has also been pointed out that as developments toward harmonization of the pesticide registration process take place, product availability to our farmers may worsen because of the implementation methodology of the Food Quality Protection Act. We feel this situation certainly warrants the attention of your committee today.

We endorse House Concurrent Resolution 3030 which urges the Congress of the United States to ensure the availability of as many crop protection products as possible, to use actual scientific data to determine the safety of crop protection products, to accept scientific data generated by the North Dakota State University Main Research Center and by the research extension centers regarding the safety of crop protection products, to establish uniform policies governing the implementation of the 1996 Food Quality Protection Act, and to ensure that implementation of the 1996 Food Quality Protection Act does not negatively impact agricultural production nor the availability and affordability of food. We believe this resolution addresses directly the vital issue of future crop protection product availability for our agriculture industry and appropriately recognizes scientific issues in keeping with the purpose of food quality protection in this country.
