Minutes: CHAIRMAN KREBSBACH called the committee to order and opened the hearing on SB 2055 which relates to compensation paid to members of the legislative assembly for attending sessions of the legislative council and its committees. JOE MORRISSETTE with the legislative council appeared before the committee in neutral position to present/introduce the bill to the committee. He presented testimony based on the Interim Committees Report of the Legislative Compensation Commission submitted to the North Dakota Legislative Assembly. A copy of this report is attached. SENATOR STENEHJEM-Joe, could you compute a fiscal note for us on what the affect would be if we were to amend the \$75.00 to \$91.00 so that that \$91.00 when coupled with the \$20.00 for meals would equal \$111.00, which is what we are paid during the session. MR. MORRISSETTE indicated that he can do that. I should have thought ahead and done that. I'll do that and get that number down to you. SENATOR KILZER-I'm kind of a novice but I live here in Bismarck and I don't get anything for meals. Why is that? I'm

wondering about meals? MR. MORRISSETTE indicated he guessed the rationale would be that you would only be compensated if you were away from your hometown for the course of the day. The way the reimbursement works is I think you're allowed \$4.00 for breakfast if you're gone during that time and \$6.00 for lunch and \$10.00 for the evening meal. You actually have to be away from your hometown for a period of a day as it says in statute. SENATOR STENEHJEM indicated that there are some internal revenue service problems with that and that is the reason for the disparity. Maybe this could be checked out to see what the reason is. SENATOR DEMERS-We're only talking about not during the session only during the interim because none of us get meal stuff during the session. I know the same is true at UND. When we have people come in from Fargo they get compensated for meals and those of us who are there don't. Even though we're all eating in the same restaurant. I think it is some IRS thing. There were no further questions from the committee. No one else appeared in support of SB 2055. No one appeared to testify against SB 2055. At this time CHAIRMAN KREBSBACH closed the hearing on SB 2055.

COMMITTEE WORK-February 4, 1999-Tape 2, Side A, Meter #'s 4843-End and Tape 2, Side B, Meter #'s 0-60 Committee discussion ensued. It was indicated by SENATOR KREBSBACH that this bill needed committee action as it needed to be re-referred to the appropriations committee. It deals with the interim pay which Senators and Representatives are to receive. Currently they receive \$62.50 per day. The bill comes in at \$75.00 however, Senator Stenehjem was proposing to go to \$91.00. SENATOR THANE noted that in some cases the senators and representatives work harder because our travel time which we have to travel great distances such as when we went to Mohall. Williston is another long trip for some of us and

even though we don't spend more than 8 hours in committee we certainly put in a lot of time doing it. So I think I agree, I think it's worth just as much as during the regular session. SENATOR DEMERS indicated she didn't have much of a chance to discuss this bill with her colleagues with the exception of Senator Mutzenberger but she didn't think there would be any problem with it that she could see. SENATOR MUTZENBERGER indicated that the people he had spoken with about this seemed rather supportive of it. CHAIRMAN KREBSBACH indicated her feelings were that if the committee decided to go up to the \$91.00 we are actually then at the rate we were at for regular session four years ago. To put us in line with that is not out of order. Senator Wardner moved the amendment which states Page 1, line 9, replace "seventy-five with "ninety-one". Motion seconded by Senator Thane. SENATOR THANE: Among other things that we have mentioned, it might encourage better participation in interim committees, because the way it is right now, under the existing \$62.00 by the time the taxes are taken out you end up with forty some dollars. It's pretty hard to justify going away from what you are doing, whether you are doing it for wages or you are self-employed or whatever. Unless you get something more than that. SENATOR KILZER: What is the effective date of this? CHAIRMAN KREBSBACH: It would be there is no emergency so it would be effective August 1 of 1999 in the next biennium. SENATOR DEMERS: I just wanted to note for the record that the interim pay has been at \$62.50 since at least 1981. That's as far back as the chart goes. I guess I feel an increase to \$91.00 is justified. There were no further comments. Roll Call Vote indicated 6 YEAS, 0 NAYS, and 1 ABSENT OR NOT VOTING. A motion for DO PASS AS AMENDED AND RE-REFER to APPROPRIATIONS was made by SENATOR WARDNER, seconded by

## LEGISLATIVE COMPENSATION COMMISSION

The Legislative Compensation Commission was originally established by the 1969 Legislative Assembly. Consisting of five members appointed by the Governor, the primary duty of the commission was to determine appropriate levels of expense allowance and compensation to be paid to members of the North Dakota Legislative Assembly. In 1979, after ten years of existence, the law which created the original Legislative Compensation Commission was repealed.

The Legislative Compensation Commission was recreated by passage of 1983 Senate Bill No. 2360. The bill, now codified as North Dakota Century Code (NDCC) Sections 54-03-19.1 and 54-03-19.2, once again established a Legislative Compensation Commission to determine appropriate levels of expense allowance and compensation to be paid to members of the Legislative Assembly.

In 1993 NDCC Section 54-03-19.1 was amended to direct the Legislative Compensation Commission to also develop recommendations for a long-term policy on legislative compensation, expense allowance, and insurance benefits. In addition, the 1993 Legislative Assembly amended Section 54-03-19.2 to allow the

commission to file with the Legislative Council a bill incorporating its recommendations.

The membership of the Legislative Compensation Commission has traditionally been bipartisan. The 1995-96 Legislative Compensation Commission recommended a bill to make bipartisan membership a requirement of the commission. The 1997 Legislative Assembly adopted the commission's recommendation and amended NDCC Section 54-03-19.1 to provide that no more than three of the five appointees to the Legislative Compensation Commission can represent the same political party.

Commission members were Harold N. Trautman (Chairman), Rosie Black, Jim Gerl, Tish Kelly, and Ray Schmidt. The commission met on June 9, 1998.

# BACKGROUND INFORMATION History of Legislative Compensation and Expense Reimbursement Rates

Section 54-03-20 was amended in 1959 to provide that the \$1,200 payment was reimbursement for expenses incurred during the interim and during the legislative session.

Section 54-03-20 was amended in 1965 to provide that the \$1,200 payment was reimbursement only for expenses incurred during the session and to provide for payments of \$35 per month during each legislator's term of office as payment for uncompensated expenses.

<sup>&</sup>lt;sup>3</sup> Bismarck legislators received \$90 per day during session as compensation and did not receive any amount for daily expense reimbursement.

- Section 54-03-20 was amended to provide that legislators not from the Bismarck area receive reimbursement for lodging or mileage at the rates provided for state employees, to a maximum of \$600 per month.
- <sup>5</sup> House Bill No. 1243 (1985) amended Section 54-03-20 to provide that the monthly amount paid to legislators during the interim was compensation, not reimbursement for expenses.

### Previous Recommendations of the Legislative Compensation Commission

The Legislative Compensation Commission reviewed recommendations of the Legislative Compensation Commission from the 1991-92 interim to the 1995-96 interim.

The 1991-92 Legislative Compensation Commission recommended, in its report to the 1993 Legislative Assembly, that legislative compensation for the 1993 session and the 1993-94 interim remain at the level then in effect and that future legislative compensation levels be increased by the same average percentage provided for state employee salary increases.

The 1993-94 Legislative Compensation Commission recommended, in its report to the 1995 Legislative Assembly, that legislators' monthly compensation be increased by \$70 per month from \$180 to \$250 per month, to partially reflect salary increases provided to state employees during the 1993-95 biennium. (The 1993 Legislative Assembly provided state employees salary increases of \$60 per month the first year of the 1993-95 biennium and three percent for the second year.) The commission also recommended this amount be paid monthly rather than every six months. These recommendations were incorporated into 1995 House Bill No. 1121, which failed to pass.

The 1995-96 Legislative Compensation Commission recommended three bills for consideration by the 1997 Legislative Assembly.

- Senate Bill No. 2051 To increase legislators' compensation from \$180 to \$250 per month, paid monthly rather than every six months.
- Senate Bill No. 2052 Contained the following provisions:
  - No more than three of the five appointees of the Legislative Compensation Commission could represent the same political party.
  - b. The commission would be required to report its recommendations regarding legislative compensation and expense reimbursement to the Legislative Assembly by December 1, 1998, and by December 1 of each subsequent even-numbered year. The compensation levels recommended by the commission would become effective on December 1 of each even-numbered year and would remain in effect unless disapproved by a

concurrent resolution adopted 60 percent of the members-elect of each house within 30 days after the convening of the subsequent Legislative Assembly. If the recommendation of the commission were rejected by the Legislative Assemthe levels of legislative bly. compensation, expense reimbursement, and insurance benefits would revert to the levels in effect before December 1 of the preceding year.

- c. Statutory references to the amount of compensation provided pursuant to NDCC Section 54-35-10, which sets the level of legislative compensation for attending interim meetings, would be changed to the fixed dollar amount of This change was \$62.50 per day. recommended so that the recommendations of the Legislative Compensation Commission would affect only compensation paid to legislative committee members, not members of boards and commissions that provide compensation based on the amount provided to legislators.
- Senate Bill No. 2053 To increase legislators'
  maximum lodging reimbursement during the
  legislative session from \$600 to \$650 per
  month and to increase legislators' compensation for attending interim meetings from
  \$62.50 to \$90 per day.

Senate Bill No. 2051, as passed by the 1997 Legislative Assembly, included the recommended increase in monthly compensation from \$180 to \$250 and the provision that at the legislators' option this amount could be paid monthly rather than every six months. In addition, this bill was amended to include an increase in the daily compensation paid to legislators during the legislative session from \$90 to \$111.

Senate Bill No. 2052, as passed, did not include any provisions to allow the Legislative Compensation Commission to set the level of legislative compensation. However, statutory references to the amount of compensation provided pursuant to NDCC Section 54-35-10 were changed to the fixed dollar amount of \$62.50 per day, as included in the introduced bill. The Legislative Assembly also did not change the provision that no more than three of the

five members of the commission can represent the same political party.

Senate Bill No. 2053, as passed by the 1997 Legislative Assembly, included the recommended increase in legislators' maximum lodging reimbursement from \$600 to \$650 per month but did not increase legislator compensation for attending interim meetings.

### Other Information

The Legislative Compensation Commission reviewed the following:

 The provisions of NDCC Sections 54-03-19.1 and 54-03-19.2 relating to the duties of the Legislative Compensation Commission.

- A document prepared by the National Conference of State Legislatures entitled 1997
   Compensation and Benefits for State Legislators, which included information on legislative compensation, expense reimbursement, and benefits provided in each of the 50 states.
- A Legislative Council memorandum entitled Legislative Compensation Increases Compared to Inflation and State Employee Salary Increases - 1991-1998. The following schedule compares actual calendar year 1998 legislative compensation rates to 1981 rates adjusted annually for inflation and state employee salary increases:

### **Discussion and Comments**

The following comments were made by members of the Legislative Compensation Commission or by members of the Legislative Management Committee during a meeting with that committee:

- The Legislative Compensation Commission should determine a level of legislative compensation that will allow citizens to hold legislative office without undue financial sacrifice.
- The Legislative Compensation Commission should consider increasing the mileage allowance provided for legislators.
- The Legislative Compensation Commission should attempt to improve citizen awareness of problems relating to inadequate legislative compensation.
- North Dakota spends a relatively small amount for legislative representation.
- The Legislative Compensation Commission should consider increasing the interim daily compensation paid to legislators for attending committee meetings.

- Legislative compensation rates should be adjusted annually based on the inflation rate or legislatively authorized salary increases for state employees.
- It is inconsistent for legislators to be paid \$62.50 per day for work during the interim, but \$111 per day during legislative sessions.

### RECOMMENDATION

To partially reduce the disparity between pay received by legislators for work during the interim and during the legislative session (legislative session pay of \$111 per day includes payment for meals expenses, legislative interim pay of \$62.50 per day is separate from meals reimbursement of up to \$20 per day), the Legislative Compensation Commission recommends Senate Bill No. 2055 to amend NDCC Section 54-35-10 to increase legislators' interim daily compensation from \$62.50 to \$75. The estimated cost of this increase for the 1999-2001 biennium is \$61,848 from the state general fund, which has been included in the budget request for the Legislative Council.

# LEGISLATIVE COMPENSATION INCREASES COMPARED TO INFLATION AND STATE EMPLOYEE SALARY INCREASES - 1981 TO 1998

This memorandum provides an analysis for the period 1981 through 1998 of actual legislative compensation rates and legislative compensation rates adjusted for inflation and state employee salary increases.

### **LEGISLATIVE COMPENSATION RATES**

North Dakota Century Code Section 54-03-20 provides that each member of the Legislative Assembly is entitled to receive compensation of \$111 per calendar day during each regular, special, or organizational session. In addition, during each legislator's term of office, they are entitled to receive monthly compensation of \$250. Section 54-35-10 provides that legislators are also entitled to receive compensation of \$62.50 per day for attending interim meetings of the Legislative Council and its committees.

## CHANGES IN LEGISLATIVE COMPENSATION SINCE 1981

In 1981 the amount legislators were paid as monthly compensation was increased from \$150 to \$180. Also in 1981 the amount legislators were paid for attending meetings of the Legislative Council and its committees was increased from \$52 per day to the current rate of \$62.50 per day.

In 1981, legislative session compensation was constitutionally limited to \$5 per calendar day. However, the 1981 Legislative Assembly set the level of expense reimbursement during legislative sessions at \$85 per calendar day, for a total of \$90 per day.

The constitutional provision limiting legislative compensation was repealed on June 8, 1982, by voter approval of Measure No. 4, which created Article XI, Section 26, of the Constitution of North Dakota, which provides that:

The legislative, executive, and judicial branches are coequal branches of government. Elected members and officials of each branch shall receive as compensation for their services only such amounts as may be specifically set by law. Payment for

necessary expenses shall not exceed those allowed for other state employees.

After the adoption of the 1982 constitutional amendment, the subsequent Legislative Assembly (1983) amended Section 54-03-20 to set the rates of legislative compensation and expense reimbursement during legislative sessions at \$40 per day and \$50 per day, respectively. As an exception to the compensation and expense reimbursement rates provided to other legislators, legislators from Bismarck received \$90 per day as compensation and no expense reimbursement. Consequently, the total of expense reimbursement and compensation for all legislators remained unchanged at \$90 per day.

The 1985 Legislative Assembly amended Section 54-03-20 to provide that legislators receive compensation of \$90 per calendar day during the legislative session, plus reimbursement for lodging up to \$600 per month. Section 54-03-20 was also amended to provide that the \$180 per month payment to legislators during their term of office be referred to as compensation rather than reimbursement for expenses.

Section 54-03-20 was not substantively changed again until 1997. The changes made by the 1997 Legislative Assembly include the following:

- Increased daily compensation during legislative sessions from \$90 to \$111.
- Increased monthly compensation during each legislator's term of office from \$180 to \$250.
- Provided that monthly compensation may be paid monthly, rather than every six months, at the option of each legislator.

The schedule attached as an appendix provides an analysis, for the period 1981 through 1998, of actual legislative compensation rates and legislative compensation rates adjusted for inflation and state employee salary increases.
