Minutes:

SENATOR FREBORG: I will open the hearing on SB 2084. Is there any testimony in favor? KEITH BJERKE, ADJUTANT GENERAL OF THE NATIONAL GUARD testified in favor on SB 2084 (see testimony).

SENATOR FREBORG: Are there any questions?

LIEUTENANT COLONEL RANDALL HERMAN, PROGRAM MANAGER testified in favor of SB 2084 (see testimony).

SENATOR FREBORG: Are there any questions?

SENATOR REDLIN: So I understand it correctly, presently 100% of tuition is offered to a

guardsman as long as he is an active member of the guard.

RANDALL HERMAN: The current program provides, through a variety of sources, 100% of school tuition. We want to combine this projection for the guard which would be 50% waiver, 25% higher education and the gift aid would be 25%.

SENATOR REDLIN: This plan will continue as far as the guardsman is concerned?

RANDALL HERMAN: This plan is going to change it; we are going to address the tuition program as more of a scholarship benefit. There are a number of changes that will go into effect next year; we will require students to perform academically with a GPA of at least 2.5. Looking at NDSU, 90% of our students had a 2.5 GPA or better last semester. Overall, 80% are performing at this level or higher. We are confident that this level will go up. Our program will be a fixed benefit for a full time student. The National Guard portion will be \$500 per semester; the higher education portion will be a 25% waiver of their rate of tuition at their institution. The percentage of benefits vary slightly for the student depending on the institution they choose to attend. They could very well be at 100% tuition for smaller schools not counting any type of gift aid at all. At larger institutions, the percentage of support from higher education and guard will be 80%. It is a direct incentive for our students to be aggressive.

SENATOR REDLIN: What are you referring to when you say gift aid?

RANDALL HERMAN: Gift aid are moneys that are acquired through the federal financial aid
process grant. Other sources could be a scholarship from say Cenex in Bottineau.
SENATOR O'CONNELL: Can you give us a brief history of how your program got started?
RANDALL HERMAN: The program began over twenty years ago. The guard, in the
beginning, would take care of 50% of the tuition and higher education picked up 50% of that, the

end result was a 75% tuition program. The intent was to provide tuition along with gift aid and this would equal a 100% tuition program.

SENATOR KELSH: What this is doing is if you are unable to support or meet the 25%, higher education is not required to match if you can't meet your obligations.

RANDALL HERMAN: This proposed legislation would relieve higher education from having a tuition responsibility if our appropriations would run out. We feel comfortable that our budget will provide the dollars within our appropriations to address our portion of the whole tuition program. I would be very surprised if we fell short of our funding.

SENATOR KELSH: If appropriations did not follow through then what would be the case, the student would not get the tuition waiver or would they just get the amount less the 25%?

RANDALL HERMAN: Basically, this legislation provides that the university system will not have an obligation to provide their support should we not have sufficient funds to provide the support necessary to do our part. It makes it a peer partnership.

SENATOR REDLIN: It will weed out the people who don't hold a 2.5 GPA.

RANDALL HERMAN: This program is an after-the-fact benefit. Students apply prior to the beginning of the academic year but we wait until they've completed the course of study, we then have their transcripts and we can see if they have completed the course work with a 2.5 GPA or better. At that point in time we issue a check for our portion and we're still working on a few other administrative policies.

SENATOR REDLIN: Would you say this would be a flat sum of \$500 per semester? RANDALL HERMAN: Yes. Page 4 Senate Education Committee Bill/Resolution Number Sb 2084 Hearing Date January 19, 1999

SENATOR FLAKOLL: This would be for a full-time student, part-time student, and could this also be for a student who wishes to enroll in medical school, law school or aviation school? RANDALL HERMAN: Part time students will be able to participate, it will be prorated at the percentage of their course study load. The current program does not incorporate graduate study. SENATOR FLAKOLL: The focus is primarily on recruiting as the reason for the program. Are there any other reasons?

RANDALL HERMAN: The better educated our members are, the better able they are to perform their responsibilities.

SENATOR COOK : Will this program give you tools to recruit a person who has already graduated from college? Are there any tools to maybe pay down school loans?

RANDALL HERMAN: I don't believe this program addresses the issue. The access to federal benefits that addresses that in particular is the Federal Student Loan Retainment Program and others.

SENATOR COOK: Will the program be applied equally to an army guard versus an air guard. RANDALL HERMAN: Yes, it is nondiscriminatory.

KEITH BJERKE: The problem with the current program is adverse selection. Our students are very smart and they realized early on if they didn't pursue gift aid. We ended up with \$300,000 shortfall. This cannot happen again.

PEGGY WIPF, DIRECTOR OF FINANCIAL AID testified in support of SB 2084. No written testimony.

SENATOR FREBORG: I will close the hearing on SB 2084.

SENATOR KELSH: I will move for a Do Pass motion.

1. Please estimate the fiscal impact (in dollar amounts) of the above measure for state general or special funds, counties, cities, and school districts.

Narrative:

This Bill serves to correct two concerns higher education had with the National Guard tuition waiver program. First, it limits the percentage of the waiver at 25%. Although this had been the traditional amount of the waiver, it was not set by statute. Second, the Bill relieves higher education of its tuition waiver obligation if the Adjutant General runs out of appropriations for tuition reimbursement. These changes do not cause any increased fiscal impact to the North Dakota National Guard. This Bill provides for the same fiscal impact, according to legislative appropriations, as existing legislation.

TESTIMONY OF LIEUTENANT COLONEL RANDALL D. HERMAN EXECUTIVE SUPPORT STAFF OFFICER BEFORE THE SENATE EDUCATION COMMITTEE JANUARY 19, 1999 ON SENATE BILL 2084

The North Dakota National Guard has conducted a thorough review of the Tuition Waiver program over the past year. In concert with the North Dakota University System, we have been working to enhance program effectiveness, and to reduce budgetary uncertainty for the National Guard and the University System. Current legislation leaves the University System responsible to fulfill tuition waiver program requirements should the National Guard appropriation be insufficient. This bill will provide a specified percentage of University System support to qualified National Guard members through the Tuition Waiver program. ND University System support would be established at twenty-five percent of the institutions current rate of tuition. It also provides that University System support is required only so long as the National Guard is able to provide like support under section 37-07.1-06.2. Our institutions will gain significant predictability for budget purposes, and eliminate the risk of greater support should National Guard appropriations be insufficient.
