Testimony of Pat Seaworth, General Counsel North Dakota University System SB 2141

Senate Education Committee January 12, 1999

Chairman Freborg and members of the Senate Education Committee:

SB 2141 provides that certain donor or prospective donor records in possession of state college or university officials are exempt from the open records law. As you know, absent a specific statutory exemption, all records of a public entity in North Dakota are open to the public. Currently, if a college or university employee is in possession of donor records in connection with the employee's official duties, those records are open to the public, regardless of the donor's wishes.

Employees of private foundations organized for that purpose do much fundraising at colleges and universities. Records of private foundations are generally not open to the public (and because that is the case, I have prepared amendments to SB 2141 suggested by the attorney general's office deleting a reference to private foundations in lines 9 and 10). However, foundation employees involved in fundraising frequently communicate with college or university officials. In fact, it is common for college or university officers to also serve as foundation officers.

Occasionally, a donor wishes to remain anonymous. Also, it is sometimes important, in order to not jeopardize fundraising efforts, to avoid premature public disclosure of prospective donor names. Under current law, such disclosure may be avoided only if foundation employees don't disclose that information in correspondence or other documents sent to college or university employees. That is impracticable when the same person serves as an officer of both the college and the foundation. It also makes communication between foundation and college employees very difficult, even though such communication may be necessary in order to respond to prospective donor requests.

SB 2141 addresses these concerns by permitting college and university officials to not disclose certain personal information about donors or prospective donors. The board of higher education requests your favorable consideration of SB 2141.



Testimony of Pat Seaworth, General Counsel North Dakota University System SB 2141

Chairwoman Kelsch and members of the House Education Committee:

SB 2141 provides that certain donor or prospective donor records in possession of state college or university officials are exempt from the open records law. As you know, absent a specific statutory exemption, all records of a public entity in North Dakota are open to the public. Currently, if a college or university employee is in possession of donor records in connection with the employee's official duties, those records are open to the public, regardless of the donor's wishes.

Private foundations organized to support state colleges and universities generate millions of dollars every year that is dedicated to scholarships and other support for those institutions. Records of private foundations are generally not open to the public. However, foundation employees involved in fundraising frequently communicate with college or university officials. College or university officers assist in fundraising efforts and may also serve as foundation officers.

Occasionally, a donor wishes to remain anonymous. Also, it is sometimes helpful to avoid premature public disclosure of prospective donor names. Under current law, such disclosure may be avoided only if foundation employees don't disclose that information in correspondence or other documents sent to college or university employees. That is not practical when the same person serves as an officer of both the college and the foundation. It also hinders communication between foundation and college employees when a donor or prospective donor wishes to remain anonymous.

SB 2141 addresses these concerns by permitting college and university officials to not disclose certain personal information about donors or prospective donors. This amendment does inhibit public access to any institution fiscal records or other "public" information. All records relating to funds received by colleges and universities, including funds received from private sources, remain open to the public. The only information that will not be open is the name and other personal information concerning a donor, if the donor wishes to remain anonymous, or information concerning a prospective donor. The board of higher education requests your favorable consideration of SB 2141.
