Senator Wanzek introduced the bill. Concern is with rural area where people are struggling in all walks of life. Proceed with caution, very important in rural area that we don't put local telephone companies at risk, or make them vulnerable. This is a way to protect them for the next two years.

David Crothers: Yes, but no entirely. The company can still order them.

David Crothers: It costs more to serve. Study was done that showed the rates to serve the home.

Senator Christmann spoke in support of the bill. Wanted to emphasize this is important to the

David Crothers: The FCC said they will reach the rural community by then.

Senator Mutch: You can still raise local rates.

Senator Sand: I would assume that because MCI, AT&T are in a competitive position. This, if

passed, will eliminate the possibility of them coming here and expecting us to pick up the load

that they dealt away because of the very competitive way.

David Crothers: I think they are very cognitive of the rural situation.

Senator Krebsbach: What is the status of the universal fund?

David Crothers: In November there was a recommendation for leaving the 25 75 but the FCC

has not acted upon that yet.

Senator Mutch: The 75 25 split that's...

David Crothers: Refers to funding of the universal service fund.

Senator Sand: The 75% state dollars will have to come out of city areas in ND. How long do

you think they will put up with that?

David Crothers: The joint board has recommended that they walk away from that formula.

Senator Krebsbach: What impact will this have on cellular companies in the state?

David Crothers: I don't know the answer to that. I don't believe that they are paying access tot

he local companies.

Passage of this bill will allow for continued affordable local rates and continued investment in the rural telecommunications company infrastructure.

"Access" is what long distance companies purchase from local telephone companies to carry a call over local lines, through their switches and deliver to your home because the long distance companies do not have the facilities to deliver that call. The long distance company is paid the full price of the call. "Access Rate" is the payment that long distance companies make to local companies for the use of those facilities.

The Federal Communications Commission has jurisdiction over access rates for "interstate" calls and the North Dakota Public Service Commission for intrastate calls. The latter are those calls originated and terminated in North Dakota.
