Bryan Hoime, N.D. Township Officers Assoc. : 39.6 testified in support of the bill. (See attached testimony)

<u>Chairman Froseth</u> : 43.4 This bill was brought up from Dist 6. There was a heavy rain and

needed to take action immediately. Under present law, they had to give the three days notice.

Rep. N. Johnson : 44.3 Do school boards have to follow the three days notice?

Bryan : I'm not familiar with school boards. Maybe Beth Baumstark would know that.

<u>Beth, Att. General Office</u> : As far as I know, the township officers are the only entities that have a minimum requirement before calling an emergency meeting.

<u>Rep. Niemeier</u> : You still would include notification of the press?

Bryan : Yes, under the open records law.
