Hearing on SB2344 opened. All senators were present.

Testimony In Favor:

SENATOR FREBORG, testified in favor. No written testimony. Intent of bill subsection 3 is to allow schools to build lost hours into a day, clarifies time. The day then can be forgiven by the Governor. Will get clarification for the language.

Testimony In Favor.

Roger Rieger, Director of Approval and Accreditation, DPI. Testimony attached.

SENATOR COOK : How does this apply to a school that has longer than 6 hour days.

Roger: Interpretation is mentioned in Attorney General's letter. Banking time is not allowed as makeup.

SENATOR COOK : Cannot bank time.

SENATOR WANZEK: Original intent that 170 days @ 6 hours, 1038 hours which can be broken to 6 hour days. If they do more why can't they count it.

Roger: Presently it is 1073 hours for secondary and 1,053 for elementary.

SENATOR WANZEK : Never bank hours before the fact. Call early so they could use the hours.

Roger: Interpretation is at a local level, it amounts to bookkeeping rather than makeup time.

SENATOR FREBORG : Schools on a schedule of 6 $\frac{1}{2}$ to 7 hours. They don't lose time, not

allowed to use extra time as makeup time. Do you need this clarified.

Roger: I believe it does not need clarity.

SENATOR FREBORG : Clarification in weather related school time, 6 hour days. Can you

take the two storm days off your regular schedule.

Roger: Does not give blanket forgiveness. Applies to districts individually.

SENATOR FREBORG : Let's say you lose time and he forgives one day.

Roger: Each school needs to fill out a request for forgiveness for a specific day.

SENATOR COOK : Any other questions, any testimony in opposition.

Beth Baumstark, representing the Attorney General's office. No written testimony but urged an amendment to clarify language.

Sen Freborg: This bill does not allow you to bank hours.

Vice Chair Drovdal : In reviewing the other bill, which bill would you be favorable to.

Freborg: I would not favor banking time ten minutes a day.

<u>Rep Grumbo :</u> Governor already has his emergency plans, when you look at him granting this day, in law, don't we have the governor's forgiveness? <u>Freborg:</u> The difference is you can accumulate hours to make a day, if this should pass. Rep Nelson : The Attorney General says banking is not constitutional. Do you share that feeling

that, banking was included in 2173?

<u>Freborg</u>: I never was in favor of banking. I spoke in favor of making up hours so it totaled a six hour day.

Rep L Thoreson : Governor only forgives full days, part days have to be made up.

Freborg: Yes. He may not grant a waiver for less than a full day of instruction.

Rep. Nowatzki : Under the engrossed bill, a school district can request a waiver from the

governor by adding up part days to make a full day.

Freborg: Yes, that is correct.


Roger Rieger: Director of the Approval and Accreditation Unit. (See attached testimony).

Had an amendment that he wished to be considered. see attached to his testimony.

<u>Vice Chair Drovdal</u>: Do you favor both of the bills to pass, or do you favor one over the other? Rieger: Bill HB 1490, that was amended and I believe we can support that as well.

<u>Rep Nelson :</u> Going back to my notes, you opposed both 1489 and 1490, why did you do that? <u>Rieger:</u>They would have shortened the term from 173 days to less.

<u>Bev Nielson:</u> North Dakota School Board Associations. We are neutral on the bill. On line of 18 on page 1 where it says that the governor may not grant a waiver for less than a full day of instruction, I need to understand what that means.

<u>Nielson:</u> If you have a questionable day, coming back to make up five hours some day, I guess my question is, why not allow them to ask for a waiver of whatever part of the day they need. <u>Rep Grumbo :</u> We already have a plan in force, I would assume that 95 per cent of the time the governor would not grant a waiver.

Nielson: Historically they have been granted in really severe winter.

Chairman R Kelsch : Anyone wishing to speak in opposition to SB 2344.

<u>Max Laird</u>: President of NDEA. Our original concern was the length of a school day and how many hours are made up.

Rep Nelson : I would like to hear Mr Rieger's answer to that question.

Rieger: One hour a day or two hours in one day.

Vice Chair Drovdal : Is it policy that if the 7th period is lost is the 7th period made up.

<u>Rieger:</u> We have not put in place any policy, we leave it up to the local school district.

<u>Rep Nottestad :</u> Have you ever done a survey if the time is actually made up the time.

<u>Rieger:</u> When we do our review of the spring calendar, we look at how they made up their 173 days. We do collect the data.

<u>Chairman R Kelsch</u>: Anyone else wishing to appear in opposition of SB 2344. Seeing none we will close the hearing on SB 2344.

SENATOR COOK : Would someone tell me what these amendments are all about.

REP. JOHNSON: The bill is basically 1490 without any of the Senate amendment on it.

SENATOR FREBORG : In looking back at the original bill we really are suppose to be

spending our time on the bill as it came out of the House, but I'm looking at one amendment here

that, at least it is time they drafted this bill they thought was necessary to clarify some language I

guess.

Subsection 3 in section 3, page 3 because of weather school must be dismissed before completing a full day of instruction, school will be responsible for making up only those hours and portions of an hour between the time of early dismissal and the conclusion of a full day of classroom instruction. Now for some reason and again I don't remember exactly what it was but that wasn't a legislators recommendation. The recommendation came from Council that it would clarify language in the original bill in 1997, 2073, was that the year and the bill. Evidently they are not quite comfortable with the language. What we should have done is put this language on 1490.

SENATOR COOK : If that language is important enough to introduce the bill and is still important today maybe all we have to do is strip it of all the amendments that were added to it and pass the bill.

SENATOR FREBORG : All we would do is pass section 3. We don't want to pass the bill anymore. It is section 3, subsection 3, that is the only language we need. But the bill would have to be cleaned up then to change title.

SENATOR COOK : What are your wishes.

SENATOR FREBORG : I only brought it up for discussion to see if we think it is important to get that in or not.

SENATOR COOK : SENATOR FREBORG you introduced the bill do you remember why it was important.

SENATOR FREBORG : I'm sorry I do not. I believe again this was a recommendation of either in fact I think it was DPI, Tom Decker made the recommendation but Anita kind of agreed with it and she drafted the amendment. REP. DROVDAL: Are you familiar with the current law if a school has to dismiss at 2:00 after 4 hours of instruction, under current law are we saying that they have to make up that whole day or just the remaining two hours. This would say that they would only have to make up the two hours but this isn't passed. Under current law how do they determine that now.

BETH BAUMSTARK, ASSISTANT ATTORNEY GENERAL took the podium to answer questions.

BETH: I believe the reason that this was put in is to put into the statute what we said in our AG's opinion that if you have a day that is longer than the minimum day you only need to make up the minimum day. Without that it might be expected that you make up your curriculum day. In some cases it would be more.

SENATOR FREBORG : If we were to adopt just section 3, subsection 3 on page 3 and simply say that we'll take everything else out of the bill and we'll leave that in and whatever proper language we need in the title. That should be all right. So that we don't have to go back to 1490.BETH: That won't conflict with what you've just done in 1490 I think. You are amending the same statutes but really you are just putting in a 3rd subsection.

SENATOR FREBORG : So if we adopted section 3 and nothing else we would be just fine. BETH: Now I not sure what has been done with 1034 to know if you need it both places under subsection 1.

SENATOR FREBORG : I would guess we do.

SENATOR COOK : SENATOR FREBORG I have had a long session with you. If we were to have a motion that the House recede from their amendments and that we further amend to delete section 1 of the engrossed Senate bill would that not leave exactly what you want.

15-40.1-09.1. Emergency resulting from acts of God — Foundation program payment eligibility. The existence of a state of emergency may be proclaimed by the governor if he finds that an act of God has occurred and that the safety and welfare of the inhabitants of the state or of any portion thereof require the closing of schools or any particular school. Any such emergency terminates upon the proclamation of the termination thereof by the governor. Any school district which is located within the boundaries of the territory included within the governor's proclamation of a state of emergency or designated by it may include days actually lost, not to exceed five days, during which school was not held because of such state of emergency for purposes of the foundation program as provided in this chapter. Any school district in which schools are closed for in excess of five days in any school year because of such a state of emergency shall receive two days of credit for foundation program purposes for each additional day school is held to make up for such lost days.

15-40.1-11. Fractional payments. Should the moneys in the state general fund be insufficient to make all payments, the payments to the various school districts or schools must be prorated by the superintendent of public instruction on a fractional basis. When fractional payments are made, additional payments may be made from time to time as sufficient moneys come into each fund, so as to make full payments under this chapter. If the appropriation made by the legislative assembly is inadequate to meet all claims against such appropriation and is thus the cause of the insufficiency, such prorated fractional payments made pursuant to this section constitute payment in full.

Madam Chairperson and members of the committee:

My name is Roger F. Rieger and I am the Director of the Approval and Accreditation Unit for the Department of Public Instruction. I am here to speak in favor of Senate Bill # 2344 regarding length of school day.

I would like to voice a concern I have with the language on page 2, lines 13 through 16, and page 3, lines 5-8. Although we have no disagreement with the intent of this language, we believe it may be limited to cover only for an early dismissal. We do think that it was meant to also take care of late starts. I have an amendment that will be inclusive of late starts or early dismissals and should not alter the intent of this bill.

This bill would add clarity to North Dakota Century Code 15-47-33 or the new section 15.1-06-04 concerning the making up of time lost to weather related late starts and early dismissals. We support maintaining the integrity of at least the minimum hours specified for a 173 school day term.

We urge the passage of this engrossed bill as an amendment and the adoption of the amendment I have offered on the department's behalf. I stand ready to answer questions from the committee.
