Minutes:

SENATOR B. STENEHJEM opened the hearing on SB 2345. Committee members present included: Sens. Bob Stenehjem, R. Schobinger, D. Mutch, D. Cook, D. O'Connell, V.

Thompson, and D. Bercier.

SENATOR WAYNE STENEHJEM I appear as the prime sponsor for SB 2345 which I introduce to you at the request of a Grand Forks prosecutor. There is a discrepancy in the Century Code relating to who can draw blood for the purpose of a DUI. I urge for a Do Pass.

GARY EUREN, GRAND FORKS There are two different statutes that have two different lists of people who can draw blood. Chemists are allowed to draw blood but are never trained to draw blood. There was a person who drew blood earlier this year with a title of CLS (a clinical laboratory scientist). This is a four year old name for medical technologist. We were getting challenges in court because this name is not included in the bill. propose to the bill. There are three or four different sections of the Century Code that need this language. The state toxicologist would be required to determine who would be qualified. (He explained the use of the amendments and change of language).

SENATOR THOMPSON Have people gotten out of cases because of these discrepancies?

GARY EUREN Yes. In administrative action, there have been some licensing hearings

dismissed due to the fact that the person drawing the blood was a designated CLS.

KEITH MAGNUSSON, DEPARTMENT OF TRANSPORTATION testified in support of SB

2345. We think this will clear things up for both a criminal trial and an administrative hearing.

The state toxicologist is the person to determine who is medically qualified to draw blood.

SENATOR THOMPSON There is a bill in the house to do away with administrative penalties on

a DUI. Does this have any effect if that were to pass?

KEITH MAGNUSSON If that were to pass, we wouldn't have as many hearings, but this bill will be good for a number of other hearings such as implied consent for snowmobiles or boating. SENATOR THOMPSON For those who support that piece of legislation, we still need this bill to clear things up, correct?

KEITH MAGNUSSON That is correct.

SENATOR O'CONNELL I don't understand the legal aspect of drawing blood.

KEITH MAGNUSSON If someone unqualified draws blood and is not qualified meaning they may not use the correct kit or solution. The whole blood test will be thrown out.

SENATOR B. STENEHJEM How many administrative hearings for a driver's license do you have in a year?

KEITH MAGNUSSON About 1,000.

SENATOR B. STENEHJEM Can you go through how an administrative process works? KEITH MAGNUSSON An officer has to have a reason to stop someone-they must go through a number of tests. At that point, the administrative process starts and the criminal citation starts the criminal part. The administrative process is required to get the driver's license or driver off the road. It affects their driving privilege. The process is done within 30 days. The criminal process puts the person in jail.

SENATOR B. STENEHJEM What's an administrative hearing? Who's involved?

KEITH MAGNUSSON The director of the Department of Transportation has hired hearing officers-they make the final decision or may make a recommended decision. We have five hearing officers around the state. The hearing officer brings in the law enforcement officer. The officer needs to show a valid stop, probable cause, and evidence of the test. There are questions on if the accused is administratively found guilty but through a criminal trial is found innocent. What happens?

GARY EUREN Even if the House Bill passes there are many other cases involved in this. This provides a procedure so everyone will know what that means. It is a burden of proof.

SENATOR B. STENEHJEM We will close the hearing on SB 2345.

SENATOR O'CONNELL I will move to pass the amendments proposed for SB 2345.

SENATOR SCHOBINGER I will second that amendment.

The amendment passed unanimously.

BLOOD TESTS FOR DRIVING WHILE UNDER THE INFLUENCE.

SENATOR WAYNE STENEHJEM, Dist. 42, introduced SB 2345. He said that it simply makes

a listing for those who are authorized to draw blood.

CHAIRMAN KEISER noted that it expands the group but is still restricted by the State

Toxicologist.

REP. MEYER asked if this includes veterinarians?

SEN. STENEHJEM said he was doubtful.

BRUCE MURRY, Staff Attorney for the DOT, testified in support of SB 2345. He said that the department favors this.

GARY ERREE, Grand Forks City Prosecutor, testified in support of SB 2345. He noted that in it's original form, the bill provides inconsistent language and that also the Medical Technology field has been changed to Clinical Laboratory Sciences. The title is now a Certified Laboratory Technologist.

REP. MEYER asked if medically qualified is listed in the bill?

GARY said that this bill simply allows the State Toxicologist to maintain a list of those who are
