Appearing before the committee to introduce the piece of legislation was SENATOR RICH WARDNER, District 37, Dickinson who is the primary sponsor of the bill. This was brought to the attention of Senator Wardner by the Secretary of State. This bill will repeal and amend certain sections of the code. Handouts were presented to committee members which told them the amount of coverage afforded to each state agency, department, industry, and institution. The bill has the amended sections and the last part has the repealer The thick handout shows which ones have been repealed completely. BOB OLSON, Administrator State Bonding Fund, North Dakota Insurance Department presented testimony to the committee concerning SB 2360. A copy of his testimony is attached. Secretary of State, AL JAEGER appeared before the committee concerning SB 2360. He indicated that 1943 was the last time the bonding requirements for the Secretary of State's office was changed. SENATOR KILZER-Is sovereign immunity any part of this? BOB OLSON-From the state bonding fund, it doesn't affect it one way or another. There was no further testimony in support, neutral position, or opposition to SB 2360. CHAIRMAN KREBSBACH closed the hearing. COMMITTEE ACTION-Motion for DO PASS was made by SENATOR W. STENEHJEM, seconded by SENATOR WARDNER. There was no discussion. ROLL CALL VOTE indicated 7 YEAS, 0 NAYS, and 0 ABSENT OR NOT VOTING. SENATOR WARDNER volunteered to carry the bill.

Representative Klein, Chairman of the GVA Committee opened the hearing on February 12,

1999.

Summary of the Bill: Relating to bonds required of state officers.

Testimony in Favor:

Senator Wardner, Appeared before the committee to introduce the bill. This was brought to my attention by the secretary of state. It started out that he was looking through bonding requirements for his position and found out that he was only worth 10,000 dollars. From there he found some other state offices that were bonded for 10,000 and asked me to take a look at it. The bonding was quite small compared to what the responsibility of the office was. The state insurance department bonds everybody, we looked into repeal of the bonding requirements

because it is covered in code with the state insurance department takes care of it. Legislative council found several more areas in code that could be taken out. So the bill blossomed that way into a large bill (large number of sections that are going to be either repealed or amended). The document he handed out to committee has a list of those that are repealed, because there is nothing else in that part of code other than the bonding. ***(please refer to handout)** The other parts of the bill pertains to the ones that are amended. Section 1 for example talks about the oath of the superintendent. Amended ones are because there is some other part such as oath that they are in there.

<u>Representative Thoreson</u>, So is that filed in the state treasures office? The oath or is that secretary of states office.

<u>Wardner</u>, The office of state treasure. It depends on the position. In section 1, it doesn't mean the superintendent of public instruction, it's superintendent for something that's connected with the treasures office. The only reason that those parts are amended and the other parts are repealed is that you have to leave these requirements in the code. We are going to make sure that everybody is bonded. Even though we have cleaned up the code and take out some obsolete language. we are still making sure that the offices in state government are bonded for. This is a good bill, it cleans things up.

<u>Representative Klemin</u>, What is the reason for taking out the bonding requirements? <u>Wardner</u>, Taking out of code because it's already covered in another part of code. It's duplicate and the amounts were a lot less than we wanted.

Representative Haas, The amount required is zero now because you've taken it out.

Wardner, The insurance department already has rules that govern and it already supersedes that. They tell you how much you have to have.

<u>Bob Olson</u>, Administer of the State Bonding Fund submitted a written testimony which he read in it's entirety (**please refer to his testimony**). There is nothing in statute that says you have to have this much of a bond. It's on an individual basis and coverage is dealt with this way, it's for theft of property and money only by an employee. The amount is whatever you think you should be bonded for if somebody steals some money.

<u>Representative Haas</u>, Then wouldn't it be appropriate to eliminate that last statement of this section of the code?

Olson, Good point.

Representative Klein, Where does the pay's 25 cents per 100 dollars come from?

Olson, It is not paid. Since 1953 we do not collect any premium.

<u>Representative Klemin</u>, The amount you have in reserves, there are no premiums you are charging for any of these entities? From investments/reserves being built up?

Olson, That's correct no premiums and reserves are being built up by investments.

Representative Thoreson, Some of this money going back to the general fund?

Olson, Yes it does.

Representative Kroeber, There is 4.4 million and we have to have 3 million in the fund.

Olson, That's correct.

Representative Klein, Who does the investing?

Olson, State investment board/per statute.

SENATE BILL NO. 2360 TESTIMONY BEFORE THE GOVERNMENT & VETERANS AFFAIRS COMMITTEE JANUARY 29, 1999

BOB OLSON ADMINISTRATOR, STATE BONDING FUND NORTH DAKOTA INSURANCE DEPARTMENT

The State Bonding Fund was established by the 1919 legislature (N.D.C.C. 26.1-21). The bonding fund is under the management of the Commissioner of Insurance.

The bond provides a blanket fidelity bond which bonds state agencies, political subdivisions, and school districts for employee theft of property and money. The bond provides that the public employee or public official, as principal, shall render a true account of all monies and property of any kind that comes into their hands as such public employee or public official and that they shall pay over and deliver the same according to law.

The premium for this bond is \$.25 per \$100 of bond coverage. The 1953 legislature waived this premium charge effective July 1, 1953. There is still no premium charged for this bond coverage. If the reserves of the State Bonding Fund are depleted below the sum of \$2.5 million, the collection of premiums must be resumed on the bond at the same rate until the reserves reach a total of \$3 million.

Presently, there are 2,889 bondholders bonded by the fund with a total limit of liability of \$516,000,000. The statute does not address what limit of liability these bondholders can bond for. This limit is determined by the bonded entity.

The reserves to pay claims are currently \$4.4 million. During the 1989 legislative session \$5,000,000 was taken out of the Bonding Fund reserves and put in the general fund.

In 1993, the Department reviewed their bond fund procedures and forms. At that time new forms were established including a new Insuring Agreement. The bondholders received all new forms at this time.

Claims presented to the fund have increased substantially since 1991 but are still not excessive and are very manageable in regard to the reserves in the fund. Attached is a breakout of claims activities over the past biennium's.

Also attached is a list of the bondholders by the entity type.

BOB OLSON, ADMINISTRATOR STATE BONDING FUND NORTH DAKOTA INSURANCE DEPARTMENT

Mr. Chairman and Members of the House Government & Veterans Affairs Committee. My name is Bob Olson and I am the Administrator of the State Bonding Fund. This fund was established by the 1919 legislature (N.D.C.C. 26.1-21) and is under the management of the Commissioner of Insurance.

We are in support of SB 2360, if only from the standpoint that we feel the majority, if not all, state entities are bonded with the fund. We have a total of 94 state entities bonded.

The wording that is being eliminated only addresses securing "a bond." This could be either a fidelity bond or a surety bond. A fidelity bond, which covers for theft and/or embezzlement, is what the fund provides and a surety bond is more of a performance of your duties type bond. It appears the main exposure to state entities would be theft of money and/or property.

The fund provides a blanket fidelity bond for state agencies, political subdivisions, and school districts for the protection of employee theft of property and money. The bond provides blanket coverage, which means everyone employed by the bonded entities, is automatically covered.

The premium for this bond is \$.25 per \$100 of bond coverage. The 1953 legislature waived this premium charge effective July 1, 1953 and there is still no premium charged. If the reserves of the Fund are depleted below the sum of \$2.5 million, the collection of premiums must be resumed for the bond at the same rate until the reserves reach a total of \$3 million.

The reserves to pay claims are currently \$4.4 million. During the 1989 legislative session \$5,000,000 was taken out of the fund reserves and put in the general fund and the 1991 legislature took \$2,000,000 out of the fund reserves and put in the general fund.

Presently, there are 2,889 bondholders with a total limit of liability (coverage in force) of \$516,000,000. The statute does not address what limit of liability these bondholders can bond for. This limit is determined by the bonded entity in cooperation with the fund.

In 1993, we reviewed our procedures and forms and discovered some changes needed to be made. We issued a new Insuring Agreement along with updated forms. All bondholders were sent a folder with the current forms and documents.

Claims presented to the fund have increased substantially since 1991 but are still not excessive and are very manageable in regard to the reserves in the fund. Attached is a breakout of claims activities over the past biennium's. Also attached is a list of the bondholders by the entity type.
