### SB 2394 Senate Judiciary February 1, 1999

Mister Chairman and members of the Judiciary Committee, for the record I am Senator Rod St. Aubyn, representing District 43, in Grand Forks. I was asked to introduce this legislation at the request of the Chief of Police at the University of North Dakota. UND Police have a specifically designated area of jurisdiction within Grand Forks. On one occasion the police were patrolling along one of the boundary streets of their jurisdiction. The encountered a car in the ditch on the opposite side of the street of their jurisdiction. Upon further investigation, the officer discovered that the driver was intoxicated and was subsequently arrested. However, the charges were later dismissed because the judge felt that the UND Police were beyond their area of jurisdiction. 1 have spoken with the chairman of this committee about this bill. I had asked the legislative council staff to write the legislation. However, the language of this bill may not be exactly what is needed to accomplish what we desire. I ask for your assistance in working with us in drafting any amendments which may be necessary to deal with the problems. Mr. Chairman and committee members, I would normally stand for questions, however, this is way beyond my expertise and I would suggest we wait until Chief Czapiewski gives his testimony. I ask for your support in giving SB 2394 a Do Pass recommendation. Thank you.

### Testimony on SB 2394 Senate Judiciary February 1, 1999

Mister Chairman and members of the Judiciary Committee, for the record I am Duane Czapiewski, Chief of Police at the University of North Dakota, in Grand Forks. The University has properties off the campus proper and our department has the responsibility for law enforcement and security issues for those areas as well as the main campus. UND Police has been designated a specific jurisdiction which entails the UND campus along with a section of residential area within Grand Forks. We are a licensed peace officers in the State of North Dakota. We have the same training as any other law enforcement agency in North Dakota and must maintain the same standards. We also do document transfers to the court and transporting prisoners to the correctional center. We often encounter various violations going to or returning from those areas. With our present statutes campus law enforcement does not have the authority to intercede or stop the suspects. The incident relayed by Senator St. Aubyn is one of many which have occurred and the court has dismissed charges because they felt we were beyond our jurisdiction. Based on the 1990 Campus Security Act and the 1997 Higher Education Act, our Department is mandated to report all criminal statistics to the public and identify the crimes adjacent to our jurisdiction which may affect students.

Under section 15-10-17.1, the Board of Higher Education could ask our department to investigate an incident or situation at another campus. We could do so within the campus juridiction. However, it is questionable that we would have the legal authority to pursue a criminal charge. On college campuses, many activities are better left as a campus administrative sanction, versus criminal charges. When a campus does not have their own campus police, it

becomes more of a problem working with their city's police department because of the nature of campus organizations. Our intent is not to broaden our power, we have more work than we can handle at this time. We do want to have the ability to handle those other types of situations which may occur at some of our other campuses. We are sensitive to the public reaction of having the public see a police officer at the scene of a crime, but not be able to deal with it. Mister Chairman and committee members, while the language in this bill may not be exactly what should be enacted, I hope you can help us correct the problems we currently experience. I ask for your support in giving SB 2394 a Do Pass recommendation. Mr. Chairman, I would be willing to answer any questions the committee may have.
