Minutes:

SENATOR SCHOBINGER opened the hearing on SB 2403. Committee members present included: Sens. R. Schobinger, D. Mutch, D. Cook, V. Thompson, and D. Bercier. Senator Bob Stenehjem and Senator David O'Connell were absent.

SENATOR JERRY KLEIN, DISTRICT #14 testified in support of SB 2403. This bill is a result of a 0 tolerance bill which we passed two years ago. The intent of the law was to take away the driving privileges for 18 to 20 year olds if they are caught driving while under the influence. It's a good idea, however, it seemed that this would not be put on the public viewing record and I know that it has. This bill will place it in the record for law enforcement but out of public view. This will not take away any DUI conviction out of public view but this only pertains to the 0 tolerance age bracket which is 18-21 years of age. They would not be off of the hook. We attempted to work it through administratively but it seems this was the best approach. This does

not affect any other law that deals with DUI's. We are not trying to take away the public's right to know.

SENATOR COOK Do you have copies of testimony from last session?

SENATOR KLEIN Your chairman does have that information.

SENATOR COOK Does this clear up your son's record now?

SENATOR KLEIN I don't know.

JACK MCDONALD, ND NEWSPAPER ASSOCIATION AND BROADCASTING

ASSOCIATION testified in opposition of SB 2403 (see testimony).

SENATOR COOK Did you follow the hearing on the bill two years ago? Were you against it?

JACK MCDONALD I did testify against it.

SENATOR COOK Was it in opposition for the same reason today?

JACK MCDONALD Yes.

KENT OLSON, ND PIA We have a question on line 12, item 2 of the bill. We have a problem with eliminating suspensions. Would the suspensions be public record for multiple offenses because a suspension is key to underwriting?

JACK MCDONALD Section 2 is reworded but it doesn't change it.

SENATOR SCHOBINGER Is there any other testimony?

SENATOR SCHOBINGER We will close the hearing on SB 2403.

KEITH MAGNUSSON This bill will take care of it.

SENATOR COOK I move a Do Pass on SB 2403.

SENATOR SCHOBINGER I will second that motion.

SENATOR COOK We did have some opposition against this bill and he made a valid point that someone hiring for a delivery or something will want to know what that record is, however, prior to last session there was no record.

SENATOR B. STENEHJEM I am supportive of the sanctions of this bill but this is not a part of the permanent driving record and should not be open to any agency or person. It was our intent last session when we passed this to make sure it did not go on public record.

A roll call vote was taken (5 Yeas, 1 Nay and 1 Absent and Not Voting).

SENATE TRANSPORTATION COMMITTEE SB 2403

CHAIRMAN STENEHJEM AND COMMITTEE MEMBERS:

My name is Jack McDonald. I'm appearing here today on behalf of the <u>ND Newspaper Assocciation</u> and the <u>ND Broadcasters Association</u>. Despite the fine and distinguished list of sponsors, we have to oppose **SB 2403**.

While we fully understand the reasons for this bill, nevertheless the bill does close a segment of public records that are now open to the public. The boards of directors of our associations have taken a firm stand to oppose all additional closure of public records.

These types of records are particularly useful in doing news stories or in in doing research. If, for example, we wanted to check on the driving records of the Bismarck School District's bus drivers, we would quite likely be looking for some of the records this bill closes. If there was an accident involving young people, we would be looking at these records.

And, I suspect, if an employer is looking to hire a young person for any type of a position that involves driving, that employer would also be interested in looking at these records.

The minor in consumption statutes were put in place to discourage minors from drinking. I don't think this bill continues that philosophy.

We <u>respectfully</u> request a DO NOT PASS. Thank you for your time and consideration. I'll be happy to answer any questions if I can.
