This resolution is really SENATOR FREBORG'S, as was the bill. The resolution is about standards and assessments, a result of the withdrawal of SB2429. We do in ND as you are well aware spend a considerable amount, \$500,000 dollars an hour or somewhere in that range on education, yet we are way behind other states in how we have any kind of standards to base the performance on the dollars that are being spent. I think it is time that we have a system of accountability. Next session it will be almost mandatory to develop a system of accountability and so that is why I believe having a thorough study of the issue for the next two years would be extremely important.
