Representative Wentz: We will open the hearing on HB1024 Workers Compensation.

David Ystebo: (3440) Chairman of ND Workers Compensation Bureau's Board of Directors. See attached.

Dick Johnson: (3715) Chair of the ND Worker's Compensation Bureau's Board of Directors

Audit Committee. See attached

<u>Paul Kramer</u>: (3945) Executive Director and CEO of ND Worker's Compensation. See attachments.

<u>Representative Gulleson:</u> (5510) On your satisfaction survey, why wouldn't you curvy the workers that were denied claims?

<u>Paul Kramer</u>: When they are denied they may not be truthful, and may not be able to respond not having gone through a claim. Page 2 Education and Environment Division Bill/Resolution Number HB1024 Hearing Date January 12, 2001

<u>Representative Gulleson:</u> If you only survey the successful claims you should have an extremely high rating, and not much to learn from that information. I question that . I don't know any other business that can measure their business by only the success.

Representative Wald: (5830) What is the percentage rate of claims denied?

Paul Kramer: We are at 4-5 percent. Our percent is lower than the national averages.

Tammy Dolan: (6015) Vice President of Employer and Fiscal Services for Workers

Compensation Bureau. See Attached

<u>Representative Wentz:</u> (787) I am going to ask you a question about the office building. You

use the language it is considering construction and yet it sounds as if a decision has been made.

<u>Tammy Dolan:</u> The board has not made an official decision to construct an office building. We have not chosen a site.

<u>Representative Wentz:</u> But you have not listed any rent expenses for 2003. How would you pay your rent in 2003?

Tammy Dolan: If the board decides not to build, it may require an amendment to out budget. We could also purchase the building we are in now. It was authorized in the last session as a continuing appropriation.

<u>Representative Wald</u>; (925) If you were to build, do you have any preliminary costs? <u>Tammy Dolan</u>; Yes, 5-61/2 million dollars.

<u>Representative Wald:</u> I assume you would use your surplus or equity to pay for the building, and that would show up in your asset side rather than cash in the bank. Would you pay your self rent?

<u>Tammy Dolan</u>: Yes to your first question and secondly we would consider it as an asset. We look at building as an investment.

<u>Representative Wald:</u> Have you done a cash flow analyst of renting as contrasted to owning? And how long are you obligated to your lease? Does the State Investment Board manage your funds?

<u>Tammy Dolan</u>: The numbers clearly point out renting was not the best financial decision for us. We are on a annual lease at this time. And yes, our funds are managed by the investment board. <u>Representative Aarsvold</u>: (1350) I am feeling uncomfortable about the rent issue budget situation with what seems like a black hole. I would be in favor of reinstating the 66,00 in the advent that the board should make a decision contrary to their apart intent at this point. I would like something a bit more solid. Secondly, in regard to the professional development of the 436,000, how does that compare on a employee basis with other states?

Tammy Dolan: I'm not sure. For most of the employees the seminars are local.

<u>Representative Wald:</u> (1540) Back to page of your testimony under operating expenses. I too am concerned about that. If we left the budget as you asked, and you hit a snag of some sort How would we fund the other 466,000 if you needed it and we didn't put it in now?

<u>Tammy Dolan</u>: You are absolutely right we would have a bit of a situation in finding funding for that second year. We potentially make adjustments and hold off on other things, and go month to month.

<u>Representative Wald</u>: Wou'dn't it make more sense to include it into your budget rather than you come begging to an emergency commission.

<u>Tammy Dolan</u>: The reason we did not and could not include it in our original budget request, we needed to meet the Governor's holding budget request. In order to do that we had to make some savings

Representative Wald: Was building your own building a recommendation of your consultants?

<u>Tammy Dolan</u>: One of the recommendations in the performance audit wasn't necessarily specific. They did recommend we look at more privatized situations, which of course owning your own building was one of them.

<u>Representative Gulleson:</u> (1980) Was one of your recommendations that your agency just go privatize completely?

Tammy Dolan: I don't think so, many other things that are similar to privatization.

<u>Representative Aarsvold:</u> If you began to operate in a more independent fashion, are there any tax consequences if you were to build you own building. Especially if you were to lease space. <u>Tammy Dolan</u>: We are tax exempt since we are a state agency. For property tax there is a provision that we will make a payment in lieu of property taxes to where ever it is we decide to build.

<u>Representative Wald:</u> I suggest everyone in this room including those in the back, get a copy of the consultants report before we make a decision on this budget.

Tammy Dolan: Continue with equipment attachment.

<u>Representative Wald:</u> (3246) In your whole fraud arena, I would hope that if we approve that FTE that you would have more emphasis on employers that hire some employees, and pay them in cash, or call them an independent contractor. I am convinced that you need an addition staff person to see that all employers pay premiums.

<u>Representative Aarsvold</u>; (3611) On page 7, the two technological fraud detection systems that are being purposed. What are we talking about?

Tammy Dolan: Computerized systems. One focused on employer fraud and the other for injured workers.

<u>Representative Aarsvold:</u> Certainly with Medicaid and Medicare we read a lot about provider fraud. It seems to me that is one place where some energy could be devoted. <u>Tammy Dolan:</u> Medical provider fraud is one of the most difficult one to find and research.

There are systems out there and we will use them as much as possible.

<u>Representative Wald:</u> I don't think your auditing department is doing enough work in the area of reclassifying some employers.

Tammy Dolan: We have found accounts have been misclassified for years. We now have a new process which will classify new accounts properly.

Representative Wald: Are you asking for money for auditing in your budget? How is your accounts receivable situation today.

Tammy Dolan: No. Our accounts receivable as of June 30 was 35 million dollars. A large portion of that is past due. About 2 million would be over a year old. We can cancel a policy if payment is past due.

Michael Wolf: Manager of the County Employers Group (CEG) for the ND Associations of Counties (NDACo). See Attached.

Representative Wentz: (6075) What was the amount of the grant and the life of the grant?

Michael Wolf: The amount was 160,000, which will expire in June 30, 2001.

<u>Representative Wald:</u> Are the counties billed as one unit, or is each county billed for their premium?

Michael Wolf: In 1916 we consolidated all 53 counties into one account.

<u>Representative Wentz:</u> Does anyone else wish to appear in opposition of HB1024? Seeing none we will close the hearing on HB1024.

<u>Representative Wentz:</u> We have a hand out from Legislative Council.

L.C. Member: What I distributed was a vacant FTU listing. As of December 31, the number of vacant positions in each agency budgets that are funded in the Governors budget. The number of vacant positions in each agency budgets that are funded in the Governors budget. If there is a vacant position that the Executive Budget doesn't have funding for it is not included in here. Representative Wald: On HB1024, the sub committee consisting of <u>Representative Bochm</u>, <u>Representative Gulleson</u>, and myself. There are two amendments 0106, and 0105. We are transferring two other bills into HB1024. We are moving HB1163 and HB1187. See attached amendments. Remembering Workers Compensation is all special funds. There are no general fund dollars in this bill. In the testimony they included rent for only one more year because they were going to build their own building. They have run into some snags as to a location and clear

title to property. We are including the 466,000 dollars to pay rent for the entire biennium. Should they complete their property prior to this time this will be a turn back in that particular line item which is doubtful.

<u>Representative Aarsvold</u>: Is there language in either 1163 and 1187 that we must save in terms of implementing those programs.

Representative Wald: Our legal council, Joe says no.

<u>Representative Wentz:</u> I still have question about the money they maintain they think they can save by moving those in house. They said, it cost them 6.8 million to contract for them and if they bring them in house they are telling us they are going to save 4.2 million. That just doesn't all up.

<u>Representative Wald:</u> I think what happened, in the last four years we have seen dramatic changes. They contracted with people that are expertise in that field. When you are in a hurray you can't always negotiate the best deal.

<u>Representative Aarsvold</u>: Are those competitive bidding sorts of situations that we see for those services?

<u>Representative Wald:</u> As I said if no competition they can ask what they want. Living in ND it is hard to attract associations from Minnesota. I believe it is a negotiated situation. Utilization review was a Minneapolis firm. They have moved some employees here.

<u>Representative Aarsvold</u>: Have we computed new employees with benefits etc. As opposed to contracted employees?

<u>Representative Wald:</u> If you look at the house version it will increase the salaries of 17.8 to possibly 20.2 million. The other amendment see attached 0105.

Paul Kramer: Executive Director and CEO of ND Worker's Compensation Bureau. What we have done is negotiated some new contracts for everything, but both rehabs. In the course of those changes we have made a sibstaaancial savings. The 4.2 million savings, about 2.6 of that is in both rehabs. That savings is in the 4.2 million.

<u>Representative Monson</u>: Did you say some of the 4.2 million that you have in your projections is already saved because you did some switching?

Paul Kramer: The 4..2 million is new.

<u>Representative Wald:</u> Would you specify in 0105, what a special investigates duties would be. 1 understand you use many outside adjusters or law firms. Some of that would be picked up by this.

<u>Paul Kramer:</u> We contract out our actual investigation. That would save us the travel expense. Our internal people manage our external investigators and put the case together.

Representative Wald: 1 move amendment 0106. <u>Representative Boehm</u>: Seconded the motion. 5 yes, 1 no, 1 absent.

Minutes:

House Appropriations Committee action on HB1024.

Rep. Francis Wald: I'm responsible for the Workers Compensation Bureau budget, first of all 1 want to take you to the budget book if you care to on page 271, the executive recommendation is about a 4.2% increase from the previous biennium, and J won't recite all those numbers, as you can see it for yourself. But if you will go to your bill book and find amendment .0107 dated July 29, 2000, that's what I'll walk you through. This budget is all off budget its all employer paid premiums that drive this and there is no general fund money in it. All of the employees in Workers Compensation are not classified so they don't come under the state personnel system, I can also tell you that, in the industry, somewhere between 25 and 30% of the premium income is used for overhead and operating expenses. In North Dakota Workers Compensation there somewhere between 10 and 12%, so in comparison to the industry and to other state funds, North Dakota runs a very efficient operation in terms of the premium dollars used for administration.

Now If I can take you to the bottom 2/3rds, we made several changes in this budget, in that the first column where it says "Increased Funding for Expansion of the safety grant program, we amended HB1163 into HB1024, and what were doing there is increasing the budget in one FTE and this is a program that was started several biennium's ago for the association of counties. The first column that you see there increased funding for the safety grant program is basically HB1163, the next column is a substantial increase, and I will explain that, that's HB1187 which we amended into this bill and will have to DO NOT pass those two bills later. To continue on in that column, increased funding for bringing contracted programs and services in-house and then there is a number one footnote. What were doing here is bringing in utilization of new people, medical bill and entry people, and audit people, case manager people and rehabilitation services in-house. All of those programs are currently contracted for with private contractors, and one of those contractors is with the Utah Work Comp fund, and another one is out of the Twin Cities, so basically what were doing is rather than contracting for these services, were going to hire them and there going to come on stream and be on workers compensation payroll. Most all of these people are already housed inside workers compensation on front street, some case managers in rehab are in Fargo, Grand Forks, Minot, and some of them are out of town. What were doing there is picking up 25 FTE's that are currently working for the bureau on a contract basis, were simply going to convert them from independent contractors to employees, and that is HB1187. The cost of paying for those people on a contract basis is \$6.8 million per biennium, but bringing them in-house the cost is going to be, as you can see \$2, 572,647 dollars, so its a savings of about \$4.2 million dollars to the bureau over one biennium by bringing them in-house as employees. The third column is increasing the rent for the entire year when the budget was put together, they had anticipated that they would have their new building ready by the end of the first year of the

coming blennium, that is not the case, their behind in terms of nailing down a specific location in getting moving on their own building, so the \$466,000 would be the rent for 2nd year of the blennium to pay for an entire two years, and then the fourth column provides for funding for a special investigator, and that would be primarily in the area of fraud in employers of auditing payroll people who simply avoid paying premiums at all because they pay their employees in cash or simply don't buy workers comp. Right now they use about 15 private investigative and law firms in fraud cases and they believe they will save money by bringing in a full time specialist in some of these cases. They also asked for an additional person, as a Human Resource Specialist and we turned that request down, we felt that the one Human Resource Specialist they have on staff was sufficient to handle about 200 employees. Those are the amendments to the bill, and as I said we incorporated HB1163 and HB1187 into HB1024, with an additional 25 FTE's in the in-house services and the other two amount to 27 FTE's.

Rep. Mike Timm: In the discussions with the bill they were talking about a new building, did anything come about other cities making proposals to build a building and move the bureau to another city? Response: No there was no serious discussion about moving the bureau to another city.

Rep. Ole Aarsvold: Just to refresh my memory from last session, my recollection was to authorize the agency to look at options of building, but there was never an authorization offered to my recollection, was that true? Response: No, we passed legislation last session authorizing them to build their own building, and if you will recall the governor vetoed it and we overrode his veto.

Rep. Jeff Delzer: Again I would say that we could buy the Butte school for about \$5,000.

Rep. Ellot Glassheim: In increasing the wages to bring on 25 new FTE's for 2.2, they said there going to save \$6.8 million in contracting services.? Response: Were going to save \$4.2 million, its a change from operating to salaries.

Rep. Bob Skarphol: It was never in this budget so you can't reflect the change in this budget, it actually was in the other House Bill, and the change would be reflected if that passed and then were amended in here, then it all could get reflected, but its theoretically going to get killed.

Rep. Mike Timm: So it can't be reflected in here unless its in here to begin with, but the additional costs are reflected in here, but not the savings. Its referred to as savings of an anticipated increase in spending.

Rep. Keith Kempenich: We had a HIPPA they said Workers Compensation was exempt, but is Workers Comp going to have to change some stuff? Did you have any conversation about that with Workers Comp, and how they were approaching that issue?

Rep. Ken Svedjan: Workers Comp is exempt from the provisions from HIPPA and no one can explain why, nor can anyone explain the logic.

Sandy - OMB: There hasn't been any conversation on that, in which I participated regarding that, however, I was just looking at the amendment that you were proposing on the contracted services, and what Rep Glassheim had said. Currently their contracts are part of their operating expense, the cost is coming out of that, so it would appear to me that there would be an offsetting reduction under operating for the money that will be saved in this next biennium.

Knudson - Legislative Council: I would agree that it appears that if that is being spent now it would be in their current budget and in their proposed budget, and any savings should be an offset to this increase.

Rep. Mike Timm: HB1187, that bill was it just a bill to re-authorize a program that's been going in the bureau now? Response: That bill was to provide for the changes that are reflected here under number 2 to provide the additional appropriation of about \$2.6 million. That's what that bill did.

Rep. Bob Skarphol: If you get on cyber and start looking at the contractual services in the last biennium they have \$2.5 million which is going to be reduced by \$937,000, which is a subsequent reduction in building and leases of \$319,373, so there are some reductions taking place as well.

Rep. Ole Aarsvold: I think perhaps Rep. Wald could respond since he is closest to this agency, I'm wondering what is unique about Workmen's Compensation in that they are able to save significant dollars by bringing services in-house as opposed to contracting, when other agencies it seems it goes the other way, it is more cost effective to contract for those services.

Rep. Francis Wald: We asked them that question and in conversations I have with Paul, your right, generally speaking, the buzz word today is outsourcing, and privatizing and this kind of goes in the opposite direction as you cluded to, and I think when they started going into utilization review and they started moving into the 21st century in terms of work comp reforms the other industry people were doing in other state funds in other states. It is almost at there mercy to find these people on short notice, and so they pretty much dictate what the cost is going is going to be for providing those services, and the best deal they could find was contracting with the Utah Fund and a firm in Mpls, and I suppose now that they have had some time to know where they are going and that sort of thing, so its much cheaper to hire them as employees than contracting. And I suppose those who were providing the contract did whatever the freight would bear, and I guess that's how things work in the business world.

Rep. Ellot Glassheim: So if I were to draw a conclusion then, the nature of this is pretty specialized and there are a limited amount of vendors out there to provide those contracted services. Response: I think that would be a fair statement. I find now in the testimony in page 3 what I think answers my question, they have been taking the payment for these contractors not out of operations but out of allocated loss adjustment expenses, and so the savings is off budget because its coming out of there claims which we don't deal with, and we have no way of seeing it.

Rep. Francis Wald: I would move the amendments. Seconded by Rep.Skarphol.

Rep. Mike Timm: Any Discussion? All those in favor of adopting the amendments signify by Saying Aye. Voice Vote. Motion passes. Amendments are adopted. Any more additional amendments that any one wants to make?

Rep. Bob Martinson: 1 have an amendment that I would like propose that I have passed around and it basically it forces the Workers Comp Bureau to pick their site selection by Feb. 28, 2001 or they will lose their authority to build their building. (18024.0109) Seconded by Aarsvold.

Rep. Bob Skarphol: I guess I would like more of an explanation from Rep. Martinson as to his reasons why?

Rep. Bob Martinson: They have had over two years to get moving on this and there are those that think they are dragging their feet and they might not get it done in the next two years. They preliminary looked at three sites in Bismarck and some say they have selected a site, but it just gets them off the dime.

Rep. Mike Timm: Maybe their still considering the possibility of putting it up in Minot **Rep. Bob Martinson:** They may be, but I think they may be much more favorable to looking at the piece of property I have for sale. (This was a Joke)

Rep. Francis Wald: Lagree with Rep. Martinson, that we should have a time certain as to when they need to make a decision on their own building and its location, but 1 guess Feb. 28th is within their time frame, but 1 would feel more comfortable if it were July 1, 2001 or June 30 at the end of this biennium. Feb. 28th is a month away.

Rep. Bob Martinson: The people that I talked to, including the director said Feb. 17th would be fine, and I said why don't we at least make it the end of the month.

Rep. Rex Byerty: If the Director of Workers Comp said that Feb. 17th was fine, I would assume that the board is going to make a decision directly, so I have no problem with the amendment but it just seems like, why would we amend it if their on the verge of making a decision, I am not close to the issue, and I'm not from Bismarck, and I know its not going to be in Williston, I guess I don't understand why were putting the amendment on. Normally on one of these things, we would put a sunset clause on that corresponds with the end of a fiscal or calendar year, the effective date of the bill, something like that, but to put in an amendment that has a retroactive clause on it, this bill isn't going to get out of the Legislature before the trigger date sets in.

Rep. Bob Martinson: They appointed a building committee.

Rep. Mike Timm: Rep. Martinson, would you be willing to make that July 1st, 2001?Rep. Keith Kempenich: The only way that this would push them, because it doesn't take effect until everybody gets through signing it and even then would it go to July 1st.

Rep. Francis Wald: Were putting an amendment on a bill that takes effect on July 1, 2001 with something that triggers on January 28th, which is in the present biennium, the bill before us HB1024 starts in the next biennium, so can we put an amendment on a bill that really doesn't become activated until July 1, 2001?

Rep. Ole Aarsvold: The reason I'm supporting this, is that 1 would like to be in town when they make the announcement.

Rep. Mike Timm: A motion was made by Rep. Martinson, seconded by Rep. Aarsvold to adopt this amendment.

Rep. Bob Martinson: I would like to add one more thing, this really came about, because in the budget they had only requested rent payment for one year, so when we asked them on when they were going to make a decision, we got mealy mouthed all over the place, well they weren't sure about this and that, so we said why don't we make you make a decision, and there seemed to be some agreement on that, and then I asked, how soon can you make it? And they said that Feb. 17th would be a reasonable date, so I said we should at least make it until the end of the month, so that's how this all came about.

Rep. Mike Timm: Rep. Martinson, is it your intention that we slap this amendment on knowing that they will take notice, knowing that the Senate will probably take it off later, is that your intention? But at least you will make your point. Any other discussion on the amendment? All those in favor of adopting this amendment (.0109) signify by saying AYE. Voice vote. Motion passes and the amendment is adopted.

Rep. Francis Wald: I would like to alleviate the fear that was raised by Rep. Glassheim, if you will go to HB1187 and go to the testimony on pages 1 & 2 and its in the middle paragraph, and I will just read it to you. "Work Comp presently contracts with several vendors to provide a multitude of services, contractors provide utilization review, medical bill audit, and medical bill entry already located within the Bismarck office, some case managers Voc Rehab Counselors work in field offices throughout the state while others work from their homes, these services cost the fund approx. \$3.4 million each year or \$6.8 million per biennium, since the program services

provide a direct relationship to specific claims, these costs are paid through a continued appropriation loss adjustment expenses, these expenses are reflected on the Work Comp profit and loss statement, not in the biannual appropriation request" and so we don't need to have an offsetting item in operating, because it comes out of the claims column not out of salary, payroll or operating.

Rep. Mike Timm: We have the bill HB1024, are there any other amendments? Rep. Wald moves for a DO PASS as amended. Seconded by Rep. Skarphol. Any Discussion? Clerk will call the roll for Do Pass as amended. YES (17) NO (3) ABSENT and not voting (1). Motion passes and Rep. Wald will carry the bill to the floor. (2480)

Minutes:

Senator Solberg opened the hearing on HB1024 - workers Compensation Bureau.

<u>Dick Johnsen</u>, Chairman of the Audit Committee for the North Dakota Workers Compensation Board of Directors, presented testimony in support of Engrossed House Bill Number 1024 (a copy of his written testimony is attached).

Senator Solberg: Has the Bureau responded to the recommendations by the BI-performance audit?

<u>Dick Johnsen</u>: As of last Thursday when we met and review the current update status -- of the 138 recommendations; 47 have been implemented; 50 partially implemented; 17 are not applicable; and 14 are pending (waiting for legislative action).

We took the recommendations seriously, though felt a number of them could have been rolled into one -- however the track performance of the Bureau is important.

Paul Kramer, Executive Director and CEO of North Dakota Workers Compensation, presented a brief overview of the Bureau's activities during the past biennium (A copy of his written testimony is attached).

Senator Robinson: Investment slide -- one in independent provider column. When Oregon presented their list of problems in the area of providers -- there were more: this doesn't seem consistent?

<u>Paul Kramer</u>: Perhaps in the definition of a problem -- hard to determine fraud; we have provided education and made changes; look differently at the category perhaps -- they may list problems that are not fraud. We have educated individuals to property code items; fraud is hard -- difficult for one provider to testify against another provider.

Senator Robinson: Broad spectrum --- but if fraud, it's fraud.

Senator Heitkamp: My area is heavy industrial -- we have injured workers who have experienced difficulty in seeking funds --- you indicate what you're doing, but what are you doing about all the injured workers? I've a list -- I've called regarding them, have been told the Bureau's practices nothing directly related to the individuals -- can understand their frustration with Bureau.

Paul Kramer: 1 will be happy to take the list and review it.

<u>Senator Heitkamp</u>: Workers Compensation is for the workers -- yet you're ranked 3rd highest in profitability (only Wyoming and the Virgin Islands are ahead of us) -- money in it--- not out to workers? Worried about losing system by not protecting the workers?

<u>Paul Kramer</u>: The Board is looking at full system --- doing sound business decisions, similar to the private businesses not government. Regarding benefits, we administer by past laws, pay as stated.

Senator Heitkamp: Subjective laws, by interpretation of individuals.

Senator Thane: Realize the good work you're doing; but need to sell to the public, how will you accomplish?

Paul Kramer:: Twice a year we have seminars; now have a newsletter -- trying to improve information throughout the state. There was a bill in the House that would have provided a discount to firms hiring someone who had been injured at another company --- 3 year discount; get injured worker back into the work force.

Senator Thane: Remember the Fargo Forum article "Shame on ND" which was critical of the Bureau --- erased a lot of hard work on your part.

<u>Paul Kramer</u>: We talked about that letter. It is frustrating; but unless the individual signs a release --- no release signed --- we cannot talk about it. No counter action to be taken by us. <u>Senator Bowman</u>: Customer satisfaction --- ultimate goal? A- can't be bad -- do you survey all injured workers?

Paul Kramer: Survey sample of those who accepted claims; no interactions with staff.

<u>Senator Tomac</u>: Customer satisfaction --- denied customers not surveyed? Only claims handled? <u>Paul Kramer</u>: Customer service can be evaluated only with those who have had interactions with our staff.

<u>Senator Tomac</u>: Reason for denial? Most surveys are dumped if one feels it's going nowhere, or one is dissatisfied?

<u>Paul Kramer</u>: We do a follow up phone call. Of 500 surveys sent out, 400 plus were returned. <u>Senator Tomac</u>: Chart 1, equity difference and 6% adjusted --liability adjustment all the same year? What rate decreased? Comparison with other states?

Paul Kramer: North Dakota figures are based on payroll cap; other states gross pay.

Senator Tomac: Explain?

Paul Kramer: Earnings of 40 thousand -- charged on first 16 thousand: Minnesota pays on 40 thousand. Only 3 states use payroll caps: Wyoming, Washington and North Dakota.
Senator Tomae: House bill to change this tried?
Paul Kramer: Tried bill, didn't market it well, House is not to blame, we didn't do our job in

educating.

Senator Tomac: work under statues?

Paul Kramer: Based on state average wages.

Paul Kramer: Us or the insurance company. 50% decisions within 70 days; cases filed through insurance (such as Blue Cross/Blue Shield) have their own checks -- may deny and ask that they be filed with worker compensation --- then if it goes back to BCBS if not workers compensation claim. We believe the process could be speeded up if BCBS would phone us--- save filing time, etc.

Senator Tomac: My neighbor gets the bills -- past due bills -- on what is truly a workmen's compensation related claim.

<u>Paul Kramer</u>: Can't address unless I could review the case. Perhaps medical servers were not aware it was work related.

Senator Lindaas: Contact those not satisfied? I've a small file of those who are not. What is the Office of Independent Review? How does it operate? Where do they get the support? <u>Paul Kramer</u>: Yes we have such a division; part of the workers compensation -- off site from the office- claims officers. We fund, purpose is to have an independent look -- work with the person

CONFERENCE COMMITTEE REPORT ON ENGROSSED HOUSE BILL NO. 1024

This memorandum is to address issues regarding the Conference Committee amendments to Engrossed House Bill No. 1024, the Workers Compensation Bureau appropriation bill.

The Senate amendments included changes to provide for a single appropriation line item, to provide an additional appropriation and authorization for up to 10 FTE employees, to provide for the North Dakota Building Authority to issue bonds for a Workers Compensation Bureau office building of up to \$14 million, to provide legislative intent regarding other state agencies' leasing of the Workers Compensation Bureau building, and to provide statutory changes regarding a building maintenance account and the compensation of Workers Compensation Bureau board members.

The Conference Committee has decided to adopt the Senate amendments with changes to remove the \$14 million limit on the office building project bonding authorization and to add an amendment to the North Dakota Century Code regarding contracts for Vocational Rehabilitation Services.

The decision whether to accede to the Senate amendments or recede from the Senate amendments depends on the type of further amendments to be made. If the new amendments change the Senate amendments, the appropriate method is to recede from the Senate amendments.

In this situation as the Conference Committee is proposing changing the Senate amendments (relating to the removal of the limit on bonding of \$14 million), the Conference Committee report should be for the Senate to recede from its amendments and further amend to include provisions of the Senate amendments agreed to by Conference Committee members and to make the additional two changes regarding the building financing limit and statutory provisions relating to Vocational Rehabilitation Services.

The request for bids must contain a detailed outline of services each vendor will be expected to provide. The accepted bid is binding upon both the bureau and the rohabilitation vendor. If additional services are determined to be necessary as a result of falled or inappropriate rehabilitation of an injured employee through no fault of the employee, the bureau may contract with the vendor for additional services. If the failure or inappropriateness of the rehabilitation of the injured employee is due to the vendor's failure to provide the necessary services to fulfill the contract, the bureau is not obligated to use that vendor for additional services on that claim and the bureau may refuse payment for a service that the vendor failed to perform which was a material requirement of the contract."

This authority of the industrial commission to issue evidences of indebtedness ends June 30, 2003, but the industrial commission may continue to exercise all other powers granted to it under chapter 54-17.2 and this Act and to comply with any covenants entered into before that date.



SECTION 4. BOND ISSUANCE REPAYMENT RESPONSIBILITY. Funding must be made available by the workers compensation bureau from non-general fund sources to be appropriated to the industrial commission to retire the evidences of indeptedness issued for the project costs associated with the construction of the project authorized by this Act

SECTION 5. LEGISLATIVE INTENT - WORKERS COMPENSATION BUREAU BUILDING - OTHER STATE AGENCIES LEASING. House Bill No. 1163 provides a special fund appropriation of \$761,600, including funding for one new FTE for expanding the safety grant program authorized by North Dakota Century Code Section 05-03-04.

House Bill No. 1187 provides a special fund appropriation of \$2,572,647, including funding for 25 new FTEs for binging contracted services in house.

Senate Bill No. 2134 removes the expiration date for the Workers Compensation Burnau scholarship fund that allows the Workers compensation Bureau to provide a scholarship for the spouse and dependent children of a worker who dies as the result of a pompensable work-related injury.

Senate Bill No. 2157 creates a single penalty section by combining penalty provisions in existing sections, creates a new section regarding decisions of the bureau, and identifies when an employer who defaults on a premium will be declared uninspeed.

Major Legislation Affecting the Workers Compensation Bureau

House Bill No. 1153 creates a new preferred worker program under which an approved preferred worker employer would not be assessed premiums on a preferred worker's salary for three years from the date of hiring, and any claims costs incurred as the result of an injury sustained by a preferred worker would be charged against the general fund. (This bill has been passed by the House.)

pouse Bill No. 1163 provides a special fund appropriation of \$761,600, including funding for one new FTE for expanding the safety grant program authorized by North Dakota Century Code Section 65-03-04. (The provisions of this bill were incorporated into House Bill No. 1024 and therefore this bill has been defeated.)

House Bill No. 1187 provides a special fund appropriation of \$2,572,647, including funding for 25 new FTEs for bringing contracted services in house. (The provisions of this bill were incorporated into House Bill No. 1024 and therefore this bill has been defeated.)

House Bill No. 1281 removes the Workers Compensation Bureau from the biennial appropriations process. (At the present time, the House has not yet taken final action on this bill.)

House Bill No. 1419 provides for a transfer of \$150,000 from the workers' compensation fund to the Insurance Commissioner to perform a workers' compensation insurance study. (At the present time, the House has not yet taken final action on this bill.)

Senate Bill No. 2134 removes the expiration date for the Workers Compensation Bureau scholarship fund that allows the Workers Compensation Bureau to provide a scholarship for the spouse and dependent children of a worker who dies as the result of a compensable work-related injury. (This bill has been passed by the Senate.)

Senate Bill No. 2157 creates a single penalty section by combining penalty provisions in existing sections, creates a new section regarding decisions of the bureau, and identifies when an employer who defaults on a premium will be declared uninsured. (This bill has been passed by the Senate.)

Good morning Chairman Wentz and Members of the Committee. My name is Dave Ystebo, and I am the Chairman of the North Dakota Workers Compensation Bureau's Board of Directors. Paul Kramer and Tammy Dolan will be providing an overview of the status of NDWC and an explanation of its 2001 – 2003 appropriation request. Prior to that, I would like to explain how the appropriation was developed and the approval process used by the Board of Directors.

The first goal of the Board of Directors was to meet Governor Schafer's hold-even budget directive. NDWC department managers were asked to evaluate their department's needs for the upcoming biennium They were told not to simply use prior expenditures as the base, but to start from zero and determine what would actually be needed based on planned activities, programs, etc. Once the hold-even budget goal was achieved, the Board also considered several proposals for additional FTE, new programs, etc. Initially there were 11 separate requests, each of which was studied and prioritized. As a result, three were eliminated. Another three were packaged and submitted in a separate bill, HB 1187. The remaining 5 were submitted to the Governor as optional adjustments, however, none were approved. Additionally, the Governor made adjustments to the hold-even budget initially submitted.

NDCC 65-02-03.3 gives the NDWC Board of Directors authority to "present testimony to the appropriations committees of the legislative assembly, requesting amendments to the budget to remove adjustments made by the governor." At its January 8, 2001 Board meeting, the Board directed NDWC staff to ask the appropriations committee to reinstate the governor's adjustments and two of the optional adjustments. Tammy Dolan will be presenting this request later this morning.

Speaking as the Chairman of the Board of Directors, you can be assured the Board as a whole studied every issue and did not submit any appropriation requests that are not critical to the continued improvement and operation of the North Dakota workers companyation are particular.

At this time Dick Johnsen, Chairman of the Board of Director's Audit Committee, will be discussing the comprehensive process the Board has in place to monitor and assess NDWC's status and progress towards established goals.




On behalf of Workers Compensation and its Board of Directors I would like to begin this presentation with a brief overview of the Bureau's activities during the past biennium.

One of the accomplishments that we are most proud of at Workers Compensation is the dramatic turn-around that has been made in our Fund status. In 1994, the Bureau was nearly bankrupt. Today, our Fund status is at a point that would allow all claims to be paid if, for some reason, we were forced to close our doors tomorrow.

At the same time as the Fund status was making its turn-around, NDWC has been able to make significant strides in reducing employer premiums, reducing work related injuries, increasing benefits, and containing medical costs while maintaining a favorable rating on customer satisfaction surveys conducted with injured workers and employers.

The following slides will provide more information on how the Bureau has been able to accomplish these tasks.









Good morning Chairman Wentz and Members of the Committee. My name is Tammy Dolan and I am the Vice President of Employer and Fiscal Services for the Workers Compensation Bureau. 1 will be presenting you with an explanation of the 2001 – 2003 appropriation request. A summary of the budget request appears below, as it was included in Governor Schafer's and Governor Hoeven's budget recommendations.

North Dakota Workers Compensation (NDWC) does not receive any State General Fund dollars; therefore, employer premiums fund the entire appropriation.

EXECUTIVE BUDGET RECOMMENDATION

Salaries and Wages

The recommended 2001-2003 budget includes \$16,972,674 to support the current staffing levels of 191 FTE, 6 Temps, and 10 Board Members. It also includes \$881,460, the Governor's recommendation for pay increases in the next biennium. This is the same funding level provided for other state agencies. However, NDWC employees do not receive the same across-the-board increases as other state employees. Salary increases are based on performance. The average increase for fiscal year 2000 was 5.0%.

To further solidify the independence of the Office of Independent Review (OIR) from NDWC's Claims Department, the Board of Directors authorized OIR to contract for advocacy services, rather than use NDWC employees. This decision resulted in a reduction of 2 FTE.

NDWC then requested that these 2 positions be transferred, and another 2 FTE be added, to its Information Services department. These 4 FTE would replace positions that are currently contracted through an outside vendor. The addition of 4 FTE, at a biennial cost of \$530.438, generated a savings of about \$1.1 million in the Operating Expense line.

NDWC relies heavily on its custom-developed software applications to provide the best possible service to injured workers, medical providers and North Dakota employers. As with any software application, improvements and enhancements are essential in order to keep up with the rapid change in technology. These positions are critical to NDWC success in this area.

The Executive Recommendation approved the FTE transfer but denied the 2 additional positions. Rather, they have included \$280,750 to continue contracting for 2 FTE. The \$280,750 is not adequate to pay for those contracted services. The cost associated with the 2 contracted FTEs is \$420,000 - about 50% more than the amount allowed in the Executive Recommendation, and more than 1½ times what it would cost to hire them as FTE.

At the reduced funding level, NDWC will have to reduce its Information Services consulting staff, which will negatively impact its to ability maintain and enhance its operating systems. This will affect NDWC's service to injured workers, employers, and medical providers. Therefore, NDWC, at the direction of its Board of Directors, respectfully requests that the House restore the original request by allowing 2 additional FTE, increasing Salaries and Wages by \$265,219 and decreasing Operating Expenses by \$280,750.

Operating Expenses

The recommended 2001-2003 budget of \$7,373,732 calls for a 9.3% reduction from the current biennium. Included in this line item is \$432,000 to cover ITD Data Processing costs, which are expected to rise 42%, based on projected ITD rates. These costs are necessary in order to connect our computers to the state system. The budget also includes \$476,044 for ITD Telephone expenses over the next two years.

The \$628,600 projected in IT Software and Supplies will cover expenses relating to the Oracle, Filenet, IBM AIX, and Great Plains software applications – all essential to NDWC customer service and efficient operations. Also included are toner, tape cartridges, compact discs, and other consumable items.

Continual improvement is demanded of all NDWC employees, as their pay depends on the quality of their performance. Therefore, NDWC is obligated to provide professional development opportunities for its staff. Over the next two years, we expect to spend \$436,390, \$2,285 per FTE, on professional development. This will allow NDWC to attract and retain high-quality employees, as well as maintain high employee morale.

The NDWC Board of Directors is considering constructing an office building. It is anticipated that construction would be completed by June 2002. At that time, NDWC would discontinue leasing its current office space in Bismarck. Therefore, no rent expenses are budgeted for FY 2003, resulting in a savings of \$466,000.

NDWC continues to contract for services essential to claims management; however, these costs are charged directly to the claims as allocated loss adjustment expenses (ALAE). If FTE could be utilized rather than contracts, a tremendous dollar savings would be realized. The problem is that the savings is "off-budget" rather than through the appropriation. A separate bill, HB1187, addresses this issue by requesting funding and FTE authority for 25 employees at a biennial cost of \$2.6 million. The projected net savings from this change would be \$4.2 million.



Equipment

The recommended 2001-2003 budget of \$1,354,057 provides for an increase of 4.0% over previous levels. \$1,156,657 - 85% of all equipment - is allocated for hardware purchases to maintain and enhance the information technology infrastructure that supports NDWC business applications. These systems are used to generate every employer billing, each injured worker payment, and every medical provider reimbursement. Some of the projected purchases are:

- replacing 4 IBM file servers for \$291,000
- replacing 3 Compaq file servers for \$95,000
- replacing 3 Uninterruptible Power Supplies (UPS) for \$100,000
- replacing 160 personal computers for \$240,000
- replacing 45 computer monitors for \$36,000
- replacing 15 network printers for \$34,500
- acquiring a shared disk drive system for about \$300,000

Two of the IBM file servers will support web development and application services. One Compaq file server will be dedicated to source control for application development in order to ensure the integrity of all business applications. NDWC's two major business applications - Claims Management System (CMS) and Policyholder Information Control System (PICS) - and its accounting system, Great Plains eEnterprise, are located on a client-server environment located on site at NDWC. Every employee has a personal computer that shares access through a Local Area Network (LAN).

The remainder of the funding, \$197,400, is reserved for office furniture as well as updating records management, image processing, mail processing, and loss prevention equipment.

Safety Partnership Grants

The 1999 Legislative Assembly appropriated \$600,000 for Safety Partnership Grants, with the goal of educating employers and employees to help prevent workplace injuries. Grants were awarded to four large employer group accounts in high-risk areas in order to serve the largest number of employees possible. These industries were allowed to customize their own specific safety program based on first hand experiences. The grants also served to enhance the partnership necessary between NDWC and employees working together for the benefit of North Dakota employees.

The recommended 2001-2003 budget continues this funding and enhances it by 5.0% to \$630,000. A separate bill, HB1163, seeks to expand this program by doubling the grant funding to \$1.26 million. As was shown earlier in Paul Kramer's portion of the presentation, NDWC is seeing a significant reduction in work place injuries, which we feel merits the continuation and expansion of such safety initiatives.

BOARD OF DIRECTORS ADJUSTMENT REQUEST

In addition to the hold even budget request, as required by the Governor, NDWC submitted 5 optional adjustments, none of which were approved. At the direction of the Board of Directors, we respectfully request the following two optional adjustments be added to the NDWC 2001-2003 biennial appropriation:

Addition of 1 FTE - Human Resource Specialist

NDWC employees are not "classified" like other State employees. As a result, NDWC staffs and maintains its own Human Resources (HR) department. The department is responsible for developing, implementing and monitoring personnel, compensation, and performance appraisal policies and procedures. The department also develops job descriptions for each position, coordinates the hiring of new employees, conducts training, assists with personnel actions, and provides any other human resource support needed.

The industry standard is to have at least one human resource professional, excluding administrative support, for every 100 employees. Currently, the NDWC HR department consists of one manager and one administrative assistant and serves approximately 200 employees – as a result our staff to employee ratio is only half the recommended standard.

NDWC is required by NDCC 65-02-30 to conduct an independent performance evaluation every biennium. The most recent evaluation was completed in September 2000 by The Hays Group of Minneapolis, Minnesota. The Hays Group specializes in workers compensation consulting. One of their recommendations was to increase staffing in the HR department. The Hays Group stated, "We understand that the current human resources department at North Dakota Workers Compensation consists of one [professional] person. Considering the size of NDWC, we believe it is important NDWC expand their human resource staff. We feel it is important that NDWC increase their human resource staff to support supervisory and management positions, so that all human resource functions are being handled in a professional and consistent basis."

While the addition of 1 FTE increases the budget request by \$102,017 in the next biennium, it allows NDWC to efficiently maintain all the employee programs, records, and projects necessary for an organization of its size.

Addition of 1 FTE - Special Investigator

•

Currently, NDWC's Special Investigation Unit (SIU) contracts with approximately 15 external private investigative agencies each year. Special investigators are crucial to managing increasing investigative caseloads, controlling and containing incurred costs, and stopping fraudulent activities of employers, providers, and injured workers. Adding 1 FTE will increase the appropriated budget by \$129,170 in the 2001-2003 biennium; however, it will save \$187,200 of contracted expenses currently paid "off-budget." These costs are specific to certain claims and are paid through a continuing appropriation. This is a net savings of \$58,030 over the next two years.

In addition, two technological fraud detection systems are scheduled for implementation during the fourth quarter of 2001 and will generate additional fraud cases for investigation. These two advanced detection systems are estimated to increase the current investigative caseload by approximately 33%. Therefore, it is pivotal for NDWC's continued financial and economic success to acquire another fraud investigator at this time.

Appendix A is attached and reflects how the NDWC 2001-2003 biennial appropriation will appear after considering the Board's requested adjustments.

TESTIMONY TO THE HOUSE APPROPRIATIONS COMMITTEE Prepared January 12, 2001 by the North Dakota Association of Counties Michael W. Wolf, County Employer Group Manager

CONCERNING HOUSE BILL NO. 1024

Madam Chair, members of the committee. Good morning, my name is Michael Wolf and I am the Manager of the County Employer Group (CEG) for the North Dakota Association of Counties (NDACo). Thank you for allowing me the opportunity to appear before you today. I am here today testifying in support of HB1024 as it relates to the Safety Partnership Grants.

Through a cooperative effort with North Dakota Workers Compensation (NDWC), the North Dakota Association of Counties formed the County Employer Group in 1996. The CEG Program resulted in the consolidation of 53 individual county workers compensation accounts into a single account. There are currently over 6,000 employees covered under the CEG Program and the County Employer Group is the largest single workers compensation premium payer in North Dakota.

In 1999, the North Dakota Associations of Counties applied for and was fortunate enough to receive a Safety Partnership Grant from North Dakota Workers Compensation. The Safety Partnership Initiative was an exciting new concept introduced by NDWC to promote safety in high-hazard industries. The fundamental objective of the initiative was to direct loss prevention resources towards specific industries that were causing significant losses to North Dakota Workers Compensation and thereby reduce those losses.

The focus of the partnership grant for the North Dakota Association of Counties was to designate an Internal Claims Manager to manage all claims and develop an aggressive transitional work program. Prior to January 1, 2000, the County Employer Group had done a very good job in implementing an effective risk management program. However, once an injury occurred, there was no mechanism in place to manage the claims or any organized return to work effort. As a result, NDWC and NDACo saw a dramatic increase in claims costs. Annual claims costs of \$396,096.90 in 1997 increased to \$647,332.36 in 1998. Since the CEG was formed in 1996, average annual claims losses have been approximately \$445,820.

On January 1, 2000, as part of the Safety Partnership Grant, the NDACo hired Jennifer Morman as the Internal Claims Manager to manage all components of medical and lost time workers compensation claims. Her specific tasks include managing the medical care for each new injury and to work closely with the injured worker, their medical provider, and their supervisor to accommodate meaningful and medically appropriate return to work options. Jennifer was also directed to manage the medical care for all injuries that had occurred over the past 5 years and determine if return to work options were possible for those injured workers who were still off the job. The result of having a dedicated Internal Claims Manager on staff has been phenomenal. According to our latest loss run we received earlier this week, total claims costs for calendar year 2000, including future reserves are a mere \$49,384.41. The keys to our success are a result of focused efforts on early reporting, increased communication with medical providers, additional training opportunities for county risk managers, employee involvement, and pro-active return to work strategies.

Here is one of many examples of how being actively involved in the claims process and the return to work process can benefit NDWC and North Dakota employers:

- 35-year old male; Injured 11/8/00
- Serious snow-plow rollover accident
- 3 broken ribs, punctured lung, separated shoulder, multiple lacerations and muscle sprains
- Extended hospital stay
- Physical therapy
- We personally met with the treating physician to determine the employees capabilities
- We personally met with physical therapist
- We personally met with injured employee and his wife
- Worked directly with county risk manager and county department heads to identify a meaningful job within the employee's restrictions
- Employee returned to modified sedentary full-time duty on January 2, 2001
- Without intervention, we feel this employee would still be off work.

I am happy to inform you that all county employees injured in 2000 are back at work, continue to be productive, and they remain a valuable resource to their county. The reality of having all injured employees back at work would be highly unlikely without the assistance we have received as a participant in the Safety Partnership Grant. As part of the safety partnership grant, NDACo is also in the process of developing a model transitional work program. Extensive work has already been done in Cass County and Stutsman County conducting a job task analysis for each position and identifying transitional job opportunities. Having pre-defined transitional jobs lends credibility to both the employee and the medical community. The transitional work program is unique in that we focus on an injured employee's capabilities, not their disabilities. Once fully developed, this state-of-the-art program will serve as a model that can be shared with other employers throughout the state.

We truly believe that without the support of the Safety Partnership Grant, NDWC and NDACo wouldn't have seen such a dramatic decrease in claims related costs this past year. Our Association urges your support of the bill with a "do pass" recommendation. Thank you. I will attempt to answer any questions you may have.

ENGROSSED HOUSE BILL No. 1024

Fifty-Seventh Legislative Assembly Before the Senate Appropriations Committee, February 21, 2001 Testimony Regarding Workers Compensation Appropriation

Good morning, Chairman Nething and members of the Senate Appropriations Committee: My name is Dick Johnsen and I am the Chairman of the Audit Committee for the North Dakota Workers Compensation Board of Directors. I am here today to testify in support of Engrossed House Bill No. 1024.

In preparing this appropriation request, the first goal of the Board of Directors was to meet Governor Schafer's hold-even budget directive. Once the hold-even budget goal was achieved, the Board considered several proposals for additional FTE, new programs, etc. Of those additional proposals, only the programs that are critical to the continued improvement and operation of the North Dakota workers' compensation system were brought forward for consideration.

The House of Representatives approved House Bill No. 1024 as amended by a vote of 76 to 21 with 1 absent and not voting. The bill as approved by the House provides \$31.14 million to defray the expenses for the upcoming biennium. It includes funding for salaries and benefits for the existing 191 FTE. It also grants the authority to hire an additional fraud investigator. It expands the funding for the safety grant program to approximately \$1.2 million per biennium and gives NDWC the authority to hire one FTE to administer the safety grants. It also allows NDWC to hire 25 additional FTE to bring some contracted services in-house, which will actually save an estimated \$4.2 million over the next two years.

The Board takes the responsibility of the appropriations process very seriously. Through its governance policies, the Board has established a comprehensive system of monitoring the status of the workers' compensation fund and the results of the agency's operations. The Audit Committee, which consists of three Board members, meets quarterly to review all monitoring documents, which include updates on financial audit results, performance evaluation

recommendations, progress toward established goals, investment activity, and the results of operations.

Operational results are measured by a set of defined benchmarks called Outcomes. These outcomes are established to reflect the most critical aspects of each major NDWC department. Examples of the Outcome Monitoring Report contents are attached to my testimony. Through this document the Board is able to see results over a period of time. From this, both positive and negative trends can be identified and corrective actions taken if necessary.

I believe the criteria used for monitoring the fund have proven to be an excellent tool to ensure the bureau operates within its appropriation. On behalf of the entire Board of Directors, I strongly encourage you to approve the funding level and FTE level presented to you this morning.

Utilization Review

Utilization review (UR) is the determination of the necessity appropriateness and efficiency of clinical services rendered to patients for the management of specified clinical conditions. Under utilization review, the use of health care services for a specific patient is compared to an established norm concerning similar services for comparable patients. Providing an unnecessary service is not only costly, it can actually harm individuals who receive the care.

NDWC's UR department conducts pre-service reviews for the following services:

Physical Therapy beyond the first 10 treatments or 30 days High-tech imaging (CT scans, MRIs, myleograms, discograms) In-patient hospital stays Surgical procedures Therapeutic Injections

The goals of UR include:


- Ensuring that the treatment provided to injured workers is medically necessary and appropriate
- Improving the quality of care by promoting timely access to health care
- Preventing unnecessary services or treatment
- Facilitating positive outcomes for recovery and early return to work

Medical providers (even designated medical providers) are required to contact the UR department to precertify care prior to performing the services. Providers can initiate a review by phone or fax. If the care is performed on an emergency basis, the provider is required to contact UR on the next business day.

The UR nurse makes a recommendation as to the medical necessity of the proposed services. The UR nurse reviews the medical records and information given by the medical provider. The medical director is consulted whenever care does not appear to meet the standards for medical necessity. The UR nurse notifies the provider of the recommendation (medically necessary or not) by phone within 24 hours of receiving the medical information required to complete the review. The nurse also generates a letter outlining the UR recommendation and rationale. The letter is sent to the medical provider and a copy is mailed to the injured worker. If services are not recommended as medically necessary, the provider has 30 days in which to appeal the recommendation. The medical director reviews appeals.

Performing UR services on-site at NDWC is beneficial because the UR staff has direct access to the Claims computer and imaging systems. Providers do not have to send their medical records to the UR department if they have already submitted them to the Claims department. The Claims staff and UR staff

ENGROSSED HOUSE BILL 1024

Fifty-Seventh Legislative Assembly Before the Senate Appropriations Committee February 21, 2001 Testimony Regarding Workers Compensation Appropriation

Good morning Chairman Nething and Members of the Committee:

My name is Tammy Dolan and I am the Vice President of Employer and Fiscal Services for the Workers Compensation Bureau. I will be presenting you with an explanation of the 2001 - 2003 appropriation request. A summary of the budget request appears below, as passed by the House of Representatives.

North Dakota Workers Compensation (ND'WC) does not receive any State General Fund dollars; therefore, employer insurance premiums fund the entire appropriation.

Each line item will now be explained in greater detail.

Salaries and Wages

Engrossed House Bill 1024 includes the Governor's recommendation of \$16,972,674 to support the current staffing levels of 191 FTE, 6 Temps, and 10 Board Members and an additional \$881,460 for current staff pay increases in the next biennium, which is the same funding level provided for other state employees. The House also approved funding in the amount of \$2,494,117 for 27 additional FTE. Of the 27 new positions, 25 positions will be used to bring contracted personnel in-house as employees, as recommended by The Hays Group in their 2000 independent performance evaluation of NDWC operations.

NDWC presently contracts with several vendors to provide a multitude of services. Contractors providing utilization review, medical bill audit and medical bill entry are already located within the NDWC Bismarck office. Some medical case managers and vocational rehabilitation counselors work in NDWC field offices throughout the state, while others work from their homes. These services cost the workers compensation fund approximately \$3.4 million each year, or \$6.8 million per biennium. Bringing these on as FTE will save an estimated \$4.2 million during the 2001-2003 biennium.

Since the program services provided are directly related to specific claims, these costs are paid through a continuing appropriation as allocated loss adjustment expenses. This is the same manner in which wage loss and medical benefits are tracked. Claims and claims related expenses (which are 90% of total annual costs) are reflected on the NDWC profit and loss statement, not in the biennial appropriation request, which only includes administrative expenses. Therefore, the savings generated by this change, while not evident in the appropriation, will appear as a reduction to the claims expenses reported in the NDWC annual financial statements.

It is important to remember that NDWC does not receive any general fund support. All costs, whether appropriated or not, are paid for with employer premium dollars. Each dollar saved is directly reflected in the rates charged to employers for workers compensation insurance. As determined by the NDWC consultant actuary, a \$4.2 million savings would decrease premium rates by 1-2% annually.

The House also approved the addition of 1 FTE Special Investigator in NDWC's Special Investigation Unit (SIU). Currently, SIU contracts with approximately 15 external private investigative agencies each year. Special investigators are crucial to managing increasing investigative caseloads, controlling and containing incurred costs, and stopping fraudulent activities of employers, providers, and injured workers. Adding 1 FTE will increase the appropriated budget by \$129,170 in the 2001-2003 biennium; however, it will save \$187,200 of contracted expenses currently paid "off-budget." These costs are specific to certain claims and are paid through a continuing appropriation. This is a net savings of \$58,030 over the next two years.

In addition, two technological fraud detection systems are scheduled for implementation during the fourth quarter of 2001 and will generate additional fraud cases for investigation. These two advanced detection systems are estimated to increase the current investigative caseload by approximately 33%. Therefore, it is pivotal for NDWC's continued financial and economic success to acquire another fraud investigator at this time.

The existing Safety Partnership Grant Program was doubled by the House of Representatives. As the grant program expands, the staff time required to administer the program and to monitor and support grantee activity will grow from a part-time to a full-time job. Therefore, they added 1 FTE for a program coordinator for the 2001-2003 biennium.



Operating Expenses

Engrossed House Bill 1024 approves \$8,114,732 in Operating Expenses for the 2001-2003 biennium. Included in this line item is \$432,000 for ITD Data Processing costs, which are expected to rise 42%, based on projected ITD rates. These costs are necessary in order to connect our computers to the state system. The budget also includes \$503,244 for ITD Telephone expenses over the next two years.

The \$628,600 projected in IT Software and Supplies will cover expenses relating to the Oracle. Filenet, IBM AIX, and Great Plains software applications – all essential to NDWC customer service and efficient operations. Also included are toner, tape cartridges, compact discs, and other consumable items.

NDWC relies heavily on its custom-developed software applications to provide the best possible service to injured workers, medical providers and North Dakote employers. As with any software application, improvements and enhancements are essential in order to keep up with the rapid change in technology. Therefore, NDWC is budgeting \$1,520,614 for IT Contracted Services in the next biennium, down \$1,046,886, or 40.8%, from the 1999 – 2001 level.

Continual improvement is demanded of all NDWC employees, therefore, NDWC expects to spend \$457,390, \$2,098 per FTE, on professional development. This will allow NDWC to attract and retain high-quality employees, as well as maintain high employee morale.

The House also amended the bill to add back \$466,000 in office rent for the Bismarck office in the second year of the biennium. These dollars were originally cut from the budget in order to meet the Governor's Hold Even request but are necessary to provide office space for the 2002 – 2003 fiscal year. This amendment brings the total function for rent/lease expense to \$1,247,801 for the biennium. NDWC Board of Directors has recently approved the construction of an office building with an anticipated completion date of December 2002.

Equipment

- replacing 4 IBM file servers for \$291,000
- replacing 3 Compaq file servers for \$95,000
- replacing 3 Uninterruptible Power Supplies (UPS) for \$100,000
- replacing 160 personal computers for \$240,000
- replacing 45 computer monitors for \$36,000
- replacing 15 network printers for \$34,500
- acquiring a shared disk drive system for about \$300,000

Two of the IBM file servers will support web development and application services. One Compaq file server will be dedicated to source control for application development in order to ensure the integrity of all business applications. NDWC's two major business applications - Claims Management System (CMS) and Policyholder Information Control System (PICS) - and its accounting system, Great Plains eEnterprise, are located on a client-server environment located on site at NDWC. Every employee has a personal computer that shares access through a Local Area Network (LAN).

Also included is \$64,300 in equipment and furniture for the 27 additional FTE. The remainder of the funding, \$197,400, is reserved for office furniture as well as updating records management, image processing, mail processing, and loss prevention equipment.

Safety Partnership Grants

Engrossed House Bill 1024 approves \$1.260,000 for the 2001 – 2003 biennium, twice the 1999 – 2001 level. The 1999 Legislative Assembly appropriated \$600,000 for Safety Partnership Grants, with the goal of educating employers and employees to help prevent workplace injuries. NDWC solicited proposals from interested employee and employer organizations to assist in providing less prevention services. NDWC received 15 proposals from various groups requesting over \$1.0 million. Since only \$600,000 was appropriated for the grant program, NDWC selected those projects that offered the most potential to reduce losses. Grants were awarded to four large employer group accounts in high-risk areas in order to serve the largest number of employees possible. These industries were allowed to customize their own specific safety program based on first hand experiences. The grants also served to enhance the partnership necessary between NDWC and employers working together for the benefit of North Dakota employees.

The additional funding will increase the scope of the grant program by encouraging innovation and aggressive new methods to combat serious old problems. Funding may provide for the purchase of safety equipment (e.g. mechanical lifts in nursing homes), professional training or seminars, or any new method to prevent or manage occupational injuries. NDWC will closely monitor each project and account for every premium dollar spent. Benchmarks will be established to measure performance and statistical analysis will be conducted to quantify results.

The effectiveness of any safety initiative oftentimes takes years to become evident. We do not yet have a complete set of data to quantify the effectiveness of these programs. However, the most important ingredient to success in safety may be awareness. The more people hear about safety and talk about safety, the more they will practice safety. The Safety Partnership Grant program focuses safety where it is needed most – in those industries that experience the most accidents. Awareness of the importance of occupational safety and health has never been greater, and over time this should prove to reduce injuries in North Dakota workplaces.

There are already some encouraging signs. In the five-year period from 1995-1999, the North Dakota Association of Counties averaged \$446,000 in yearly claims costs. In 2000, their total claims costs were \$49,400 based on data valued at year-end. Some of the credit for this positive trend must be attributed to their safety program and aggressive claims management, both of which were significantly enhanced by being the focus of their Safety Partnership Grant.

The overall success of NDWC's investment in loss prevention is evident. In 1994 there were 3,745 lost time claims accepted by NDWC. That important statistic has declined steadily to 2,646 in 2000. This is a drop of nearly 30% over 6 years and represents a savings to the system of millions of dollars. It affects not only the health of thousands of individual workers, but the economic health of the entire state. It has also been an important factor in the reduction of rates each of the last six years. Engrossed House Bill 1024 allocates \$1,260,000 to continue and expand this funding.

Mr. Chairman, members of the committee. Good morning, my name is Michael Wolf
and I am the Manager of the County Employer Group (CEG) for the North Dakota
Association of Counties (NDACo). Thank you for allowing me the opportunity to
appear before you today. I am here today testifying in support of HB1024 as it relates to
the Safety Partnership Grants.

Through a cooperative effort with North Dakota Workers Compensation (NDWC), the North Dakota Association of Counties formed the County Employer Group in 1996. The CEG Program resulted in the consolidation of 53 individual county workers compensation accounts into a single account. There are currently over 6,000 employees covered under the CEG Program and the County Employer Group is the largest single workers compensation premium payer in North Dakota.

In 1999, the North Dakota Associations of Counties applied for and was fortunate enough to receive a Safety Partnership Grant from North Dakota Workers Compensation. The Safety Partnership Initiative was an exciting new concept introduced by NDWC to promote safety in high-hazard industries. The fundamental objective of the initiative was to direct loss prevention resources towards specific industries that were causing significant losses to North Dakota Workers Compensation and thereby reduce those losses. ł

The focus of the partnership grant for the North Dakota Association of Counties was to designate an Internal Claims Manager to manage all claims and develop an aggressive transitional work program. Prior to January 1, 2000, the County Employer Group had done a very good job in implementing an effective risk management program. However, once an injury occurred, there was no mechanism in place to manage the claims or any organized return to work effort. As a result, NDWC and NDACo saw a dramatic increase in claims costs. Annual claims costs of \$396,096.90 in 1997 increased to \$647,332.36 in 1998. Since the CEG was formed in 1996, average annual claims losses have been approximately \$445,820.

On January 1, 2000, as part of the Safety Partnership Grant, the NDACo hired an Internal Claims Manager to manage all components of medical and lost time workers compensation claims. Specific tasks include managing the medical care for each new injury and to work closely with the injured worker, their medical provider, and their supervisor to accommodate meaningful and medically appropriate return to work options. The Claims manager was also directed to manage the medical car for all injuries that had occurred over the past 5 years and determine if return to work options were possible for those injured workers who were still off the job. The result of having a dedicated Internal Claims Manager on staff has been phenomenal. According to our latest loss run we received from Workers Compensation, total claims costs for calendar year 2000, including future reserves are a mere \$49,384.41. The keys to our success are a result of focused efforts on early reporting, increased communication with medical providers, additional training opportunities for county risk managers, employee involvement, and pro-active return to work strategies. In 1995, county employee's missed 5,320 work days as a result of workplace injuries. In calendar year 1999, when the first focus on claims management began, county employees missed 611 days of work due to workplace injuries and in calendar year 2000, there were only 185 missed workdays. This dramatic turnaround is a direct result of active claims management.

Here is one of many examples of how being actively involved in the claims process and the return to work process can benefit NDWC and North Dakota employers:

- 35-year old male; Injured 11/8/00
- Serious snow-plow rollover accident
- 3 broken ribs, punctured lung, separated shoulder, multiple lacerations and muscle sprains
- Extended hospital stay
- Physical therapy
- We personally met with the treating physician to determine the employees capabilities
- We personally met with physical therapist
- We personally met with injured employee and his wife
- Worked directly with county risk manager and county department heads to identify a meaningful job within the employee's restrictions
- Employee returned to modified sedentary full-time duty on January 2, 2001
- Without intervention, we feel this employee would still be off work.

I am happy to inform you that all county employees injured in 2000 are back at work, continue to be productive, and they remain a valuable resource to their county. The reality of having all injured employees back at work would be highly unlikely without the assistance we have received as a participant in the Safety Partnership Grant.

As part of the safety partnership grant, NDACo is also in the process of developing a model transitional work program. Extensive work has already been done in Cass County and Stutsman County conducting a job task analysis for each position and identifying transitional job opportunities. Having pre-defined transitional jobs lends credibility to both the employee and the medical community. The transitional work program is unique in that we focus on an injured employee's capabilities, not their disabilities. Once fully developed, this state-of-the-art program will serve as a model that can be shared with other employers throughout the state.

We truly believe that without the support of the Safety Partnership Grant, Workers Compensation and NDACo wouldn't have seen such a dramatic decrease in claims related costs this past year. Our Association urges your support of this bill with a "do pass" recommendation. Thank you. I will attempt to answer any questions you may have.

2-21-01 STATEMENT BY CHUCK PLTERSON, REPRESENTING GNDA, REGARDING HB 1024 WORKER'S COMPENSATION LEGISLATION.

Chairman Nething and members of the Senate Appropriations Committee. I am Chuck Peterson, a member of GNDA, and a North Dakota businessman. Thank you for the opportunity to provide testimony in support of HB 1024.

The Greater North Dakota Association is the voice of business and the principle advocate of positive change in North Dakota. As a member of GNDA we represent over 1000 business and professional organizations from all areas of North Dakota. GNDA is governed by a 25 member Board of Directors elected by our membership.

I also speak for the Associated General Contractors, the North Dakota Petroleum Council, the North Dakota Retail Petroleum Marketers Association, the North Dakota Motor Carriers Association, the Automobile Dealers and Implement Dealers Association, North Dakota Grocers Association, the Bismarck-Mandan Chamber of Commerce, and the North Dakota Hospitality Association.

We have reviewed the changes contained in HB 1024. Our understanding of this legislation is as follows:

Add 25 full time employees to cover those in contract service Add 1 full time employee to the special investigation unit Add one safety coordinator Increase the number of Safety Grants from 4 to 8 for a cost of \$1.26 million.

We believe this is good legislation and should receive favorable consideration. From the time that I have been aquatinted with the Bureau, I have viewed the cost of contract service as a poor utilization of worker compensation funds. Third party companies charge as much \$50.00 to\$60.00 per hour for employees who receive salaries \$20,000 to \$30,000 per year. This provides a poor alternative to hiring and training a full time employee.

Eliminating contract services will give the Bureau control of the rehabilitation and return to work function, case management, and utilization review, and bill audit. It will also make the Bureau more accountable, rather than farming out these important functions to firms located out side the state. When I have heard complaints from injured workers, it has often been made concerning the service provided in rehabilitation and return to work. We believe that bringing these functions in house will provide better service to the injured workers at less cost.

The Safety Partnership Initiative has been very successful program. The Bureau has been able to target high-risk industries. They have put trained staff in the field where it will have the most benefit.

The feed back from associations that have partnered with the Bureau has been positive. There has been a strong commitment to continue. I have been very satisfied with the service the motor carrier industry has received from Carl Berg, our safety coordinator. We have a knowledgeable, professional available when and where we need him.
