Vice-Chairman Brusegaard: We will now open the hearing on HB1374.

Rep. R. Kelsch: (District 34) *Introduced the bill*

Rep. Nottestad: I think this is a fabulous idea. I remember during WWII, our teacher would have us go down to the church when bodies were brought back, and the impact it made on us. Is there anyway, in this bill, for families of those killed in action, who would not have received an honorable discharge, to be eligible for the family to receive this?

Rep. Kelsch: The way it's written, it would only mean that an eligible veteran had been deceased, their family may request it. My guess is, that would seem like an honorable discharge

in my mind. If they were serving in the line of duty, and they were killed, that's going out the way most of us would want to.

Sen. O'Connell: (District 6) *Co-signer spoke in support of the bill*

Rep. Mueller: *Co-signer spoke in support of the bill*

Arnold Maier: (DAV) In 1941, I got to meet a lot of young men my age. Some of these men couldn't go to high school, because they had to be in the war. Myself, I was very fortunate. My father made a promise that his family would all have high school education. In turn, he hired a man to help with the farm work, so his children could go to school. Once, he paid ten dollars a month, another time, he paid board and room. HB1374 was drafted after it was done in MN. The VFW got a hold of it, researched it and brought it back, and they got a unanimous approval from the council to pursue this bill to give victims of WWII a diploma. As a veteran, I urge you strongly to support this bill.

Ron Otto: (Morton County Veterans Service Officer) *Please refer to written testimony*

Rep. Thoreson: Just a point of clarification. The bill says that, prior to completing high school.

Does that mean they had to have started?

Otto: What the bill is stating is that if they were in high school and they went into the service.

Rep. Thoreson: Do you think some of the people who didn't go onto high school, because he had to work on the farm. He wouldn't be eligible.

Otto: What I think the amendments will show is those WWII veterans who served in the armed services during WWII will be granted the honorary high school diploma.

<u>Wayne Sanstead:</u> (State Superintendent of Public Instruction) This has references to the department. As has been indicated, this is a novel piece of legislation that's passed elsewhere.

Two question on the dates was interesting to me. You recall that the element of war was appearing on the horizon prior to Dec. 7, 1941. As a result, units were being ordered to active duty by the War Department, so they decided that the most ready units in the entire nation of the reserved forces of that time were found in ND and MN. The more capable, those ready to be put into action. They were immediately deployed in the Philippine Islands. I believe school districts will want to use this piece of legislation. We don't feel that there will be a fiscal need after a few phone calls and things.

Bob Hanson: (NDVCC) I was asked by the School Board's Association, NDEA, and the Administrators to say they are all in support of this bill as well. Does it apply to veterans who were not in high school? Yes. This is just one small token of how we can say to them thank you. Vice Chairman Brusegaard: We will now close the hearing on HB1374.



Minutes: CHAIRMAN FREBORG called the committee to order on 2/28/01.

Roll Call was taken with 6 present, 1 absent (Sen. Flakoll).

CHAIRMAN FREBORG called the hearing on Engrossed HB 1374, relating to honorary high school diplomas for veterans; and to declare an emergency.

Testimony in support of HB 1374:

REPRESENTATIVE RAE ANN KELSCH. District 34, spoke in support of the bill. She stated this bill as amended allows for schools districts, or the Superintendent of Public Instruction if the school district does not wish to do so, to grant an honorary high school diploma to any honorable discharged WWII veteran who does not have one. This is for ND veterans only. We recognize the sacrifices of WWII veterans and this allows them to receive an honorary high school diploma when they were unable to obtain one before they went off to war. The families of honorably discharged veterans can also request a diploma, either for a living or deceased family member. This also applies to those who dropped out of school to go to war.

WAYNE SANSTEAD, Superintendent of Public Instruction, supports the bill. He feels the local school district should make the decision to grant an honorary diploma to a veteran, otherwise DPI can.

RAY HARKEMA, North Dakota Veteran's Affairs, stated they are prepared to work with DPI and the county Service Officers. He foresees no problems in verifying the veterans. North Dakota had 69,000 WWII veterans and they are passing away at an alarming rate now, RON OTTO, Morton County Veterans Service Officer, presented prepared testimony, (see attached).

BOB HANSON, ND Veterans Coordinating Council, which represents the five veteran's organizations, unanimously supports this legislation. He also feels the local school districts should make the decision. SENATOR O'CONNELL asked how many other states do this. Mr. Hanson stated maybe five. Minnesota and Nebraska are two.

There being no opposition, the hearing on HB 1374 was closed.

SENATOR KELSH moved a DO PASS. Seconded by SENATOR CHRISTENSON.

SENATOR COOK wondered if there should be a reference that the veteran attended a ND school. SENATOR CHRISTENSON answered that it seems that intent is implied in the bill.


