Minutes: Rep. Weisz - Chairman opened the hearing on HB 1443; A BILL for an Act to create and enact a new subsection to section 39-06.1-06 of the North Dakota Century Code, relating to speed limit fees; and to amend and reenact subsections 3 and 8 of section 39-06.1-06, paragraph 30 of subdivision a of subsection 3 of section 39-06.1-10, and subsection 1 of section 39-09-02 of the North Dakota Century Code, relating to speed limits.

Rep. Porter: For the record Representative Porter represents District 34, pt. Of Morton Co. This bill is actually designed to people back their drivers license. When I was here earlier with the HCR talking about the point system and how it has evolved over the years -- I then had a bill drafted and in that process I talked to Rep. Weisz and Rep. Jensen and came up with their feeling on several sections reflected in this bill. The first section under the speeding section Rep. Jensen: Wanted introduced and the section follows to the amendments of the points which is my concern. I felt that the point system is antiquated and I feel that a person should be given a up to 10 mph of a fine only an the point system kick in after that. Section 4 of this bill is the section

Rep. Weisz wanted introduced and I imagine Rep. Schmidt. This part of the bill changes the speed limits. It takes away the night time provisions on 2 lane road so that those roads become 65 mph at night -- 24 hrs per day. It also raises the speed limit on the interstate from 70 to 75 mph. Rep. Jensen: (270) I am from District 17 and I am also a sponsor on this bill. The part of this bill that I have an interest in is the part that raises the speeding tines. I have over the years noted that state like South Dakota and Minnesota charge considerably more for their speeding fines than ND. I have a dual point here I believe that higher speeding fines are a deterrent to speeding and if not they produce more money. Last session we had a fiscal note on this that said it could raise as much as \$1.25 million.

Rep. Mahoney; (355) How do we compare with other states in the midwest in the level of fines for speeding?

Rep. Jensen: (402) We had data last time that said almost every state was higher than ND.

Rep. Kelsch: (453) I know that 18 years ago 11mph over the speed limit was a \$40 fine.

Rep. Ruby: (478) Would the passing of this bill mean we no longer need HCR 3005?

Rep. Jensen: I don't know they would get the same results with the study.

THERE WAS NO OTHER SUPPORT OR OPPOSITION TESTIMONY FOR HB 1443.

NEUTRAL TESTIMONY:

Kent Olson: I am Director of the PIA of ND. We are the auto insurance agents around the state. We deal with the driver record, points, violations -- we have a concern-- we watch bills that come in on driving records, speeding violation, etc. --- we are always concerned about safety. A personal observation and recommendations would be on the fines - start at \$30 - \$40 it is a user fee -- I will slow down at \$40 but I don't for the Montana \$5 fine. Points are a concern to

insurance to people -- because you will notice that if you collect 3 - 4 - 5 - 6 points you are going to have a problem with your insurance. On page 3 it lowers the excess by 5 mph and this is good because it is going to add the points and it is a safety issue. You will notice that on line 5 it increases the 6 pointers to 10 point-- that is a serious violation. So you are going to have a high fine and lots of points --- that should be a pretty good deterrent. I know there will a Question about signing costs but I would say that the user fee -- revenue builder above the signing cost -- but the safest road in the country is the interstate system and we go 10 mph on that and on the poorer gravel roads 15 mph and a lesser fine and that is not as safe a highway system. We want you to know we are looking at points and safety issues.

There being no further testimony. The hearing was closed. (797).
