Minutes: <u>Rep. Weisz - Chairman</u> opened the hearing on HCR 3005 - a concurrent resolution directing the Legislative Council to study the fees and point demerits for traffic offenses. <u>Rep. Porter</u> (940) sponsor of House Concurrent Resolution 3005 stated for the record that he had no points assessed against his drivers license nor has he ever had. The main reason that he(Rep. Porter) sponsored this resolution is a disparity in the point system as it now exists. Mainly in the highway system --- our best highways namely I-94 and I - 29 --- are posted at 70 mph and if you drive 6 mph over the posted speed limit you loose one point off your drivers license. If you take the two lanes roads which are our most dangerous roads ---- where people have to pass into oncoming traffic they have the leeway of 14 mph before they loose any points off their drivers license. This doesn't make any sense to have this disparity. I have another bill which I will be introducing which will allow up to 10 mph on the highway system including the two lane Page 2 House Transportation Committee Bill/Resolution Number HCR 3005 Hearing Date 11, 2001

highways and the Instate System with no points lost. With 11 mph over the posted speed limit you would loose 1 point. Once I introduced the bill, Senator Stenehjem wanted to sign on from the transportation standpoint the point system has not been looked at since 1971. We think its a good time to look at the whole point system. That is how this Resolution came about.

<u>Rep. Weisz - Chairman</u> (1138) called for any questions of Rep. Porter or whether there was anyone else who wanted to appear on behalf of the Resolution. No one appeared in opposition. The hearing for testimony was closed.

Committee discussion followed. (Tape 1 Side 1 meter about 1863).

Rep. Price moved a 'Do Pass" for HCR 3005.

<u>Rep. Carlson</u> seconded the motion.
