### Minutes:

The hearing was opened on SB2055: Composition of the North Dakota Library Coordinating Council.

SENATOR SOLBERG: spoke in favor of SB2055. Senator represent Pierce, McHenry and the southeastern part of Ward County. Local librarian contacted me. Do you remember the last section that we redid the State Library Board and went to a ten member board and they have now after two years and they have now after two years of operation, as I understand it, asked to change that to eleven member board, add one citizen at large. SENATOR FLAKOLL, now I notice that that one person is to be added to the citizen at large, why was that selected?

SENATOR SOLBERG, I don't know. I think they wanted a little bit more input, a little more balance on the board. As I understand they wanted some more balance, more citizen input in the board. CINDY LARSON: ND State Library, See written testimony. Felt one more citizen member would better represent the citizens of the state on member issues, SENATOR COOK:

Cindy, you are a board member you said? CINDY, No, I am not a board member, I am a staff member of the State Library, but I work very closely with the Board Meeting Council.

SENATOR COOK: Can you just tell me Cindy, just some things that the Coordinating Council does? The issues it deals with. CINDY: The council was instigated about three years ago to replace two others actual boards, and what it does, it basically provides representation from all different types groups throughout the state both citizen and different types of library so that citizens and librarians have a vehicle to have their needs and their concerns represented. As you know library services are evolving and changing and some of the issues, connectivity, Internet resources, that type of thing, need addressing and need development. So they felt, or this Board actually addresses that, they work on different initiatives to try to meet the needs of the library users. Looks at different initiatives, it looks at the different services that can be provided and that should be provided at the state wide level, and then looks to secure support and funding for it.

SENATOR COOK: At the state wide level, I am thinking about the state library? CINDY

LARSON: Through the State Library, but to support different aspects of library services of the state. It could be an initiative by the university library, it could be an initiative by public libraries, or by school libraries, but it tries to have a state wide impact, that's what the core of the boards is. It has responsibilities to make decisions basically on monies that the library issue 2004 initiative which was about, so it is not a governing board for the state library, because it is run by the Department of Public Instruction, but it does have decision making power over grants that are given to libraries. SENATOR WATNE: Under the Dept of Public Instruction? CINDY LARSON: In 1991, the State Library was moved under the Department of Public Instruction, and we report to Dr. Sanstead. SENATOR MATHERN: Does this include any school

librarians? CINDY LARSON: Yes, there is a school librarian representative on the board.

SENATOR FLAKOLL: The part that is struck on line 16,17 and 18, 19, is essentially because it has already been established? CINDY LARSON: Exactly, that was a start up date. SENATOR COOK: I've tried to do some quick math here, but I am assuming that the State Librarian is one the eleven? CINDY LARSON: The State Librarian is one of the eleven, the state librarian does not have a voting privilege, but of course gives this board direction and takes instructions from the board also, because we feel that one of our missions at the state library is to represent citizens and librarians throughout our state, and so this board helps in this process, so we don't necessarily need a vote, because this board only has decision making power on a limited amount of funds which is the grant funds. SENATOR COOK: So if this bill passes, you will go to ten voting members. CINDY LARSON: Exactly, yes ten voting members. Right, the Director of the North Dakota Library Association, or the President is a voting member, ex-official but a voting member. So the State Librarian is the only nonvoting member. So we will have ten. SENATOR WATNE: How often do they meet? CINDY LARSON: They meet 3 to 4 times a year, SENATOR WATNE, because a fiscal note comes with this at about \$400. CINDY LARSON: Right. SENATOR WATNE: So you must pay their mileage and expenses? CINDY LARSON: Exactly, we pay their per diem and their mileage. But they donate their time.

SENATOR COOK Closed the hearing on SB2055.

Senator Lyson moved a Do Pass on SB2055, Senator Watne, 2nd.
