Minutes: A BILL FOR AN ACT TO AMEND AND REENACT SECTIONS 12.1-20-06 AND 12.1-20-07 OF THE NORTH DAKOTA CENTURY CODE, RELATING TO SEXUAL ABUSE OF WARDS AND SEXUAL ASSAULT; AND TO PROVIDE A PENALTY.

Senator Lyson, testifies in favor of SB 2254. This bill comes to us because four years ago when laws were changed concerning deptment of corrections and sexual abuse of wards. I agree with this bill when first talked to about it. Problem is when a jail staff gets involved with an inmate. Or when a guard had sex with 5 inmates, this was only a misdeamenaor. I think it's horrible when authorities use their power for sexual abuse. This bill is absolutely necessary and must be passed.

Senator Watne, if you look at 2 and it states the ages. Remember our other bill regarding minors we passed? Does this bill correlate with those same parameters of age?

Senator Lyson, it does and I'm not so sure that it should.

Senator Watne, it doesn't look like it correlates.

Ken Sorenson, what bill?

Senator Watne, bill 2035. We changed it to make the crimes more severe.

Senator Lyson, I see what you're doing, and I'm not so sure I agree with it. When you're dealing with someone who's in charge of someone. It should be more severe of a punishment.

Senator Watne, an adult with a minor was a class A. A man 18-21 with a victim of 15-17 was a lesser charge. An adult with a minor under 15, or if adult is 22 and minor is 15-17 this is a class C.

Senator Lyson, I felt anyone who was in charge of a ward should get a class C felony.

Senator Traynor on line 11, page 2. Would amendments be appropriate so it would be compatible with SB 2035?

Senator Lyson, the penalties regarding wards should be more severe, I don't care how old the person is.

Senator Watne, can anyone be a guardian? What is the age?

Senator Lyson, I am a guardian of someone who is 48. Age is not the issue.

Senator Bercier, what about two consenting adults?

Senator Lyson, I don't think you can have two consenting adults in a jail. That was an argument at the penitentiary.

Ken Sorenson, Consent is not a defense. They are in charge of someone else.

Senator Dever, could this be constured to add a teacher at a school?

Ken Sorenson, that would be dealt with in another exisiting law.

Senator Traynor, your uping the penalty.

Senator Lyson, yes.

Senator Traynor closed the hearin on SB 2254.
