Minutes: Chairman Krebsbach ordered the hearing on SB 2363 which relates to the prohibition of expense reimbursement by state officers and employees while engaged in political activity.

Appearing before the committee to introduce the legislation was Senator Gary Nelson, District 22, primary sponsor of the bill. He asked the committees support of the bill. He indicated that he is not sure that many people are aware that if they came to Bismarck for a meeting and at the conclusion of the meeting they were to stop at the Democratic Headquarters or the Republican Headquarters for any reason at all, that you no longer qualify for expense reimbursement for that particular meeting. He indicated he thinks he knows the genesis for the reasons that this is in state law and this becomes a very touchy subject. He indicated that he doesn't know many legislators who haven't violated this at one time or another, or other state elected officials. He indicated that if everyone was honest we know that both parties have had occasion to violate this. Most of it has come from the fact that people don't even realize that this is on the books. He believes that we should be upfront and address this. There are many good reasons for people to

attend various functions when they come to Bismarck. At the risk of having it blown all out of proportion by the news media, let's change it so that we are within the boundaries of the law. Senator T. Mathern inquired we as legislators are already under this provision, this is just extending it to everybody. Senator G. Nelson indicated no, everybody is under this provision and this is just eliminating the political activity. This allows us to be reimbursed even if you do engage in some political activity on the same day that you are asking for reimbursement. If you are really honest about it you know that both political parties sometime sponsor events when they know a number of legislators are going to be in town. He knows that the minority had a fund raiser last week. He indicated it was questionable whether you could apply for the \$650.00 and use that portion from that day as an expense reimbursement the day that you had the fund raiser. Senator T. Mathern indicated he was confused because what Senator Nelson was saying didn't seem to relate to what the bill says. Senator G. Nelson indicated the content does seem somewhat confusing. A discussion ensued with Chairman Krebsbach, Senator T. Mathern, Senator Dever, and Senator G. Nelson participating. John Olsrud, with Legislative Council appeared before the committee. The key in the whole change in this bill is in line 13. We have been aware of this statute for a number of years and have been waiting for someone to use it in a campaign against an incumbent sometime. It would be bipartisan, it could apply to either political party. You come in particularly for an interim committee meeting and you get reimbursed for your travel to Bismarck and then you stay overnight, but then that same night that you drove in you go to a political fundraiser or dinner on your own time in the evening. A literal reading of this statute would say that you can't get your expenses for that day because you engaged in political activity on that day. That is the concern. All the other changes are just cleaning up the statute. Senator T. Mathern, Senator G. Nelson, Senator Kilzer, and John

Olsrud participated in a short discussion relating to the proposed changes this bill is making. Senators G. Nelson, Chairman Krebsbach, Mr.Olsrud, and Senator Dever participated in a short discussion. There was nothing further at this time. No further testimony was presented on the bill. Chairman Krebsbach closed the hearing on SB 2363. Chairman Krebsbach reviewed what the committee had heard on this bill earlier in the day. She indicated that John Olsrud had come before the committee and explained why they had removed the language on line 13; on any day on which political work was done. According to the law we should not have been paid for any day that we did anything with a political group or anything of that nature. Now it just changes that while engaged in a political activity. So in other words we wouldn't receive any pay while we were at a political function. Senator C. Nelson wanted to know how they are going to determine that? She indicated that he brought up the Democratic fund raiser that they had last week. That was at 5:00 o'clock. Are they going to take 1/12th of our pay because we were there from 5 to 7. Chairman Krebsbach, No. The point here is what they are trying to do is fix this for us. To say that you may receive pay, your normal pay and your normal expenses during that period of time. Discussion continued with Chairman Krebsbach, Senators, T. Mathern, C. Nelson, Dever, Kilzer, and Wardner. (Tape 3, Side A, Meter #'s 11.0-20.7) A motion for a Do Pass was made on SB 2363 by Senator Wardner, seconded by Senator Dever. There was no further discussion. Roll Call Vote indicated 5 Yeas, 1 Nay, and 0 Absent or Not Voting. Senator Kilzer will carry the bill.
