SENATOR KLEIN: The other bill mentioned revocable/irrevocable trusts.

SENATOR D. MATHERN: This one mentions the deceased's marital status and makes no mention of the 45 day cooling off period.

No opposing testimony. Hearing concluded.

SENATOR ESPEGARD: Move do pass.

SENATOR KREBSBACH: Second. Roll call vote: 7 yes; 0 no. Motion carried.
