**Testimony on SB 2445**  
**Presented by Attorney General Wayne Stenehjem**

A key component to my drug enforcement initiative is the systematic gathering of information regarding the successes or failures of the program. To ensure our success as we do our respective jobs, law enforcement, mental health professionals and the Legislature require accurate and comprehensive information regarding prevention, enforcement and treatment efforts. Senate Bill 2445 establishes a reporting mechanism that gathers information from each of the key entities involved in program. Through this centralized gathering, one agency – the Attorney General's office – will not only receive the information, but will also provide a comprehensive analysis of data with the help of experts from each agency

As with any bill requiring multi-agency reporting, clarifying the initial proposal has been necessary. I have submitted a list of amendments and a revised version of the bill for your consideration. The amendments were drafted after discussing the specific reporting requirements with representatives from Human Services, the Health Department and the Department of Corrections. We consider these friendly amendments, and a more detailed review of the specifics of each is provided below.

Under SB 2445 the health department will provide critical information regarding the accessibility and prevalence of gateway and other illicit drugs. The phrase "gateway drugs" includes tobacco, alcohol and marijuana. Studies have shown that in many instances these substances are the first step in a progression of life-long drug abuse. The health department's report will provide us with basic information regarding not only the types of drugs being used, but also about frequency of usage among our youth.

The state crime laboratory will provide a report detailing the type of controlled substances tested and frequency of testing. The information from Human Services will deal with treatment ... the number of individuals treated and a delineation of the types of substance abuse addressed during treatment.

From the Department of Corrections we will receive statistics on the number of people incarcerated or on probation guilty of violating Title 19, the controlled substance chapter. The department's report will include length of sentence, including probation, and the actual time served. It will also identify the number of people referred to and treated as a condition of sentencing, probation or parole.

Finally, my office will assemble statistics on the number of arrested for violating title 19 and information regarding the current enforcement efforts to combat unlawful drug trafficking and usage.

As you can see, by serving as a clearinghouse, the Office of Attorney General will be in a better position to formulate ideas and provide useful information to the Legislature during the interim. This information will prove to be invaluable to my office and to legislators as we design future drug enforcement policy.

Revised Senate Bill 2445

**Section 1.** A new section to chapter 19-03.1 of the North Dakota Century Code is created and enacted as follows:

**Comprehensive status and trends report.** On or before July first of each even-numbered year, the attorney general, or designee of the attorney general, shall report the current status and trends of unlawful drug use and abuse and drug control and enforcement efforts in this state. This report must be made to an interim legislative committee and must include the following information:

1. The state department of health shall provide the results of the most recent survey of the state's young people regarding drug usage. This survey must include information on the accessibility of gateway and other illicit drugs, the prevalence of gateway and other illicit drugs in schools or on school property, and the types and frequency of gateway and other illicit drugs used by young people.
2. The state crime laboratory shall provide a report that includes the type of each controlled substance tested and the number of times tests were ran for each controlled substance.
3. The department of human services shall provide a current status report of the number of people who were treated in the state. The report will include information about the variety of drugs, legal and illegal, for which people were treated.
4. The department of corrections and rehabilitation shall provide the current status of the number of people incarcerated or on probation in the state correctional system for violation of title 19. The report must specify the average length of sentence including probation, the average length of incarceration ordered by a court to be served, and the average actual time incarcerated for drug offenders sentenced to the custody of the department. The report must also identify the number of people referred to and treated as a condition of sentencing, probation or parole.
5. The attorney general shall provide the current status of the number of arrests for violation of title 19 and the current enforcement efforts to combat unlawful drug trafficking and usage.
