Minutes: **Chairman Krebsbach** or ched the hearing on SCR 4020 which is a resolution relating to directing the Legislative Council to study state employee compensation levels. **Senator David O'Connell**, District 6, prime sponsor of the resolution appeared before the committee. indicated that he brought this resolution at the request of a number of state employees who felt that there was a need to study the levels of compensation that are being used in the state. The Senator indicated that in his own research he found that there are a number of state employees who are on fuel assistance. This surprised him. He indicated one of the employees he spoke with indicated she did inherit a couple of quarters of land. She is making payments on the land, she works full time for the state and she still qualifies for fuel assistance. He also indicated that there are even a number of food stamps which surprised him. He spoke with some of the other higher salaried employees and their opinion was that the "gap" is coming together. Why should they take a job and supervise people and have more responsibilities. There isn't enough difference between the pay gap as a supervisor and what others are receiving. Basically this is

why the study resolution is here. He noted that there are quite a few employees who were hired as temporary. They are still on the payroll and are receiving no benefits. He thinks that the state needs to take a look at this. Senator C. Nelson inquired if the definition of state employees includes higher education. Senator O'Connell indicated it did. Ken Purdy with the Central Personnel Division appeared before the committee. He indicated that they really don't have a position in support of or opposition to the study. Anytime there is an opportunity to continue to review and work with legislative committees and helping them understand and continuing to develop employee pay. We are willing and able to help out any way we can. Currently we have a state employee compensation commission. This does some review of some of these pay issues during the interim. Senator Kilzer was on it in this interim. It has been in operation for about 3 bienniums now. We review market pay issues and we have a system for employee pay that is kind of a blend of market and internal equity. Determining the relative value of employee jobs, comparing the knowledges, skills, complexities, and accountability of various positions. We set the relative value and grade level based on that evaluation and analysis. We gather market salary information and using those relative values apply an overall comparison, wherein we try to place our salary ranges with the midpoints of our ranges at about 95 % of average market pay for that level of work. Comments and observations were made by Senators C. Nelson and Kilzer. There was nothing further at this time. **Chairman Krebsbach** closed the hearing on SCR 4020. A motion for a Do Pass was made by Senator Wardner, seconded by Senator Dever. Discussion ensued. Senator Wardner commented that he comes from education and he realizes that an education is very, very important. One thing we keep commenting on is that teachers are 50th. In his experience in the legislature, our state employees work very hard, are very loyal and that's it. He wishes we had enough money to take care of them too. Senator Dever commented

that he would agree with Senator Wardner. One difference between our initiative towards teachers salaries and state employees is that the teachers we don't have direct control of that. The state employees we do. We have that direct responsibility. He thinks we need to look at it. Senator Kilzer commented on lines 14, 15, and 16, he indicated that he wouldn't want to reinvent the wheel. It sounds like some of this information is being used already and is gathered annually. Chairman Krebsbach indicated that perhaps Mr. Purdy's office would be providing much of the information for such a study and if he has that information we just speed up the process. Senator Kilzer inquired if this would increase his overhead. Mr. Purdy indicated that they participate in what is called Central States Compensation Association. We were one of 10 original states forming that group. We got tired of answering each others surveys. About 12 years ago they formed a very loose association. The first year they had three or four meetings working on this. The regional market data which comes as a result of this is readily available. each year. Chairman Krebsbach offered some comments on lines 8 and 9 of the bill. She indicated that she recalls fighting quite hard in the last session that we maintain certain percentages of dollars for the state employees. She indicated she takes a little objection to that type of language. Senator C. Nelson indicated deleting the word minimal from line 19 would make this a true statement that there appears to be little support for going beyond the increases in the governors budget. It doesn't matter to her if that whole phrase is knocked out of there. Going back to line 3 and 4. It's true. She thinks it has to be in there that we hire some people at the lower level jobs that are making less than what is considered to be poverty. She thinks it is important to find out how many of them are. Senator Dever commented that he agrees with the chairman that there are some statements here that he is not necessarily willing to concede to. Senator Wardner indicated that he would withdraw his motion if the committee wished to

amend the resolution. Senator Kilzer indicated that the third whereas contains three areas that he prefers not to see an editorial about. Senator C. Nelson made some additional comments about this section. At this time Senator Wardner withdrew his motion for a Do Pass and the second was withdrawn by Senator Dever. Senator T. Mathern made a motion to amend SCR 4020 removing language on lines 8, 9, and 10. Seconded by Senator Wardner. Roll Call vote indicated 6 Yeas, 0 Nays, and 0 Absent or Not Voting. Senator Wardner made a motion for a Do Pass as amended, seconded by Senator Dever. Roll Call vote indicated 6 Yeas, 0 Nays and 0 Absent or Not Voting. Senator T. Mathern will carry the resolution.

Minutes: Senator Wardner, Chardan of the Conference Committee, called the committee to order. The clerk called the roll. All members were present. Chairman Wardner asked the house to if one of their members would like to explain the amendments which they attached to SCR 4020. Representative Devlin who was the author of the amendments explained them. He indicated when they looked at the original resolution the house committee thought there were some things missing that they believed were important. Some of them get questions from constituents back home who want to know how state salaries compare to those in the private sector. The house felt that if we were going to look at the state compensation, employee compensation we also need to look at the benefit levels. This would be done to see not only how they are in our state but also how they compare with surrounding states. The house also felt that since we have the state employee compensation commission that involves four legislators and five other people studying this all the time there might be some duplication, but, if it was the intent of the senate to do this study the house wanted to expand it to make sure that it covered not

only salary and benefits but also comparative salaries with not only the public sector but the private sector. So that was the house's intent. **Senator T. Mathern** indicated that he thought that the house has put some useful amendments on this bill. He thinks that one of the concerns of the senate was that we not get into too many issues and kind of look at the salary thing and to try to focus on that. He doesn't think it was the senate's intent to say that those other things weren't important. He feels that if the house wants to look at that these are appropriate amendments and he has no problem with the intent. **Senator Wardner** indicated that he felt the senate doesn't disagree with anything here. The house just got a little more specific. **Senator T. Mathern** moved that the Senate accede to the House Amendments, seconded by **Senator Dever**. There was no further discussion. Roll Call Vote indicated 6 Yeas, 0 Nays, 0 Absent or Not Voting. The conference committee was adjourned.
