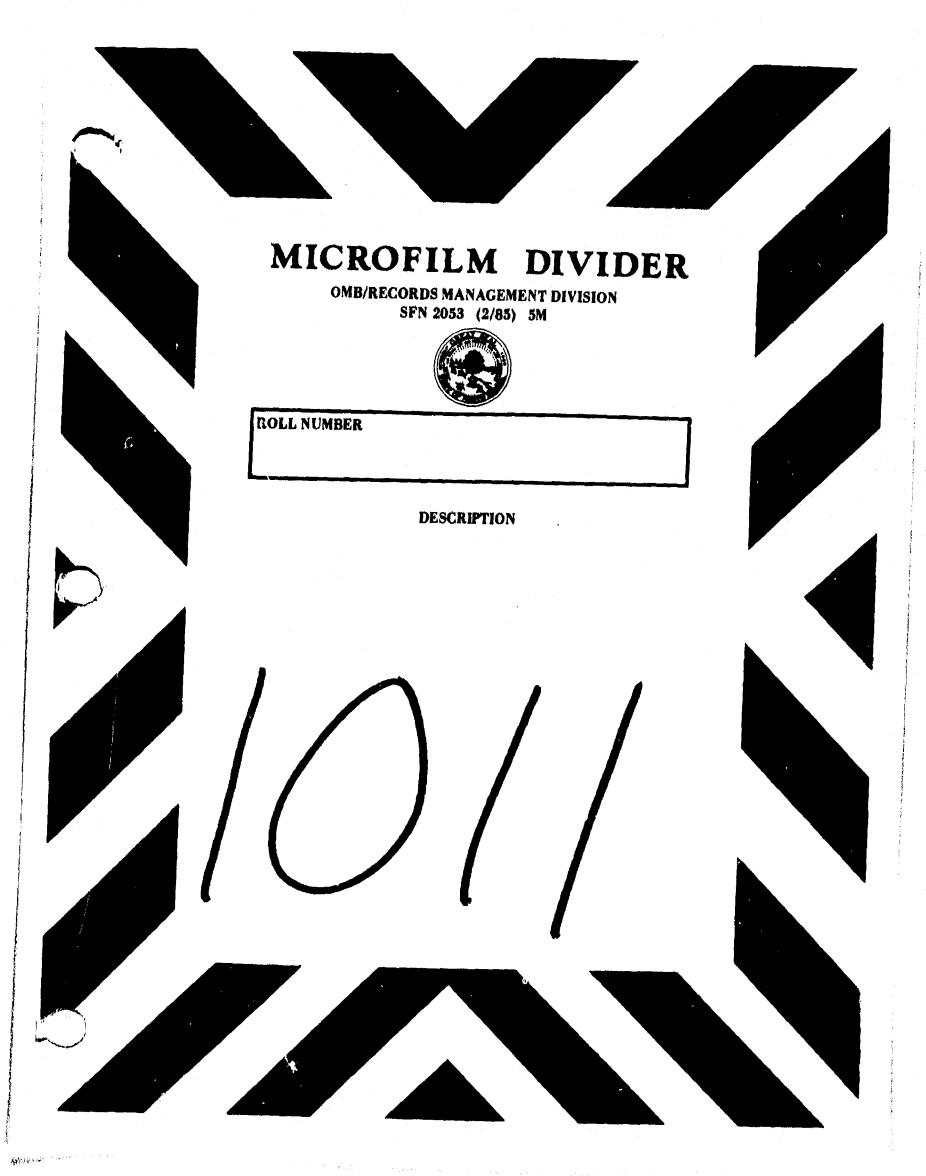

Colonel James Hughes, Superintendent of the ND Hwy.. Patrol testified on behalf of HB 1011 Written testimony is enclosed. In attendance, Maj. Mark Nelson, Field Operation Commander, Maj. Neil Johnson, Patrol, Mark Lahren, analysts, and Capt. Dave Kleepe, Administrator.

Col. Hughes also shared information related to the Amber Alert system which is connected with a second, South Dakota, Minnesota and the Canadian provinces. The system will be tested on Feb. 6, 2003

department has called upon retired troopers to work part-time without benefits in an effort to redirect it's resources.

Rep. Timm asked where the funds will be allocated from the dollars retained by reducing 15 FTE's.

Colonel James Hughes responded 90% of the budget is operations; cars, people, gas etc. A 90% budget was submitted with 32 FTE's and the closing of several weigh scales. The Governors office was able to give us back 21 FTE's and we received 1M in funding from the Federal Government to maintain 3 weigh stations..

Colonel James Hughes in response to Rep. Skarphols question, the department anticipates 6 vacancies in patrol, 1-2 might retire during the next biennium. He also advised the committee although insurance costs have skyrocketed, his department has received a 10% discount in rates from Risk Management because of a reduction in accidents.

Rep. Glassheim commented he has received many letters from fixed scale communities, voicing safety concerns. Fixed scale facilities do more that just check for weight.

Colonel James Hughes agreed, saying Historically, scales have provided 1) truckers with needed permits, this has gone for the most part electronic. 2) scales provided a deterrent to overloading..30% of overloads are picked up from patrol, accounting for 70% of fines. He stated no buildings will be removed from the closed sites so officers can use these facilities for monitoring as needed. Weigh in Motion detectors will be added and 3) the site provide for an inspection site needed by Federal guidelines. Their will be flexibility with the mobile teams.

Rep. Keith Kempenich, District #39 appeared before the committee to voice his concern over the site closings. Mobile units are based on more inspection vs. Weight with mobile stations not being opened at night. He would like to visit with Col. Hughes for further discussion.

Rep. Skarphol commented to the committee, the legislature put a lot of pressure on the Col. last session, 90% of Hwy.. damage is due to weight....the biggest abusers are our citizens. The cost of replacement is to high to allow abuse. I agree with the Colonel.

Hughes Colonel James stated the department is phasing in the scales and the original budget closed all scales, at the last minute the Feds, Gov. Office and the state pulled together to keep 3 scales open in Fargo, Joliet, and Williston. The sites are not being destroyed. Therefore, when the funds become available we can turn the switch and reopen.

Rep. Timm commented he believed the Hwy.. Patrol should be funded totally from the General Fund. The funding change was from the Hwy. Trust Fund instead of the Hwy. Fund. OMB made that change.

Hughes Colonel James Some of the funding has been returned, we returned 5 Million to the Hwy. Trust Fund, 6.2M from Hwy. Fund. We believe more money will be returned this biennium.

Rep. Glassheim requested a written response to the scale closing budge, federal funding etc.

Sherry Neas, Procurement Manager, answered questions regarding the 1600 cell phones used in state government. The current plan includes several state packages. The plan expires 2/28/05, this is a joint contract with Higher Education. Bids will be send out soon. The cost show from 7/01 to 7/02, which includes a 13 month period averaged \$30,000. 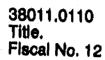

Senator Holmberg, chair, opened the hearing on HB 1011 (#1061).

Senator Holmberg stated that there would be a subcommittee on this bill, which will consist of Senator Christmann, chair; Senator Bowman and Senator Tallackson.

Colonel James M. Hughes, Superintendent, ND Highway Patrol. His written testimony (Exhibit #1) is attached. He read his written testimony. He added that he had 5 vacancies at Motor Care inspectors, the 5th being at the scales. The Highway patrol will not be filling any of these vacancies as the House removed 13 FTE's which would include the 5 vacancies noted. There are 6 vacancies in the trooper section. There are in the selection process for the academy to start in June. These come from retiring highway patrol troopers. The individual filling the trooper position completes a 22 week of training. It takes about a year to fill a vacancy and get the trooper on the highway.

Questions: (#4300) Senator Robinson: On page 1 of his testimony he talked about highway safety, that speed kills, etc. There is a the bill that raises the speed limit to 75 on the Interstate, you have a shortage of troopers now, you have added responsibilities now for covering the capitol, helping with the traffic at the air bases, additional security around the state, etc. What kind of impact does it have on the patrol. Jim responded; He spoke on speeding, tickets, accidents and the bill to raise the speed limit. He continued about the speed limit bill and how he wanted to see the penalty and more points added to this bill. Senator Robinson asked Jim to relate the coverage of his troopers and the added security coverage since 9-11. Jim responded that the 75 speed limit with the added fines and penalties would be okay, so that would be enough to handle the situation. So that is were the Highway patrol stands on the 75 speed limit. Senator Robinson; He wanted to know how and way the Highway patrol is called upon to help with the air bases in Minot and Grand Forks? Is the state reimbursed for these services? Jim: Missile sites are all over, they have the locations of all these, and they were asked to patrol those areas when they are patrolling the highways, when the alert is orange or higher. When the air bases go to orange or red alert, then all vehicles coming into the bases must be checked, physically. This backs up traffic on the highways, so they were asked for additional help, outside the base, to help control and move the traffic. Senator Bowman: There are some major policy changes with this budget, in closing down the scales that people have be come to depend on, there was no public impute, that he understood, what bases was used to close down something that protects all the millions of miles in our roads and all the truck traffic that goes across the scales to protect that investment, how is it justified going to a portal system when they have been at very good at catching people who are overweight. He also asked about the portable scales that are already out

there that local law officials can use. He also wants to know what the average person makes working at a scale house. Jim responded: The Minot scale was closed with months of public hearings, with legislators, city commissioners, and all those involved. He talked about the other closures around the state. He was asked to present a 95% budget and the Highway Patrol budget is over 90% operating funds. Over 90% of the budget consists of salaries, gasoline, patrol cars and people. They don't own any buildings, no projects, no other resources. For the patrol to submit a 95% budget, they have no choice, he has to cut people, since he has no other money to cut. To find 5% which is over \$2.2 million they have to look at the operation of the department, our e-permit system, mobile enforcement system, the new electronic system that is being planned later this year, that will put electronic devices in the highway, the officer can sit up the road, turn on his computer and get the weight of the truck, axles on the truck and let people roll on, rather than stop a hundred thousand trucks that are overloaded, people can continue down the highway. The bottom line is money, the patrol does not have many options. Senator Bowman wanted to know what the average salary is that works at a weigh station. Jim responded that it was approximately \$80,000 to \$84,000 a biennium. Senator Bowman continued regarding the sites that are being closed and the oil traffic that is in western North Dakota. These people rely on these weigh stations for permits, etc. If they have to wait for the mail for permits then they have down time, which costs them millions of dollars. He wondered if the patrol considered what it would do to the oil patch by the closure of these stations in the western part of the state. Jim replied that it was considered. (Tape #3 side A ends here, Side B continues with the rest of Jim's answer). He took the 3 highest producing sites in the state, those in major federal highways and those that are closest to the Northern border. So they looked at homeland security

issue, production issues, the locations and the cost to run those scales. He talked about the cost of running the scales (manpower) vs. the amount of money they bring in. He stated that he realized that money wasn't the only factor and that was why they pushed on for the e-permits. The scales will not be torn down, they will be left up with the electronics so that the local troopers or officers that work in weight enforcement, or an officer that would be located there under a federal program could go there and open the scale and start random checking the trucks. There are other ways that trucks can drive up with nobody there and weigh his own truck if it is during harvest or whatever to find out there weight. Senator Krauter: He wanted to know more about the E-permits. Jim responded that the E-permits were started because working with the ND Motor Carriers Association, the bigger companies know what permits they need all the time, if they can go to their computer and go to the patrol web site and pull up the e-permits and fill out the required information and pay by a credit card, without having to find a scale or highway patrolman. This was an easier way for them to get the permits they needed. He continued with other permits that are available. There are still people who do not want to use the computer system and they can still call the patrol office and get the permits that way also. This was a good way to do these thing where there are no scales in the area. He then talked about the Phase II of this program which would be Non-resident Interstate permits including self-issueing permits, seasonal permits, and routine oversize permits. Senator Andrist: He thought the mobile scales were a good idea, he wondered how they work, they can weigh a vehicle without stopping it, where are they based? How are they used? Jim stated that (he walked away from the mic and it was difficult to hear him) He showed 2 maps that show where the new electronic scales are located, etc. Exhibit #2 which is attached. 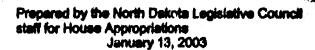

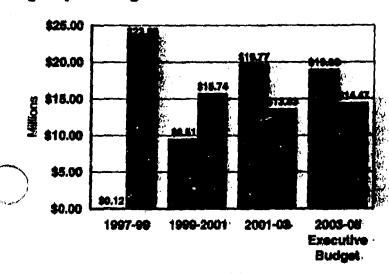

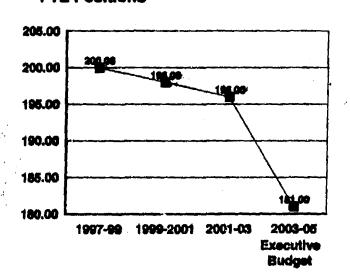

North Dakota Highway Patrol Agency Overview

1) What is the main purpose of your agency?

The primary purpose of the Highway Patrol is directly related to public safety. The Patrol concentrates their efforts at patrolling the highways and being visible; the reduction of traffic crashes and investigating them when they do occur; impacting alcohol abuse relating to DUI and underage consumption and the tragedies that occur on our highways as a result of these; and providing quality service to the public.

The Patrol also has the responsibility of operation, maintenance, and administration of the Law Enforcement Training Center.

Attached is a copy of the 16 separate duties and responsibilities of the highway patrol as identified in 39-03-09 NDCC.

2) How do you measure success?

The Patrol identifies performance measures that are regularly reviewed to determine how to best focus our daily efforts to impact traffic safety related issues. Following are examples of performance measures used by the NDHP:

Success is also measured by feedback we receive from the public. On a weekly basis we receive written comments from the public complimenting our officers for the helpful and courteous manner in which they received assistance on our highways.

3) What can the Legislature do, financially or otherwise, to help you achieve your purpose?

At this time there is probably nothing additional the Legislature can do. However, you should be aware that the movement of some personnel from state funded positions to federally funded positions will result in less flexibility in how we utilize these employees. These employees will concentrate more on the inspection of commercial vehicle equipment and compliance with commercial driver requirements and less on enforcement of size and weight regulations. We also become more reliant on the continuation of federal funding although we have no reason to believe that the funding will be discontinued.

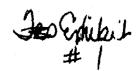

House Bill 1011 - NDHP Appropriations

Introduction

Good afternoon, Mr. Chairman and members of the Senate Appropriations Committee. **Senate Bill 260** was enacted and approved on March 12, 1935, creating the North Dakota Highway Patrol. It authorized the appointment of the superintendent, assistant superintendent, and not more than 10 persons who shall be known as "highway police" and whose duty it shall be to enforce the provisions of laws of the state of North Dakota relating to the protection and use of the public highways in the state.

- The State Patrol is now 67 years old.
- I just started my thirtieth year.
- I've worked for the State Patrol for almost half of its existence. Boy do I feel old!
- Much has changed and all for the better I hope, and mostly because of you and your predecessors' support.

And from those meager beginnings, the North Dakota Highway Patrol has grown into one of the most widely respected law enforcement agencies in the nation.

With that being said, let's get started with the work at hand.

Traffic Safety

Our goal is to reduce the number of traffic crashes by patrolling the highways, enforcing traffic laws, providing public awareness and education, and working closely with other agencies and safety organizations. During 2002, North Dakota recorded 97 traffic fatalities in 84 fatal crashes. This is a decrease of 8 fatalities from the 105 (95 fatal crashes) recorded in 2001. The following information relates to 2002:

- Alcohol was a contributing factor in 42 percent of fatal crashes (42 fatalities)
- Speed/speed too fast for conditions was a contributing factor in 36 percent of fatal crashes
- There were 32 deaths in one-vehicle rollovers 91 percent were not wearing seat beits
- 4,444 total traffic crashes were investigated by the Patrol
- 1,120 arrests for DUI
- 27 sobriety checkpoints were conducted with 21 arrests for DUI
- 702 traffic safety talks/presentations were given to citizens

Motor Carrier Operations

(Federal Fiscal Year 2002 - October 1, 2001-September 30, 2002)

On July 1, 1983, the regulatory responsibility of the truck regulatory division of the Department of Transportation was transferred to the Highway Patrol. This included 10 locations with 12 fixed scales with 49 truck compliance officers and supervisors staffing these sites. Currently, we have 7 fixed sites manned by 30 motor carrier inspectors and supervisors and 4 unmanned fixed sites. During the last 19 years several things have occurred that required the closing of some the scales: the 1998 flood in Fargo in conjunction with the construction of a new scale on the Minriesota side of I-94, the traffic concerns in Grand Forks and Minot, and retirements in the Hague area. We are working with our neighbors on our borders of Manitoba, Montana, and Minnesota to reduce the amount of stops that a commercial vehicle must make. This reduces their cost of operations and expedites the goods being transported. These changes were supported by the North Dakota Motor Carriers Association.

Over the last several years we have noted that while the fixed scale locations have apprehended the majority of overloads, the mobile units have, by far, assessed the larger fees. In Federal Fiscal Year 2002 while the mobile units only detected 36 percent of the total overloads, they accounted for 71 percent of the total fees collected or \$200,000. This indicates that the more serious violations are **avoiding our fixed sites** and emphasizes the need for mobile enforcement.

When it was necessary to relocate the Minot scale, a mobile team was established as a pilot program. This has so far proved to be very effective, giving us the flexibility to be mobile while still having the fixed location that may be used by local units. During the first two months of operation, the mobile team inspected 239 commercial motor vehicles, placing 87 vehicles and 15 drivers out of service, detected 17 overloaded vehicles, and collected \$8,600 in fees. This is a 50 percent increase in overload fees over the same period last year at the **fixed location**. They have conducted operations at 18 different locations throughout the western part of North Dakota.

Our 2003-2005 budget proposal provides for an increase in mobile enforcement teams and reduces our manned fixed sites from seven to three. The four scale locations that are not operated full-time would still be available for use by mobile enforcement personnel to open and operate on an unscheduled basis. The three sites we propose to continue operating are located in Williston at the intersection of US 85 and US 2, Jolliette on I-29, and West Fargo on I-94.

The Motor Carrier Safety Assistance Program (MCSAP) has the primary function of reducing commercial vehicle crashes. This is done through the inspections of commercial vehicles and drivers on the roadside and also by conducting compliance reviews at companies that have given indication of safety problems. This program is essential to insure we have personnel that have the technical knowledge to conduct these inspections and reviews. Since its inception in 1985, we have seen a 50 percent decline in the number of vehicles being placed out of service for serious defects and a reduction in overall commercial vehicle crashes. This program has included all of our motor carrier troopers and four troopers assigned specifically to the MCSAP program.

We have added one full time position that will give us five full time MCSAP positions. This will reduce the time the motor carrier troopers spend on inspections and allow more time for their primary duty of weight enforcement.

Capitol Security

I am sure you all remember the events of September 11, 2001, and the dramatic affect those events had on overall security of people, buildings, and key infrastructure. Specifically, security at the State Capitol, which you know is the responsibility of the Patrol, underwent several changes. All in an effort to provide an adequate yet acceptable level of security for state officials, employees, and citizens.

- On September 11, 2001, uniformed officers from the Bismarck district office and Headquarters staff began performing extra security assignments at the Capitol.
- On October 15, 2001, we began rotating two officers each week from our eight field districts to the Capitol for security duties. This continued until January 28, 2002.
- On January 28, 2002, a private security firm (Bismarck-Mandan Security) was hired to provide two security personnel to assist with security at the Capitol. We discontinued using the two uniformed officers from our field districts.
- On April 19, 2002, the services provided by Bismarck-Mandan Security were discontinued with security duties continued by NDHP personnel.
- This Legislative Session, we anticipate security duties will be handled by our current Capitol Security personnel. We do not plan to utilize road officers to augment the security force as we have done in past sessions.
- The biennium began with two troopers assigned full-time to Capitol Security. Currently, we are using one trooper and three part-time civilians who are retired Highway Patrol officers. We feel this allows for better utilization of our uniformed officers.

TRAINING

Section 39-03-13.1 NDCC states that the superintendent of the Highway Patrol is responsible for the operation, maintenance, and administration of the law enforcement training center. The primary function of the training center is the coordination of basic and advanced training courses for all law enforcement in North Dakota within the guidelines established by the Peace Officer Standards and Training Board.

In 2002, 57 training courses were held at the training center for 1,004 students. A total of 85 new officers from various agencies satisfactorily met the minimum training requirements to serve as a peace officer in North Dakota. An additional 50 persons received training to serve as correctional officers and 10 troopers completed the Highway Patrol Recruit Academy.

Information Technology

Electronic Citations

Last summer the Highway Patrol began pilot testing an electronic citation system with officers in the Grand Forks and Jamestown districts. The application was designed as a module within our Case Management System and involves entry of traffic citation information into the database via the Mobile Data Communications System.

A vehicle printer is used to print the copy that is given to the person being cited. The next step of the project involves completing the electronic transfer of citations to the state court system and the Department of Transportation.

E-Permits

In response to the growing trend of E-government, the Highway Patrol initiated an online permitting application to provide individuals and trucking companies another way to purchase permits. The first phase of E-permits was deployed late last year and included the following permit types:

- 10 Percent Weight Exemption
- **Resident Custom Combine**
- 72 Hour Trip (vehicle registration fee)
- Fuel
- Long Combination Vehicle (LCV)

Since the website access was turned on last month, 162 permits have been sold on-line generating \$13,990 in revenue. State ITD is expected to begin software development of Phase II of E-permits later this spring.

Mobile Data Phase II

Procurement and implementation of the North Dakota Mobile Data Communication System Phase II was completed early last year. Phase II consisted of equipping 20 additional patrol vehicles with mobile data. State Radio's portion of the project included upgrading five additional tower sites for data communications. The state system now consists of 15 tower sites that provide coverage to about two-thirds of the state. A total of 98 Highway Patrol vehicles are equipped with the technology. Many other agencies have benefited from this development and have implemented mobile data communications within their agencies.

Mobile data communications gives patrol officers the ability to check the FBI's National Crime Information Center (NCIC) for wants and warrants within seconds. Nationwide driver license and vehicle registration information can also be obtained directly instead of going through dispatch personnel. Car to car and car to office messaging as well as

direct entry of daily activity and arrest reports improves data handling and greatly reduces the need for data entry personnel.

Accreditation

The North Dakota Highway Patrol is a nationally accredited law enforcement agency that meets or exceeds the high standards that the Commission on Accreditation for Law Enforcement Agencies (CALEA) has set for law enforcement. We feel that it is vital that an independent agency such as CALEA periodically reviews our department to ensure that the expectations of the citizens of North Dakota are met with the highest quality of service we can provide and that they deserve.

Nationally, accreditation membership has been on the increase, currently 24 percent of all law enforcement personnel belong to an accredited agency. Of this percentage, 80 percent belong to agencies that employ less than 300 people. We have also seen an increase in the number of state agencies seeking accreditation; currently 15 state police, highway patrol and department of public safety agencies are accredited, and an additional 5 have signed contracts since 2000 and are seeking accreditation.

The North Dakota Highway Patrol will be up for re-accreditation in July of 2003. This will be our fourth re-accreditation since 1989 when we were first accredited. Last fall we conducted a mock assessment of our agency where we had assessors from other state agencies review our files, conduct interviews with agency personnel, and rode with a number of our troopers from around the state. In their exit interview they commented a number of times on the professionalism of all personnel and held our agency in high esteem. Staff Sergeant Al Manint from the illinois State Police (assessor) paid us the following compliment "the officers i spoke to thought highly of management; they were obviously well trained and professional. I would work for your agency in a heartbeat." The actual accreditation on-site will be held this April and we are working hard to ensure that we will be re-accredited this summer.

The North Dakota Highway Patrol and the Bismarck Police Departments are the only two North Dakota agencies to achieve status as a nationally accredited agency.

Following the terrorist attacks of September 11, troopers statewide were called upon to provide additional security details to insure that the citizens, as well as the interests of North Dakota were protected. In the last biennium, troopers in the field logged 412 hours toward security details. In the first 18 months of this biennium, troopers logged 2,607 hours toward security details. These security details included:

- Providing 24-hour security for the Garrison Dam.
- Providing high visibility patrol at both the Grand Forks Air Force Bacs and the Minot Air Force Base (at the request of the military).
- Providing high visibility patrol near our state's missile sites.
- Providing air surveillance along our northern border.

- Providing increased security at our state's Capitol.
- Conducted 386 hazardous materials site visits.
- And, at the same time, stressing high visibility during our normal duties.

Recognizing the need for our citizens to become involved in our security efforts, our agency developed 'border meetings' in each of the eight counties bordering Canada. The purpose of these meetings was to develop a communication network between local residents and law enforcement officials. Citizens attending the meetings were asked to report any suspicious activities along the border to their local law enforcement agencies.

As the threat of anthrax surfaced in various parts of our nation, North Dakota citizens began to report suspicious packages to their local law enforcement officials. The Patrol, in close cooperation with the State Health Department, agreed to transport all suspected contaminated articles to Bismarck for testing. While these types of calls continue, our troopers to date have provided for 61 transports since the initial threat occurred.

At the request of the Governor, the Patrol, serving as the functional coordinating agency for public safety, was directed to take a lead role in the development of a statewide **Amber Alert Plan**, a plan which reflects North Dakota's commitment to the safety of its citizens, especially its youth. Through the cooperative efforts of numerous agencies, I am proud to announce that after a statewide test of the Amber Alert plan was successfully conducted on February 6, 2003, the plan is now fully implemented and operational. The communications network that the 'Amber Alert' plan brings between law enforcement and the citizens of North Dakota will help to insure that all or our children remain safe.

During the past blennium, the Patrol has continued to provide the service that the citizens of North Dakota have come to expect. Our troopers, whether it was changing a flat tire or providing a warm vehicle to sit in until a wrecker could arrive, provided 10,744 highway assists to the citizens traveling our highways.

And our assistance extends beyond our borders as well. Recently, Nebraska authorities broadcast an attempt to locate on a kidnapping suspect possibly traveling through North Dakota. Kidnapped were three children ages 3, 1, and 3 months that had been taken by their mother. **Troopers**, monitoring the call for assistance, observed the vehicle traveling northbound on **I-29 near Hillsboro**. A stop was initiated and the suspect taken into custody. The three children were returned to Nebraska unharmed, and the mother is awaiting extradition to Nebraska.

Drug and alcohol violations have continued to be a priority for our agency. During 2001, nearly 45 percent of all arrests in North Dakota were for either drug or alcohol violations, with alcohol accounting for nearly 40 percent by itself. Alcohol arrests in North Dakota averaged 32 per day, every day, for the entire year. The number of alcohol related deaths during each of the past two years has remained near the 43 percent range.

Recognizing the need for a strong education and enforcement effort regarding drinking and driving, the patrol has continued to perform sobriety checkpoints. Through a strong media campaign and an approval rating of over 90 percent by our citizens, the Patrol conducted 54 sobriety checkpoints during the past biennium and is looking to increase that number during the 2003-05 biennium.

Drug arrests have been occurring on a regular basis as well. During the past year (2002), troopers statewide investigated 395 cases involving drugs; an average of over one per day. One such arrest involved a subject who was stopped for a routine traffic violation near Harvey, North Dakota. The trooper, observing a hole cut between the backrest of the backseat and the trunk of the vehicle, searched the vehicle and found over 25 pounds of marijuana located in the trunk.

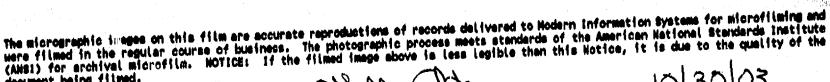

I would like to add that our ability to respond, be flexible, adapt quickly to unforeseen situations and apply resources to where they are needed in a responsible, effective, efficient, and timely manner is crucial for the state's success. For example: road construction, blizzard, road closures, and most recently 9-11, grass fires, anthrax threats, etc.

Our lives were changed forever since that fateful day in September and has proven to all of us how small the world really is. What we do in North Dakota or what others do in New York, all public safety workers like us, make a difference. The geographic location may change but the demands, the expectations, and the results are the same. We are on the front line everyday "doing whatever it takes" to protect those in need.

These are not times for the selfish, the weak minded, the non committed, or those who would give less than 100 percent. These are times for those in law enforcement who are strong minded, well focused, and dedicated to the public welfare, putting their needs ahead of personal gain — that's the North Dakota Highway Patrol.

Thanks in part to your support we are well trained and well equipped, both mentally and physically, to perform. We can and will push on because we have so many past successes showing us the way.

North Dakotans would have died since then - one of those 2,500 lives saved may have been yours or a member of your family.

I recently started my thirtieth year as a state trooper and eleventh year as Superintendent. An example of one thing I am most proud of is that during the last 50 years we had only 11 years when less than 100 people were killed on our roads. Nine of those or 81 percent of those occurred in the last twelve, or since 1991. We are making great progress.

In closing, I believe public safety is a feeling of being safe and having confidence in our law enforcement officers.

- During a disaster the public sees troopers helping out side by side with those affected.

39-03-09. Powers of highway patrol. The superintendent and each member of the highway patrol shall have the power:

- 1. Of a peace officer for the purpose of enforcing the provisions of this title relating to operators' licenses, the provisions of title 24 relating to highways, and of any other law regulating the operation of vehicles or the use of the highways, and in addition the highway patrol shall enforce all laws relating to the use or presence of alcoholic beverages in motor vehicles.
- 2. To make arrests upon view and without warrant for any violation committed in the person's presence of any of the provisions of this title relating to operators' licenses, or of title 24 relating to highways or to other laws regulating the operation of vehicles or the use of the highways.
- 3. To direct traffic in conformance with law, or, in case of fire or emergency and to expedite traffic, or, to ensure safety by directing traffic as conditions may require notwithstanding the provisions of law.
- 4. To facilitate compliance with the provisions of this title, to require the driver of a vehicle to stop and exhibit the driver's operator's license and the registration cards issued for the vehicle, if any are required, and to submit to an inspection and test of the equipment of such vehicle.
- 5. For the purpose of locating stolen vehicles and to investigate the title and registration thereof, to inspect any vehicle of a type required to be registered under the provisions of this title, in any public garage or repair shop, or in any place where such vehicles are held for sale or wrecking.
- 6. To serve all warrants relating to the enforcement of the laws regulating the operation of vehicles or the use of the highways.
- 7. To investigate traffic accidents and secure testimony of witnesses or of persons involved.
- 8. To investigate reported thefts of motor vehicles, trailers, or semitrailers.
- To take applications for operators' licenses without making a charge therefor.
- 10. To enforce all laws, rules, or regulations of the state of North Dakota pertaining to the closing hours of all businesses or establishments selling alcoholic beverages outside the limits of incorporated cities of this state.
- 11. To exercise general police powers over all violations of law committed on state property.
- 12. To exercise general police powers over all violations of law committed in their presence upon any highway and within the highway right of way or when in pursuit of any actual or suspected law violator.
- 13. To require a motor carrier owner, or a motor carrier's agent, affected by rules adopted under chapter 39-21 to produce logs or other documents to determine compliance with rules adopted under chapter 39-21.
- 14. To provide security and protection for the governor, the governor's immediate family, and other officers next in order of succession to the office of governor to the extent and in a manner the governor and the superintendent deem adequate and appropriate.
- 15. To provide security and protection for both houses of the legislative assembly while in session as in the opinion of the speaker of the house, the president of the senate, and the superintendent are deemed adequate and appropriate.
- 16. Of a peace officer when responding to a request for emergency assistance requiring an immediate response regardless of whether the request is being made by another law enforcement agency or officer.

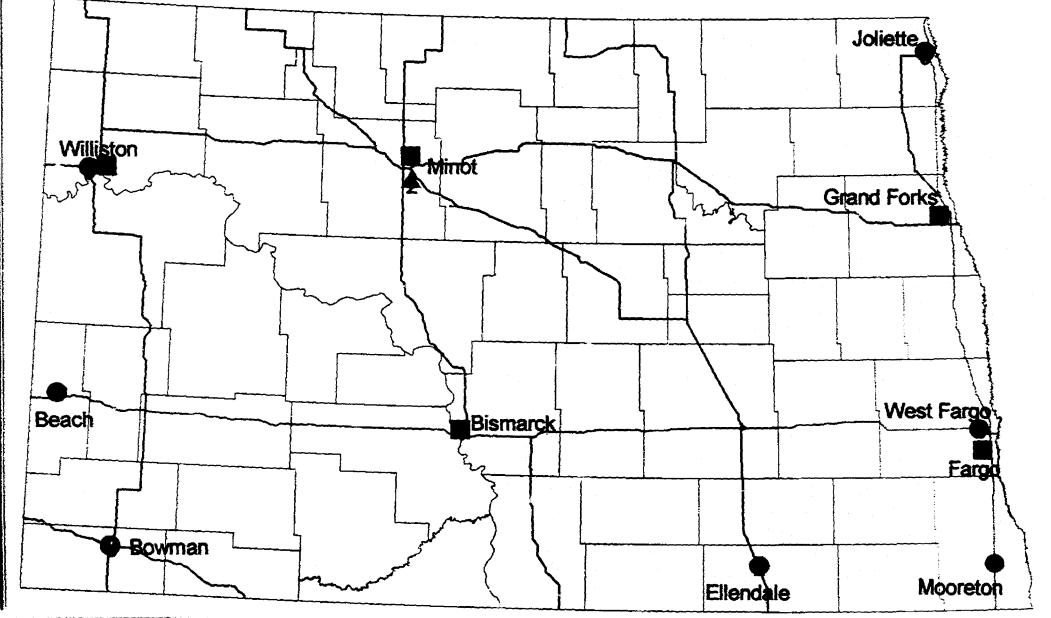

Based on recent information obtained from the U.S. Department of Transportation, the Highway Patrol respectfully requests authorization for two additional FTEs in the 2003-2005 budget. Additional costs of \$180,000 are estimated. If approved, the positions would be 100 percent federally reimbursable by the USDOT's Federal Motor Carrier Safety Administration.

The "New Entrant Program" is the result of the Motor Carrier Safety Improvement Act of 1999. The Act required the Secretary of Transportation to establish regulations specifying minimum requirements for applicant motor carriers seeking federal interstate operating authority including a requirement that new entrants undergo a safety audit within the first 18 months of operations. The purpose of the Safety Audit is to provide educational and technical assistance to the new entrant and gather safety data needed to make an assessment of the new entrant's safety performance and adequacy of its basic safety management controls.

The Federal Motor Carrier Safety Administration is contracting with the states to assist with these audits. North Dakota is authorized two positions based on the number of new entrants seeking authority; the average for the last five years was 289 new entrants per year. Funding for the two positions will be 100 percent federal dollars and will not affect our current Motor Carrier Safety Assistance Program.

The effect of these requested changes to HB 1011 would be as follows:

- An increase in line 9 of \$180,000 to \$30,364,984
- An increase in line 12 of \$180,000 to \$14,653,199

- Maximum flexibility
- Job enrichment and diversity for employees
- Closure provides for maintaining existing fixed sites to be utilized on an occasional basis by the mobile teams which will assist with continuing a level of deterrence

Although the reduction of 15 employees and the services they provide is difficult, the deployment of E-permits and the additional employee added to the headquarters permit office will provide for adequate access for purchasing permits.

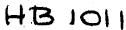

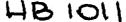

HIGHWAY PATROL - MOTOR POOL RATES AND FUNDING

The 2003-05 executive budget includes funding of \$3,712,000, \$2,613,000 of which is from the general fund, \$825,000 from the highway tax distribution fund, and \$274,000 of federal funds for motor pool costs of the Highway Patrol. This amount is based on total estimated miles of 7,004,000 for the 2003-05 biennium at an anticipated rate based on Fleet Services guidelines of \$.53 per mile. For the 2001-03 biennium the Highway Patrol budget was approved on an anticipated motor pool rate based on Fleet Services guidelines of \$.50 per mile. Actual motor pool rates for the 2001-03 biennium to date have been:

July 2001	\$.50 per mile
August 2001 - November 2001	\$.46 per mile
December 2001 - February 2002	\$.44 per mile
March 2002 - July 2002	\$.43 per mile
August 2002 - December 2002	\$.42 per mile
January 2003	\$.39 per mile

Copies of Fleet Services current rental rates and the guidelines used for developing agency budgets are attached. Representatives of Fleet Services indicated that the current rates may be lower than actual costs for this time period due to reserves accumulated in earlier months of this biennium. The 2003-05 biennium guidelines are based on the rack price of gasoline being at a level that would result in the retail gasoline price being \$2.00 per gallon.

State Fleet Services budget guidelines for the 2003-2005 biennium are attached:
The mileage/hourly rates consist of two components: Operating costs and depreciation.

- a. Operating costs include parts, fuel, insurance, labor, shop overhead, and administration.
- b. Depreciation is the actual cost, less salvage value of the fleet, spread over the estimated useful life of the vehicle.

The replacement rate is the difference between what is needed to purchase new vehicles, and the amount that is recovered through the depreciation portion of the rate. Because this rate is to fund replacement costs, it cannot be charged to federal programs. The replacement rate also funds additional vehicle needs. Agencies are to budget the total of the mileage/hour rate, and the replacement rate. The funding source for the replacement rate must be either general or special funds.

Fuel costs and commercial repairs and labor continue to increase at an accilerated pace. Insurance costs are new this biennium and will continue next biennium.

The attached budget guidelines reflect our best estimate of potential costs for the next biennium. Many factors can increase or decrease the rental rates. It is hoped the forecast is relatively accurate.

All agencies anticipating increases in monthly rentals must identify in writing the number of units, and which rental group will be affected. If no increases are identified, we presume there will be no increases the next biennium.

Each agency/institution's mileage may be determined by referring to the monthly billing report.

SUBJECT: INFORMATION REQUESTED DURING BUDGET HEARING

At the end of the hearing on the Highway Patrol's budget, follow-up information was requested on training costs of new positions, fuel costs relating to mobile enforcement, and some updated figures on page seven of our testimony.

Costs for the two inspector positions needed for the federal New Entrant Program are estimated at \$7,200, which is 100 percent federally reimbursable. There would be no training costs needed for the three new MCSAP Trooper positions, the eight new MCSAP Assistants, and the new clerk position at the permits office.

Fuel costs associated with the three new MCSAP Trooper positions are estimated at \$88,000 total with the federal share being \$61,000 and state share \$27,000. Attached is an updated copy of page seven of the budget hearing testimony we handed out.

Recognizing the need for a strong education and enforcement effort regarding drinking and driving, the patrol has continued to perform sobrlety checkpoints. Through a strong media campaign and an approval rating of over 90 percent by our citizens, the Patrol conducted 54 sobrlety checkpoints during the past blennium and is looking to increase that number during the 2003-05 blennium.

Drug arrests have been occurring on a regular basis as well. During the past year (2002), troopers statewide investigated 395 cases involving drugs; an average of over one per day. One such arrest involved a subject who was stopped for a routine traffic violation near Harvey, North Dakota. The trooper, observing a hole cut between the backrest of the backseat and the trunk of the vehicle, searched the vehicle and found over 25 pounds of marijuana located in the trunk.
