CHAIRMAN FREBORG opened the hearing on Engrossed HB 1227 relating to honorary high school diplomas for Korean conflict veterans.

**Testimony in support of Eng. HB 1227:**

REPRESENTATIVE OLE AARSVOLD, Dist. 20, presented testimony. (see attached)

JIM COATS, Mandan, WWII and Korean Veteran, spoke on the self esteem afforded the WWII vets as they received their diplomas. This is the 50th anniversary of the ending of the Korean Conflict. The average age of the Korean vet is 70. Most of these veterans do not care to go back to school to obtain their GED at this stage in their life.

SENATOR LEE asked if MR. COATS knows how many veterans will benefit from this bill. He stated he didn't know.

JOHN JACOBSON, Veterans Coordinating Council, served during Desert Storm, stated 15 veterans make up the Council, one from each of the five veterans organizations. They offer their unanimous support for this bill.

SENATOR DAVID O'CONNELL, Dist. 6, spoke in support of the bill for those who gave up obtaining their high school diploma to serve in the military. Those WWII veterans who have received their diplomas are very proud and thankful.

SENATOR CHRISTENSON asked if we have seen an application form for the diploma or the diploma itself. The committee members had not.

SENATOR FLAKOLL asked what happens if the district lines have changed since the veteran attended high school and the school either is no longer there or is in another district.

SENATOR O'CONNELL stated that DPI can also award the diploma. SENATOR FREBORG thinks it would go to the veteran from the school district that the original school was attached to.

BOB HANSON, Vice Chairman of the Veteran's Coordinating Council, answered several questions. There are less veterans from the Vietnam and Korean Conflicts than there were from WWII. He stated the form is a one page form that asks for documentation of their service time, and the period in which they served. The district where their school used to be is the one that would award the diploma. If they don't want to or can't, DPI can award it.

There was no further testimony on Eng. HB 1227.

The hearing was closed on Eng. HB 1227.

I appear before you as a cosponsor and proponent of **HB 1227**. **HB1227** would amend section 37-04-42 that was enacted last session authorizing the granting of honorary high school diplomas to World War II veterans whose military services prevented them from finishing high school.

The amendment (subsection2) would add Korean War veterans to that list of eligible veterans. Although, **HB1227** would not include an eligible number of veterans, nearly as large as the World War II provisions in 32-01-42, the Korean veterans are surely as deserving of similar consideration.

The Korean Conflict has long been called "the forgotten war." Having grown up on that era, I have not forgotten seeing flag-draped caskets returning from that confrontation. Nor have I forgotten the North Dakota National Guard 164th Infantry and the role they played in turning the tide of that conflict. I encourage you to join me in remembering those who fought and returned but sacrificed their educational opportunity as a consequence.

I request a positive committee recommendation on **HB 1227**.

Re: HB 1227

I appear before you as a cosponsor and proponent of HB 1227. HB1227 would amend section 37-04-42 that was enacted last session authorizing the granting of honorary high school diplomas to World War II veterans whose military services prevented them from finishing high school.

The amendment (subsection2) would add Korean War veterans to that list of eligible veterans. Although, HB1227 would not include an eligible number of veterans, nearly as large as the World War II provisions in 32-01-42, the Korean veterans are surely as deserving of similar consideration.

The Korean Conflict has long been called "the forgotten war." Having grown up on that era, I have not forgotten seeing flag-draped caskets returning from that confrontation. Nor have I forgotten the North Dakota National Guard 164th Infantry and the role they played in turning the tide of that conflict. I encourage you to join me in remembering those who fought and returned but sacrificed their educational opportunity as a consequence.

I request a positive committee recommendation on HB 1227.
