Minutes:

Rep. Weisz, Chairman opened the hearing on HB 1292, a bill for an Act to amend and reenact section 39-24-4 of the North Dakota Century Code, relating to a snowmobile access fee.

Rep. Nelson: Representing District 7 introduced this bill on behalf of some individual snowmobilers. There is a bill in this legislature to raise the snowmobile license fees from \$20 to \$40. The concerns raised was that there is a trail fee in all the neighboring states and provinces -- the thought is that the license increase is an attempt to get trail fees on the backs of the snowmobile owners and not all the users who come here use our trials. This just an attempt to share these cost with those who come into the state.

Rep. Hawken: How would we do this -- is it easy to do?

Rep. Nelson: In other states there is a sticker you get when you buy your trail permit of pay your trail fee. In this state enforcement may be a problem but it probably be self policing.

Rep. Hawken: How would they know where to buy the tre'l fee if there isn't someone out there at the trail?

Rep: Nelson: They would go through the vendors and dealers.

Rep. Severson: Representing District 23 stood to support the bill. He felt this was a safety issue because if you don't have good groomed and marked trails people just hear out across country. There are fences and obstacles. With more groomed trails there wouldn't be a need for facing these hazards.

Rep. Thorpe: (6.6) In my experience is that if this was properly set up there would be a lot of support for this and greater use of the trails.

Rep. Weisz: Rep. Severson - do you see the possibility of fewer people coming into the state because of this?

Rep. Severson: No I don't -- we go to Minnesota and they have a fee and I have never seen anybody object to paying the fee. I think they are used to it -- expect it -- if you have good trails well marked and groomed it may draw more.

Rep. Zaiser: What are the fees in other states like Minnesota and Colorado in the mountains?

Rep: Severson: I don't remember -- its been a couple of years and we paid in lump sum for several sleds.

Rep. Nelson: I understand that Minnesota if \$15. Manitoba is \$30 Canadian.

<u>Carrie Bahmer</u> Executive secretary for Snowmobile North Dakota was present to answer questions.

Rep. Weisz: Do you have any idea of how many out of state snowmobilers come to North Dakota.

Carrie Bahmer: We believe about 100 to 200. It depends on the snow year.

Rep. Delmore. Isn't this an equity issue -- wouldn't it be a way to track how many come into the state.

Carrie Bahmer: It may be but the other side of the issue is that right now it going to cost more to set up than we will get in to administer the fee. We need to print enough stickers to have a supply on hand for all the dealers, vender, recreation site, etc. That is to print many more than we need. We need to distribute the stickers -- then we need to equitably distribute the receipts, monitor the improvements, do the marking and signing. We see more problems than it is worth. That is not considering the enforcement side of it and we are not set up to do that -- collect the fines and penalties.

Gary Markwart: I travel around quite a bit to Montana, Wyoming, Colorado --- Their fines are \$20 to \$50 and they do have people riding the trails all the time for enforcement.

Rep. Delmore: Couldn't this be the start of something -- it wouldn't be much of problem to bump the fines up. Why not have what Minnesota has?

Gary Markwart: Minnesota has a combination of family activities associated with snowmobiling and it would have to be promoted that way. We don't have that is this state -- out of stater will go to where the snow is -- to Bismarck if the snow is there or to the Turtle Mountains is that is where the snow is.

Carrie Bahmer: When you go to Minnesota they have 300 miles of trails from a family center and you can go in any direction. Here in North Dakota we have 3000 miles of groomed trails and 800 miles of ungroomed trails throughout the state. However, they are not strategically located around site with enough options at one site.

Rep. Thorpe: Have you folks discussed Rep. Severson's idea of acquiring the abandoned railroad?

<u>Carrie Bahmer:</u> Yes we have looked into that and the cost is prohibitive -- for example the line from Marion to Luca if about \$350,000.

Tom Balzer: With the North Dakota Parks and Recreation. That is \$350,000 and then you have to pull the ties, relay the gravel, and set down the signs, etc.

<u>Unidentified voice</u>: We had other problems on that stretch of railroad bed south of Mandan -- if you have notice -- railroads build their line above surrounding land and the wind sweeps the snow off. It seldom had good snow on it.

Rep. Headland: Is snowmobiling in North Dakota adequately funded now? There is a movement to double the license for residents.

Gary Markwart: Important thing is that we would be for anything that made us money -- but we would want to study this to make sure that we wouldn't loose money -- cost more to set up than we make.

Rep. Headland: You already have sticker for residents -- why couldn't the same type of sticker be used?

**Rep. Ruby:** I guess the way I look at it is right now they are raising funds for this through a number of different ways and one of the ways they are doing that is to go to the businesses that will benefit from having the influx of out-of-state people come. Those businesses are willing to donate money to have, whether it's to have a rally or whatever they do when they're out riding, than to have these other clubs come in from out-of-state or just individual riders. That's a benefic for them. They don'te money because it benefits them in the long run. I would see if we're going to raise the fee, then that cuts into the amount of people who are here, who will come to the state, I think that will hurt the businesses' ability to make money, and they will probably be less likely to want to donate for this other revenue, that maybe this wouldn't bring in if the out-of-state people don't come like they have now. So I don't think this is the right approach. **Rep. Headland:** I don't have a problem charging out-of-staters, if they don't care. It isn't an issue. Everywhere they go they pay a fee. The only issue I had, and that was why I was hoping to see some amendments, it seems to be some issue that it is going to cost more to implement than what we're going to return. I don't think that the fact of the fee is going to keep anyone out, ½ of them probably won't pay the fee anyway; people don't know about the fee, etc. The concern that I have is the cost vs. return.

Rep. Headland: The real problem with this bill lies in setting up a network, a place to sell these stamps. I just don't feel there is time to get that implemented and I think this is something that we should look at and plan for next session.

Chairman Weisz: Rep. Delmore are you aware if the bill in the Senate has passed in the Senate.

Rep. Delmore: No, I am not, and it is an increase to the residential snowmobilers. It might be better to keep this one alive in case they don't.

Representative Jon Nelson (District 7) Introduced HB 1292. The trail fees in ND do not require a decal or permit from nonresidents who come into the state and all areas around ND do have that requirement for a nonresident. The bill, with amendments, would require a nonresident who uses the trail system in ND to buy a \$15 permit decal. The penalty would be increased to \$50 for not registering a sled.

(Meter 3800) Discussion on the fiscal note attached to this bill. It would take \$12,000 to initiate the program in this biennium. It was not determined if the appropriation was a one time appropriation.

Andy Zachmeier (Bismarck) (Tape 1, Side A, Meter 6188, Tape 1, Side B, Meter 0) Opposes HB 1292 because of enforcement issues such as who will enforce and how they will enforce it. (Tape 1, Side B, Meter 250) Discussion as to how present registration laws are enforced. It all comes down to catching the violators. There are already all kinds of enforcement problems. The hearing on HB 1292 was closed.



Tom Trenbeath, Senator from District 10. No written testimony. He stated that when the bill was heard in his committee (Transportation) there was no testimony against it. The testimony was in favor for it, including the snowmobile club's, organization. The penalty was raised because it was only \$10.00 for non-resignation of snowmobiles, It was decided to have a \$50.00 fine so that it would take away the incentive not to register. The reason for the no date is to give the snowmobiles time to do the surveys they need to do and to create the enforcement aspects, printing the decals, etc.

Mr. Chairman and members of the Senate Transportation Committee, my name is Tom Balzer, Recreation Division Manager with the North Dakota Parks and Recreation Department. I appear to offer neutral testimony on House Bill 1292.

The North Dakota Parks & Recreation Department administers the state snowmobile fund as prescribed in the North Dakota Century Code and we are fully prepared to effectively implement the intent of this bill into our existing state snowmobile trail program.

The revenue generated by this fee will be initially spent on associated decal and awareness printing costs and distribution royalties to local vendors who will be required to sell the permits. The remaining funds will be allocated to increased enforcement presence and trail maintenance across the existing system.

Since we have never tracked out-of-state snowmobile users who use the state trail system we do not have hard numbers to give you, but based on discussions with Snowmobile North Dakota and enforcement officers we feel at the extreme 200 out-of-state snowmobile users visit the state during years of sufficient snow. The number of out-of-state users is highly dependant on snowfall in relation to surrounding states, making the revenue generation extremely volatile. At this time we do not see a reliance on these funds to augment the state snowmobile trail program.

Finally, if the committee decides to give this bill a do pass recommendation, to be consistent, I would ask for the committees consideration to also amend and reenact section 39-24-11 of the North Dakota Century Code to make the penalty of violating this bill comparable to that of violating in-state registration of snowmobiles.

Mr. Chairman and members of the House Transportation Committee, my name is Gary Markwart, Board Member of the Board of Directors for Snowmobile North Dakota. Snowmobile North Dakota is contracted by the North Dakota Parks & Recreation Department to manage North Dakota's snowmobile program which involves overseeing the snowmobile safety and trail programs. This includes securing land leases, providing trail insurance, inspecting and monitoring trails, law enforcement, and administering snowmobile safety classes and providing snowmobile safety information to the public. Currently, Snowmobile North Dakota works with 51 clubs and 18 trail associations in maintaining snowmobile trails throughout the state. I appear in opposition of House Bill 1292 implementing a fifteen-dollar trail access fee for out-of-state and out-of-county snowmobile users.

Under normal snow conditions, North Dakota does not have the out-of-state snowmobile user base that other states, such as Minnesota, Michigan, Wisconsin, South Dakota, Montana and Wyoming boast. Many families would travel the extra 300 miles to sled in surrounding states that offer trail systems with more centrally located trails and scenic value than North Dakota offers at this time. This winter has been a prime example of an abnormal snow year which is why we saw an increase in the number of out of state riders. The current snow year should not be considered a long term trend in planning the future of the snowmobile trail system.

The snowmobile trail fund supports approximately 3,000 miles of groomed trail and 800 miles of ungroomed trail throughout the state. As it currently stands, law enforcement is a challenge because of the geographical size of the state and the strategically placed snowmobile trails throughout North Dakota. At this time we feel there is not adequate enforcement personnel in place to implement and manage the fifteen-dollar trail access fee effectively.

We feel that the estimated administrative costs of this program could outweigh the potential income that would generate from this fee. For example, to effectively implement this program trail passes would have to be sold at non-government sites, like gas stations, restaurants, and lodging establishments, much like hunting and fishing licenses. As you are well aware, non-government and some governmental entities such as County Commissioners receive a royalty for the sale of these licenses. The associated administrative costs such as printing, decal design, production, royalty fees, and enforcement needs would exceed the amount of the fees collected. In the end, the in state users would pay for the cost of the over-run.

House Bill 1292, as proposed with the current laws, states an out-of-state or out-of-country snowmobile user who is sited for not purchasing a trail pass, would only be fined ten dollars. We feel with the current enforcement resources, this is a chance many snowmobile users will take.

There are also many clubs in North Dakota which have a large percentage of members from South Dakota and Minnesota. These members are an intricate part of the state trail system in

North Dakota. Their help in signing, grooming, and grubbing the North Dakota trail systems is a valuable asset to the State of North Dakota. We fear that enacting this legislation would alienate these members and put a strain on the volunteer labor needed to support the state trail system.

We feel at this time the snowmobile trail fund is not prepared to develop or handle a program dealing with an out-of-state or out-of-country trail access fee. More research and development needs to be completed before the snowmobile trail fund would be able to administer this program effectively. We ask for a vote of DO NOT PASS on House Bill 1292.

## TESTIMONY - HOUSE BILL 1292 SENATE TRANSPORTATION COMMITTEE MARCH 6, 2003 - 10:00 AM LEWIS & CLARK ROOM

Mr. Chairman and members of the Senate Transportation Committee, my name is Tom Balzer, Recreation Division Manager with the North Dakota Parks and Recreation Department. I appear in support of House Bill 1292 with the proposed amendments.

The North Dakota Parks & Recreation Department administers the state snowmobile fund as prescribed in the North Dakota Century Code and we are fully prepared to effectively implement the intent of this bill into our existing state snowmobile trail program.

The revenue generated by this fee will be initially spent on associated decal and awareness printing costs and distribution royalties to local vendors who will be required to sell the permits. The remaining funds will be allocated to increased enforcement presence and trail maintenance across the existing system.

Since we have never tracked out-of-state snowmobile users who use the state trail system we do not have hard numbers to give you, but based on discussions with Snowmobile North Dakota and enforcement officers we feel at the extreme 200 out-of-state snowmobile users visit the state during years of sufficient snow. The number of out-of-state users is highly dependant on snowfall in relation to surrounding states, making the revenue generation extremely volatile. At this time we do not see a reliance on these funds to augment the state snowmobile trail program.

Finally, in order to insure the true penalty intent of the proposed amendments, I would ask for the committee's consideration to amend the amendment in section 39-24-11 to replace "section 39-24-02" with "sections 39-24-02 and 39-24-04".

## PROPOSED AMENDMENTS TO HOUSE BILL NO. 1292

Page 1, line 1, replace "section" with "sections" and after "39-24-04" insert "and 39-24-11"

Page 1, line 2, after "fee" insert "; to provide a penalty; to provide an appropriation; and to provide an effective date"

Page 1, after line 24, insert:

"SECTION 2. AMENDMENT. Section 39-24-11 of the North Dakota Century Code is amended and reenacted as follows:

39-24-11. Penalties. Any person who violates subdivision b or g of subsection 5 of section 39-24-09 is guilty of a class B misdemeanor. Any person who violates subdivision c of subsection 5 of section 39-24-09 is guilty of an infraction or a class B misdemeanor as determined by section 29-24.1-07. Any person who violates subsection 11 of section 39-24-09 is guilty of a class B misdemeanor and must be assessed a fine of at least one hundred dollars. Any person who violated any other provision of section 39-24-09 must be assessed a fee of twenty dollars. Any person, unless specifically exempted, who fails to register or fails to display a decal as required by section sections 39-24-02 and 39-24-04 must be assessed a fee of fifty dollars. If the person provides proof of registration after the violation, the fee may be reduced by one-half. Any person who violates any other provision of this chapter for which a specific penalty is not provided must be assessed a fee of ten dollars.

SECTION 3. APPROPRIATION. There is appropriated out of moneys in the state snowmobile fund in the state treasury, not otherwise appropriated, the sum of \$12,000, or so much of the sum as may be necessary, to the parks and recreation department for the purpose of establishing and administering the decal program for snowmobiles registered in another state or country, for the biennium beginning July 1, 2003, and ending June 30, 2005.

**SECTION 4. EFFECTIVE DATE.** Section 1 of this Act becomes effective on August 1, 2005."
