Jack McDonald. ND Newspaper Association & ND Broadcasters Association: Opposed (see attached testimony).

**Rep. Koppelman:** I am the sponsor of HB 1320, (see attached testimony). I have drafted an amendment to my bill, and urge the committee to adopt that amendment. The bill does allow access to autopsy photos, what the amendment would do is delete the areas of the bill that deal with both inquests and records. Immediate family can still have access to autopsy photos and by law enforcement or a court order. I request that the amendment to HB 1320 and a Do Pass recommendation on the bill when amended.

Rep. Delmore: So Rep. Koppelman, you would be amenable to what Mr. McDonald has suggested?

Rep. Koppelman: I would and I believe the amendment does accomplish that.

**<u>Rep. Koppelman:</u>** We did discuss that, the term immediate family is well-defined and well established in state law.

**Rep. Klemin:** The second quest on has to do with medical education and training of persons who do this kind of work. Would this preclude those persons in medical education or training programs from seeing autopsy photos.

**Rep. Koppelman:** I don't really know the answer to that. I suppose if they are not public record, they would have to get the permission of the family or a court or law enforcement to do that.

**Rep. Klemin:** Use of the word confidential. As I understand it, there is a distinction between confidential and exemption in open records. You are saying, that even though these would "confidential" records which means they can't be disclosed, that nevertheless the family could disclose them.

**<u>Rep.</u>** Koppelman: I am not sure that I know the answer to that. My intention is simply to keep them from being released for public consumption and used in an irresponsible manner, and whether that term should be confidential or exempt, I am not sure of the distinction.

**Chairman DeKrey:** Thank you for appearing. Anyone else wishing to testify in support of HB 1320.

**<u>Chairman DeKrey:</u>** Have you seen the amendment, Mr. McDonald. Does it fix what you want or still have problems with it.

**Jack McDonald:** We support the amendment. I think we need to massage the amendment a little bit, I'm not sure if it is doing exactly what Rep. Koppelman wants. I think we can work through it.

**<u>Rep. Klemin:</u>** This section that you've got attached to your testimony, that says records of the coroner are public records in counties over 8,000 people. There is no similar provision for counties under 8,000 now?

Mr. McDonald: Not really. That specific provision is in 11-19.1 which actually is the older law. 11-19 is the new law.

**Rep. Klemin:** So if it's over 8,000, they are public records and if under 8,000 they are not. **Mr. McDonald:** No not really because there is no provision in 11-19 that makes it confidential or exempt, so therefore they are open to public records. That's the reason they didn't put that in, they are open records unless there's something that makes them closed. There is a definition of "immediate family" in the law, relating to notification of next-of-kin in the law enforcement section; husband, spouse and children. If records are confidential, they are closed and forbidden by law to be released to anyone, including someone with medical training, etc. Exempt means that they can be released at the discretion of the coroner, or for medical training.

Edward Erickson, AG Office: I was not hear to provide testimony but just to observe; but the section that Jack had mentioned talking about the medical records being public documents, was

**Testimony on House Bill 1320** 

Good Morning, Mr. Chairman and Members of the House Judiciary Committee. For your record, I am Representative Kim Koppelman and I represent District 13, which consists of most of the city of West Fargo and a small surrounding rural area.

House Bill 1320 grew out of mounting national concern over the public nature of something as personal as autopsy photos. This problem first came to light, in the wake of the tragic death of race car driver Dale Ernhardt. Apparently, someone took advantage of open records laws in that state to acquire the photos of his autopsy and post them on the internet.

I first visited with the Attorney General about this issue several months ago. After some investigation, he concluded that, under current law, although they are closed during a criminal investigation, after it's completed, autopsy photos would probably be considered open records.

As a former journalist myself, I am a strong supporter of open meetings and open records and am proud of the strong laws we have on the books in North Dakota to ensure open government. I believe I can also assure you, however, that no responsible journalist or member of the public would seek to deepen a families grief by wanton public flaunting of something so sensitive as autopsy photos. As fellow legislators, I trust that you would agree with me that no public information purpose would be served by such activity.

The original draft of this bill inadvertently included the closing of inquests and autopsy records. My intention was not to suggest such a broad change in state law, but only to close autopsy photos, as public records. Accordingly, I've had an amendment drafted, which would accomplish only that. I would encourage the committee's adoption of that amendment.

You'll note that the bill does allow access to autopsy photos by the decedent's immediate family and by law enforcement or by court order. I believe this allows appropriate means to access them, if necessary.

Mr. Chairman and members of the committee, I respectfully request the amendment of House Bill 1320 and a "do pass" recommendation on the bill, when amended. I'd be happy to answer any questions you might have.

These records have been open records since the early 1900s. I'm not aware of there ever having been a problem or a controversy regarding their use. Reporters use the records in controversial cases to verify cause of death and other circumstances. I'm not sure if there are autopsy photos in every case, but I'm quite certain that no newspaper in the state has ever published such a photo.

There is also some confusion. The bill amends portions of Chapter 11-19, which only covers countles of 8,000 or less. Counties over 8,000 are covered by Chapter 11-19.1, which specifically provides that these records are open (see §11-19.1-08).

We would agree to work with the sponsor to amend this bill to cover photos only, if that is the committee's wish, but basically we would rather urge a DO NOT PASS.

#### § 11-19.1-08. Records of coroner's office

It is the duty of the coroner to keep a full and complete record and to fill in the cause of death upon the death certificate in all cases coming under the coroner's jurisdiction. All records must be kept in the office of the coroner, if the coroner maintains an office as coroner, and if the coroner maintains no separate office, then in the office of the recorder of the county, unless the board of county commissioners designates a different official, and must be properly indexed, stating the name, if known, of every deceased person, the place where the body was found, date of death, cause of death, and all other available information required by this chapter. The report of the coroner and the detailed findings of the autopsy, if one was performed, must be attached to the report of every case. The coroner shall promptly deliver or cause to be delivered to the state's attorney of the county in which a death occurred copies of all necessary records relating to every death in which the coroner or state's attorney determines further investigation advisable. The sheriff of the county, the police of the city, or the state highway patrolmen on duty in that county in which the death occurred may be requested to furnish more information or make further investigation by the coroner or the coroner's deputy. The state's attorney may obtain from the office of the coroner copies of records and other information necessary for further investigation. All records of the coroner shall become and remain the property of the county and are public records.
