Chairman DeKrey: We will now hear testimony on HB 1350.

Sandi Tabor, Deputy AG: It was actually brought to our attention by some of the members of the City of Fargo Police Department, and also the Bismarck Police Dept. that there are several SWAT teams (Special Operations Team). These people go out to take care of bombs, lab raids, and have been responding to calls in the rural areas around their respective cities for some time. As they look at their budgets, and see times getting tighter and tighter. The special operations and special response unit, the budgets for those are also being looked at. The Association of Counties, and the ND League of Cities, and the Attorney General's office got together with the respective police departments and talked about how we could rectify this issue. ND Association of Counties went back to its membership, talked to them, they set up a fee schedule which goes anywhere from \$100-500 of a voluntary assessment, to help fund these special operations team response fund. A grant was given for \$50,000 to help fund the fund. We need this tool. They

only have them in eight communities right now. It is not something that the rural areas are necessarily going to be able to afford to do themselves. This is a pretty effective, economically and otherwise cooperative agreement between the cities and the counties, and our office is happy to be a part of this and to facilitate it, because it needs to continue.

**Rep. Onstad:** If SWAT from Bismarck or Fargo goes to rural area, do they get reimbursed? **Ms. Tabor:** Not that I know of. Bismarck doesn't, we eat it. But they can't keep it up much longer.

**Rep. Onstad:** Is there a concern that if you get more than one call, are there enough officers to go around.

Ms. Tabor: I think that Chief Magnus is here, and he'll probably give you a little more detail on how they manage these calls. This bill won't cover all the costs, it will be a way to look at getting overtime reimbursement for the officers and cost of driving and taking the vehicles and equipment, paying for gas. We're trying to be proactive.

Chairman DeKrey: Thank you. Any further testimony in favor of HB 1350.

Lt. Paul Laney. ND Peace Officer's Assn. of Special Operations Comm.: (see attached testimony) Support.

Rep. Delmore: Do you have a team in each of those area, if so, how long would it take to get a unit from wherever they are stationed, into each of these parts, and how many times do you estimate probably being called out.







To provide rural law enforcement agencies throughout the State of North Dakota, the opportunity to use the trained tactical teams provided by larger law enforcement agencies. The rural law enforcement entity would contact their assigned tactical team for any incident that they believed required specialized training or tactical intervention. The rural agency would not be responsible for any monetary reimbursement to the responding tactical teams.

#### Examples of requested assistance:

- -Incidents involving clandestine labs
- -Execution of drug warrants including the manufacturing of methamphetamine
- Barricaded subjects and/or hostage stand-offs
- -Incidents in which a trained negotiator is needed
- -Any incident where specialized tactical training ensures public and officer safety

#### NDPOA Special Operations Committee:

In January of 2001, Jerry Kemmet of the Bureau of Criminal Investigations and the NDPOA SOC discussed the need for certified special operation teams in rural North Dakota.

The NDPOA SOC met throughout 2002, and established a criteria that tactical teams must meet if they want to receive reimbursement for calls of assistance to rural agencies. These criteria covered areas such as Personal, Administrative Status, Firearms Qualifications and Equipment. These qualifications were established to ensure that the responding tactical teams were giving rural North Dakota a capable, safe and highly trained tool to draw from.

Once these qualifications were established, there were seven teams that met the minimum qualifications for the reimbursement of call outs. The State of North Dakota was split up into jurisdictions, and each of the seven qualified teams were assigned their areas of responsibility.

If a tactical team is requested, they would respond to the rural agency and upon arrival, fall under the control of the requesting agency. Under no condition, would the responding tactical team assume control of the incident without the permission and cooperation of the requesting agency.

#### **HB 1350** Creation of a Special Operations Team Reimbursement Fund
